Surrender

Surrender is that moment when we realize and acknowledge to our innermost selves that we cannot stop drinking. That the option to "not drink" has been removed. That will power and desire to stop drinking have no effect to change our behavior.

We may use different internal and external words like "I need help" or "I cannot do this anymore" or "I'm through living in this hell." Before surrender, our life was one of attempts to manage and control our drinking and everything else. These efforts were futile. But it may take us many years to realize the reality of that statement.

Negative consequences were usually rationalized away or ignored, so that we could shift our attention to our "go to," — alcohol. It seemed to be the answer to every situation in our lives: Anxiety, sadness, relief, joy, celebration, depression. The mental preoccupation with alcohol can only be understood by an alcoholic.

In the back of our mind was always the thought "do I have enough alcohol on hand for today," or, "when can I take my next drink," or, "I need more." We seemed to rush to get to the reward; the next drink.

Surrender is our moment of release from the powerful hold alcohol has on us. It is a moment of sanity and humility.

Eventually, we realize we do not have the answer to our lives. That our best efforts have left us broken, ashamed, humiliated, and defeated. Now, it is exactly in this moment that we are released and begin to feel the freedom from alcohol. We begin to learn how to live a completely new life. We “let go” and “let God.”

Gradually, surrender becomes a daily practice. Many of us start the day with the Third Step Prayer. We learn to *pause when agitated*; to stop our automatic response to a situation; relax and find our *soul's integrity*. We look for opportunities to serve others in and outside of AA.

Our life has a new meaning. This is the gift of sobriety.

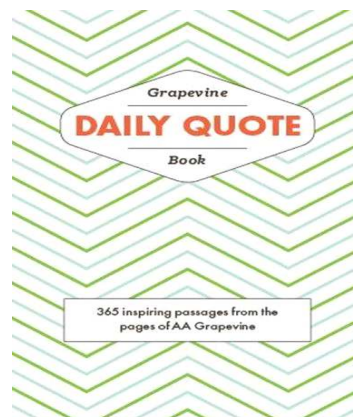

OFFICER REPORTS:

Chair: (James C.) We will be having our December General Meeting on the 26th, which is a Wednesday, instead of Monday, at the same time.

Vice Chair: (Justin C.) We had five new reps tonight. A reminder that in January we will be having elections for officer positions.

Secretary: (Patrick B.) Previous minutes were passed.

Treasurer: (Francis. B) Group contributions for October, were \$6,441, which was \$1,289 more than October, of last year, we received \$8 from bank interest and \$200 in group insurance fees for a total of \$6,649. After expenses we had a net gain of \$3,090. Bookstore income was \$6,579. After expenses we had a net loss of \$287. We received \$200 in group insurance fees. Actual loss of \$87 We had a net Loss from Halloween Dance of \$701. Overall, we had a net gain of \$2,302.

Registrar: (Craig. H) As of November 26th, 2018, there were 235 groups in Sonoma County, offering 347 meetings each week. There are 169 meeting representatives on record, for 67% participation. There were 60 representatives attending the November, 2018, General Meeting, for 40% participation. There were 4 new reps attending the November, 2018, new rep orientation.

Our Intergroup members work hard to carry the message of *experience, strength and hope* through year round activities, including seminars, dances, supporting the bookstore, and providing this newsletter. The list of Intergroup Officers with the description of duties can be found below..

In service, Pete D.

SCIF OFFICER POSITIONS & DESCRIPTIONS

Term length for all jobs is one year. Two consecutive terms O.K. All Committee Chairs are required to attend SCIF Steering Committee and General Meetings

CHAIRPERSON: Presides over monthly General and Steering Committee meetings. Maintains direct communication regularly with other officers and committee chairs. Serves on ICSC. Must have/gain general knowledge of A.A. Service Manual, Robert's Rules of Order, Chair's Rules, SCIF business procedures (for conducting Intergroup Business Meeting), and Intergroup history and responsibilities. Sound business or professional background.

Length of sobriety = 4 years. Average monthly time commitment: 12-15 hours.

VICE-CHAIRPERSON: Supports Chairperson in their duties; and fills in for Chairperson should he or she be absent or unable to perform that office (ex. running the monthly General and Steering Committee meetings). Runs the new Rep Orientation before the General meeting, provides the new reps with orientation packets, gives the "what to take back to your meeting" summation at the end of the General meeting, and may be asked to liaise with committee chairs and fill in for absent officers/committee chairs. The Vice Chair should have knowledge of: 1) Intergroup history and responsibilities; 2) current and pending business; 3) Chair's Rules – Parliamentary procedure as informed by A.A.'s Twelve Traditions.

Length of sobriety = 4 years. Average monthly time commitment: 8-12 hours.

TREASURER: Works with Assistant Bookstore Manager and Bookkeeper in overseeing monthly financial statements. Receives and records all monies collected at Alkathons and SCIF activities. Serve on ICSC committee. Sits in on initial planning meetings for all expense-related committees to assist with budgeting questions. Accounting/bookkeeping background helpful.

Length of sobriety = 4 years. Average monthly time commitment: 5-10 hours.

RECORDING SECRETARY: Takes minutes at SCIF General and Steering Committee meetings. Emails drafts to steering committee for approval. Delivers final copy of general meeting minutes to Newsletter Editor and approved copies of both minutes to bookstore manager for archives.

Length of sobriety = 3 years. Average monthly commitment: 6-8 hours.

REGISTRAR: Attends the monthly Steering Committee and General Meeting, Provides report of previous month's attendance statistics. Provides sign in sheets for General Meeting. Updates Excel spreadsheet and generates report for presentation. Sends Secretary New Rep sign in sheet. Emails monthly report to steering committee. Works with Outreach Chair to identify unrepresented meetings and improve reporting accuracy.

Length of sobriety = 3 years. Average monthly commitment: 3-5 hours.
