My commitment was to attend the PI/CPC monthly meetings during the two-year Panel 59 (2009-2010). I had the opportunity to contribute as "a link in the chain", by communicating information between both District 12 and PI/CPC.

What a wonderful way to be introduced to this kind of 12th Step work. After rotating out as liaison, I knew I wanted to work with this committee whose members were committed to providing many valuable services to our community. Their work is another way to be sure that the hand of A.A. is always there for any alcoholic seeking recovery.

My new assignment is to help coordinate AA speakers for the local Drunk Driver Program classes (see last month's article). To do my work, I was immediately supplied with the contact list of our Sonoma County AA members who are available to speak to the public, and at non-AA events. This got me to thinking (uh oh, possibly dangerous) that perhaps some of these folks haven't had a request to speak lately, and might want to refresh their skills, plus get back on our radar. To get up to speed, or get involved, please attend our 7:00 PM Speaker Training just prior to the PI/CPC monthly business meeting every second Wednesday from 7:30-8:30 PM. We meet at the City Hall lounge by the underground parking lot off First Street. Our speakers have a working knowledge of the Steps, and no less than 2 years of sobriety.

Members might also be interested in viewing the many Public Service Announcements that are often used in PI/CPC work, all of which are easily accessed on AA.org. There is a brand new one titled "My World". At a mere 15 seconds, this PSA is designed to give suffering alcoholics hope for a solution, and how they might find Alcoholics Anonymous. Check it out.

# PROPOSED CREDIT/DEBIT CARD MACHINE AT THE BOOKSTORE

Motion: ICSC seeks group's approval to accept Debit and/or Credit Cards at the SCIF Bookstore.

#### Pros:

- \* Many customers have already requested a POS machine that will handle all ATM and major credit cards. Having a POS machine available will significantly boost SCIF Bookstore sales.
- \* Many other Intergroup Bookstores in California have POS machines available for their customers, and have reported increased sales as a result.
- \* POS machines offer a convenient way for customers to keep track of their purchases.

#### Cons:

- \* Convenience comes at a cost to the Bookstore and the Fellowship as a whole. Since there is no compelling evidence that the Bookstore is losing business by accepting only cash or checks, that cost would not be repaid by additional sales volume.
- \* SCIF has investigated fee schedules at several financial institutions, and found that costs range from 1.25% to 1.9% of per transaction amount plus 15 to 30 cents per transaction. There also may be minimum fees of \$20 to \$50 per month. There is additional cost to purchase or lease the equipment to swipe the cards. There are soft costs, as well additional administrative burden for the Office Manager, Treasurer, and Bookkeeper to manage our interchange account, not to mention the necessity to retrain more than fifteen Bookstore volunteers to accurately and securely handle the transactions as well as to follow security protocols required by the industry.
- \* While our insurance policy covers us for identity theft, defending against any security lapse or fraud could still be expensive in time and money.
- \* Your out-the-door price for Bookstore items will go up in April when Santa Rosa raises its sales tax rate. The costs of accepting plastic could erode our already thin financial margin enough that prices would need to be raised. We have recently scaled back print runs for the newsletter, dropped the PD ad, and looked for other ways to cut expenses, and we are still facing a shortfall of \$4,400 in our prudent financial reserve. This is not the time to incur additional expenses, especially not if the benefit is simply convenience, with no additional income to offset the costs.

#### **BRIDGING THE GAP**

"Uncle" Bill Wilson needs YOU—to carry the message to the alcoholic just leaving the treatment facility. "We can't keep it unless we give it away" is one of our most powerful messages to assure long term sobriety. We need your help in many ways. First of all, BTG needs volunteers to fill out a yellow card and attend an orientation to learn how to best assist the newcomer to find and attend his first meeting out

of treatment.

When the newcomer fills out a blue card, or request for assistance, to get to that first meeting, BTG finds a volunteer that shares the same sex, age, and zip code. Once the volunteer is contacted, he or she calls the newcomer to find out what kind of help is needed to get her to that meeting. That's all that is required. Sometimes sponsorship blossoms from this encounter, but not always. The volunteer may be contacted often or infrequently depending on the demographics of the newcomers and volunteers. BTG Sonoma County needs more volunteers especially in West County. But please don't shy away because you don't live ithere.

We are now making presentations to Azure Acres, Mountain Vista Farm, Campobello, Turning Point, North County Jail(honor farm), Kaiser, and starting this month, Orenda detox. 40 Blue Cards from newcomers were turned in this month. BTG is still in need of committee members: a liaison to SOCYPAA, and a female Phone Coordinator.

# PROS & CONS ON NOT RETURNING PRIMARY PURPOSE GROUP TO SCIF MEETING SCHEDULE LISTINGS

Motion: We request that SCIF not remove the Nor-Cal Primary Purpose Group from the Sonoma County AA Meeting Directory.

# Why it SHOULD be returned:

The Nor-Cal Primary Purpose Group, (NCPPG), was started with one specific purpose; to learn what is in the Big Book of Alcoholics Anonymous to better help the next suffering alcoholic coming to NCPPG. In doing so, the group adopted parts of the format used by Primary Purpose Group, Dallas, TX. NCPPG does not affiliate nor endorse Primary Purpose Group (PPG) Dallas. NCPPG is a separate non affiliated group conducting a meeting in Santa Rosa, Ca.

NCPPG is listed on the PPG Dallas, TX website as a big book study along with numerous other Big Book Study groups, of various names, in the United States and internationally. We do not believe being listed on an AA website constitutes affiliation or endorsement. The Sonoma County Fellowship AA directory itself states; "A directory listing does not constitute or imply approval or endorsement of any groups approach to or practice of the traditional program of Alcoholics Anonymous." NCPPG does supplement out basic text, Big Book of Alcoholics Anonymous with a study guide. The study guide is purchased by an individual not the group and is sold at cost. The study guide is not put on a literature table, nor are members obligated to purchase the study guide or attend the meeting with a Big Book. The study guide is merely a tool to study the Big Book of Alcoholics Anonymous sentence by sentence. Once again the NCPPG is not affiliated or endorsed by PPG Dallas, TX. Please remember the intent of the Sixth Tradition is to prevent "...money, property or prestige from diverting us from our primary purpose."

NCPPG is a Big Book study carrying the primary purpose of Alcoholics Anonymous as the original one-hundred did. The purpose of the study guide is to enable the member to better understand the information the authors of the book, Alcoholics Anonymous, intended to impart to each of us based on their experience and knowledge of alcoholism. NCPPG preamble states: "To show other alcoholics precisely how we have recovered is the main purpose of this book." AA pg xiii (and of this group).

### Why it SHOULD NOT be returned:

\* NCPPG is listed on the PPG Dallas website, which is

NOT AA GSC approved as per their own disclaimer, which follows:

\* The primary purpose group website is neither endorsed nor approved by Alcoholics Anonymous World Services. This website is simply part of our 12-step work; its main purpose is to show the alcoholic who still suffers the simplicity and the effectiveness of the program of alcoholics anonymous when practiced as described in the big book of A. A. Although some of the items contained in these pages are published with permission of AA World Services, Inc, this does not imply approval of the Web Site by the General Service Conference. (4th, 6th Traditions Violations)

- \* NCPPG's Step working Guide is NOT AA GSC approved, and is created by an INDEPENDENT publisher. NCPPG endorses this non AA GSC Step Working Guide, which is a violation of AA's 6th Tradition regardless if sold at cost, and regardless whether it is displayed or not.
- \* NCPPG DOES NOT support SCIF IN ANY WAY. They have NO representation at SCIF, nor have they financially supported SCIF. (Traditions 1, 2, 6, 7,12 violations)
- \* AA's 6th Tradition was created to prohibit groups from endorsing, financing, or lending AA's name to ANY related facility or outside enterprise. The NCPPG tactic of quoting the 2nd half of Tradition 6 while in violation of its 1st half is STILL a violation of Traditions. Using non AA GSC approved literature FOR ANY REASON is a violation of AA's 6th Tradition. In addition, using said literature jeopardizes the unity of the Fellowship as a whole. - \* As far as NCPPG's statement "To show other alcoholics precisely how we have recovered is the main purpose of this book," NCPPG must remember that a group which uses non AA GSC approved literature to accomplish AA's Primary Purpose is in DIRECT VIOLATION of the 5th Tradition, which, ironically, is the group's namesake! NCPPG must realize that the Twelve Traditions possess no caveat which allows ANY group to violate a specific Tradition (6th) in order to facilitate another. (5th)
