Sonoma County Intergroup Fellowship General Meeting — February 25, 2013. The meeting opened at 8 p.m. with the Serenity Prayer.

Birthdays: Annie T. 33 yrs., Trevor H. 26 yrs., Gus 11 yrs., Scotti B., 4 yrs., Greg 3 yrs.

Officer Reports:

Chair: (Patty G.) Welcomed everyone. Thanked all outgoing committee chairs for being of service.

Vice-Chair: (Tina C.) Welcomed all new representatives. Reminded of importance of arriving early and signing in.

Secretary: (Mark V.C.) January 28, 2013 General Meeting Minutes put forth and approved.

Treasurer: (Jimmie B.) Group contributions for January were \$6,400. Individual contributions were \$550. After expenses, we had a gain of \$2,775. Bookstore income was \$9,077 and after expenses we had a gain of \$574. Overall, we had a net gain of \$3,449. On January 16th, checks were distributed for our end of the year excess disbursement: \$2,628.64 to Sonoma County General Service and \$1,971.48 to both General Service New York and Northern California Coastal Area.

Registrar: (Carolyn A.) Last month there were 232 groups offering 374 meetings per week in Sonoma County. At January's general meeting there were 84 representatives equaling 36% representation. There were 19 new reps at the January meeting. Carolyn thanked everyone for allowing her to serve another year.

Housekeeping Motion: There was a motion to approve SOCYPAA's request for a letter supporting their bid to be the host city of the 2014 ACYPAA Convention. The motion was approved with no objections.

Elections of Committee Chairs: Patty G. explained the majority vote procedure. Activities: Lorie J., approved with one abstention; Alkathons: Richard H., approved unanimously; Communications/Newsletter: Barry D. approved unanimously; Outreach: Benjamin G. approved unanimously; Workshops/Seminars: Kathy M. approved unanimously; Teleservice: Joe B. continues for a second year; Liaison to General Service: Barbara F. approved unanimously; Liaison to H & I: Varuna A. approved unanimously; Liaison to Unity Day: Laurie E. approved unanimously.

Committee Reports:

Bookstore Report: (Annie T.) Linda M. celebrated five years as the manager. There was a party for the volunteers on February 24th. February revenue is up. The label printer is fixed. Storage space rent increasing from \$89 to \$97. The new door coverings are in, cost \$150, look good, check them out.

ICSC: (Annie T.) Member-at-large John F. stepped down. So, there will be an election in March to select a person to finish the 13 remaining months of John's term. Annie's term is ending in April and the election for that will be in April. Pat H. is our accountant and a past Intergroup Treasurer. She donates many hours of her time. She broke her

hip and the Fellowship sent her flowers to wish her a speedy recovery.

Activities: (Tina C.) Thanked everyone for their help. The new proposal from the Santa Rosa Veterans Memorial Building will be discussed at the next steering committee meeting March 11th.

Alkathons: (Kathy M.) Thanked everyone for their help, especially Richard H.

Communications/Newsletter: (Barry D.) Reported that March newsletters are available. Reported that there will be new schedules in April.

Outreach: (Ben G.) Committee is doing better. They let meetings know the importance of having an Intergroup rep. The committee can always use more help.

Seminars: (Chris M.) Twelve Concepts on March 27th – Padee M. & Michael facilitating. Origin of the Twelve Steps on May 29th – Roger facilitating.

Teleservice: (Joe B.) Stated there are 73 total volunteers, of which 42 are active. There is a waiting list. They maintain a Twelfth Step list. They strive to have women work with women. They strive never to turn a call away. Joe asked the reps to ask for differently abled volunteers and volunteers who are Veterans of the military.

ICSC Nominating Committee Election: Mary B., Mike C., and Nevin V. were all approved unanimously.

Liaison Reports:

SOCYPAA: (Natalie L.) They meet 1st & 3rd Sunday at 1551 Montgomery Dr. The Masquerade Ball was a success with over 100 in attendance. The next event is Tacky After ACY, a Thrift Shop Jam on Saturday, March 23rd. Speaker at 8:30 p.m. & dance from 9:45 p.m. – 1 a.m. 1495 W. Steele Lane. ACYPAA will be in March.

Spanish Central Office: (Rosa S.) They meet on Saturdays from 4 p.m. – 6 p.m. at 1700 Corby Avenue, Suite C. They will have their 16th Anniversary Party on March 16th.

H & I: (Patrick W.) Reported there were three brown-outs and no black-outs.

General Service: (Joann L.) February 16 was the Agenda Topics Workshop and it was a success. 125 people from eight different districts attended. This is the time of year for all G.S.R.s to take the Agenda Topics to their group and arrange sharing sessions to hear the groups' conscience. The pre-conference assembly is in Antioch on April 6-7. The G.S.R.s take their conscience to the Delegate. The Delegate will attend the New York General Service Conference on April 21-27. We get to hear what happened at the N.Y.G.S. Conference at an assembly in Livermore on May 18.

PI/CPC: (Diana W.) Described how their committee provides accurate information to courts, Child Protective Services, DDP, health fairs, probation officers, schools and Senior Peer Counselors.

GENERAL SERVICE

Who is in Charge of A.A.?

This is the time of the year when all the A.A. groups in the United States and Canada prepare to share their thoughts and ideas on the Agenda items for the General Service Conference, which takes place once a year in New York City. They do that with the help of each group's GSR, or General Service Representative. This is the person that the group has elected to attend the monthly business meeting at the District level and report back what is happening with the rest of A.A. These Agenda items are called the Agenda Topics.

The GSR brings the information about these Agenda Topics to the group and holds what are called sharing sessions on whatever topics the group decides to talk about. This collection of thoughts and feelings on the topic is called a group conscience. It is not really a vote. It is the essence of everything that was discussed in the group about how they felt about the topic. Ideas of who was in favor, ideas of who were against and the reasons why. It is so different from an actual yes or no vote. It is because the "why's" may hold the key to what is a good decision or what may not be good decision. This is what makes A.A. different from a usual political process. In A.A. we listen to all the reasons behind the feelings on a subject.

Then the GSR will bring his or her group conscience to the Area Assembly, where with other GRSs from other A.A. groups, the GSR will go to a microphone and share with the Area Delegate and all of the assembly how his or her group felt about a particular topic. After listening to what is said at the Area Assembly, our delegate will go to the New York Conference. At the Conference, decisions are made on what is best for A.A. as a whole, but with all of our input taken into consideration. We, the members of the A.A. groups have a voice, we have a vital part in the decision making process. Who is charge of A.A.? For our group purpose there is but one ultimate authority, a loving Higher Power who speaks to us through the group conscience. By participating in the group conscience, we get to be responsible for A.A. as a whole.

Clarifying What A.A. is — and is not

I'm sometimes surprised by the misconceptions held by my non-A.A. friends and family about alcoholics and Alcoholics Anonymous. Just the other evening at a potluck, a friend of many years asked if I would like a glass of wine with dinner. I replied, "No, thank you." She said, "Really, even on special occasions you don't have just one little glass?" "That's right," I smiled. She's known for years that I don't drink and participate in A.A., but obviously she isn't familiar with the program.

When I speak at the Drunk Driving Programs as part of PI/CPC, there are usually questions that reflect a lack of understanding about what A.A. is, and what A.A. is not. But I expect the questions as most folks are outside the Fellowship and that's why we're invited to speak – to provide accurate information about the program of Alcoholics Anonymous.

The Preamble tells us what A.A. is: a fellowship of men and women who share their experience, strength and hope with each other that they may solve their common problem and help others to recover from alcoholism.

What A.A. does not do: We don't recruit members, keep lists, or sponsor research; make medical or psychological diagnoses; run hospitals or detoxes; provide housing, food, clothing, jobs, money, or counseling services; accept any payment or funding for services.

In years past I've been careful about who I told about my participation in A.A., especially related to my work or professional life. But I'm no longer reserved about it; when the opportunity arises I speak freely about my experience of alcohol and drug abuse and how A.A. gave me tools for living without the use of any mind altering substance. The program taught me to live productively, contributing rather than taking away.

It feels good to be in service. If you have a desire to share information with the public and to those who have contact with alcoholics through their profession, please come to the PI/CPC speaker training held on the second Wednesday of each month at 7 p.m. in the Employee Lounge at the underground parking area of Santa Rosa City Hall.

Speaker training topics include the role of the PI/CPC committee, speaking to non-A.A. groups, tips for effective speaking, and requirements for a speaker. The business meeting starts at 7:30 p.m. I hope to see you there.

Meds, Docs and A.A.

A couple of weeks ago I attended a speaker meeting where the speaker mentioned that she had some other "outside issues" that she had to seek medical help for, which included medication. Well, that really made the discussion period lively.

It was a large meeting so we ran the complete range of responses. Everything from "if you are taking medication you are not sober" to quoting from the Big Book, "There are those, too who suffer from grave emotional and mental disorders, but many of them do recover if they have the capacity to be honest." Others cited Alcoholics Anonymous page 58 or "A.A. is not a medical organization, does not give out medicines or psychiatric advice," from A Brief Guide to Alcoholics Anonymous (Pamphlet) page 10.

If or when this subject comes up at your meeting you might want to have a copy of a sheet Access Sonoma County put together with quotes from the Big Book, Twelve Steps and Twelve Traditions, Living Sober and various pamphlets regarding this issue. There is also an excellent pamphlet "The A.A. Member – Medication and Other Drugs." Also we are considering doing a workshop on the subject of "Mental Health and A.A." If you feel there is a need for such a workshop or would be interest in attending such a workshop please let us know.

Reaching Out at a Critical Time

Perhaps the most critical period for the newcomer leaving an institution or managed care facility is when he or she first returns to the world at large. This is the time when they must make the transition from imposed physical sobriety to recovery. The purpose of Bridging The Gap is to help them make this move and to provide them with a support network and the tools to begin a new life in Alcoholics Anonymous.

Any A.A. member can help a newly recovering alcoholic make that first connection with our fellowship if he or she has a car, a license and insurance. You could be the critical difference between recovery and relapse.

Bridging the Gap meets on the third Thursday of each month from 6:30 - 7:30 pm (6 pm orientation for new members) at the Bookstore. We can make a difference.

Facts About the Intergroup Central Service Committee

The Intergroup Central Service Committee (ICSC) is a management and oversight committee specifically charged with responsibility to set the policy, regulate the affairs, and oversee the operation of the SCIF Central Office/Bookstore. It also advises the Steering Committee on matters affecting SCIF's status as a non-profit corporation, making sure that state and federal government regulations are followed and regulatory filings are completed as required. As such, it fulfills many of the functions cited as responsibilities of "the Board of Directors" in the California Corporations Code.

The ICSC is a rotating body of five members – two officers and three at-large members elected by the group representatives. The composition of the ICSC committee changes several times a year, providing both continuity and fresh eyes.

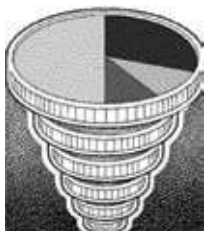
