
If you're reading this, you're obviously

familiar with the SCIF News. The Editor collects news, reports, meeting changes, and other pertinent information for this newsletter. This position requires familiarity with and access to a computer with page layout software and a printer. It also requires familiarity with Excel and Word programs, and very good communication, grammar and punctuation skills. The Editor maintains a mailing list of current subscribers, and prints mailing labels for each issue, also sending email subscribers a version in Acrobat format (pdf).

The Newsletter Editor attends three service meetings per month - SCIF Steering Committee (2nd Monday), SCIF Communications Committee (3rd Thursday), and SCIF General Business (4th Monday) - and reports on newsletter issues. The average monthly time commitment is 16+ hours.

Two years sobriety is the requirement, and previous experience as a trusted servant is recommended.

If you need a shot of enthusiasm for the joy of sobriety and service in AA, come to the Hospitals & Institutions Committee meeting on the first Wednesday of the month (August 6) at 6:00 pm at the Santa Rosa Senior Center (see Calendar).

This is one joyous meeting, and it's worth a look!

(We did not receive an article from our H&I correspondent this month, but we want to salute this service.)

OUR PRIMARY PURPOSE

At a group steering committee meeting recently, a member recalled being told that "General Service is for the politicos; Intergroup is for the social butterflies, and H&I is for people who like to talk about themselves." I thought the statement had the merit of being equally unfair to all. But it also reminded me that some folks think the primary purpose of Intergroup is to sponsor dances and picnics.

Our by-laws say that Intergroup's "primary purpose is to meet the needs of the A.A. groups and to provide services as required." Not to carry the message or to stay sober and help other alcoholics to achievessaturietys of the purpose of the individual A.A. member and his home group.

What are those "services as required?"

- A 24-hour Hotline service, at a cost of about \$10,000 a year
- Pamphlets, meeting schedules, and other materials "free" to groups, at a cost of about \$9,000
- A website and "free" newsletters, at a cost of about \$8,000
- The Central Office/Bookstore, open 44 hours each week. The Bookstore portion of this service is designed to be self-supporting, but the Central Office function provides information and assistance to members and to our service committees, at a cost of about \$26,000 last year
- Three Alkathons each winter, and several seminars yearly, all striving to be self-supporting
- And, yes social events like dances and picnics, also intended to be selfsupporting

A word about those "self-supporting" services: last year, the social events, seminars, and alkathons together netted \$128 more than they cost; the bookstore came in with \$3,200 over its expenses. See this month's financial report (page 7) for how we are doing for the first six months of 2008. All other services listed above are funded by the generous contributions of groups.

I like to think that Intergroup functions as a clearinghouse of information about the life of Alcoholics Anonymous in Sonoma County and provides services to support that life. In our newsletter and at our General Meeting, we share what's new, what's needed, and what's interesting in local A.A. We ask the groups – through your Intergroup Representatives – what our priorities should be. Your Intergroup officers, committee chairs, and countless volunteers clearly understand that we are serving a diverse community of A.A. members – some never use the bookstore; some never go to dances, some never phone the office or the hotline. So we rely on the group conscience of this community, expressed by Intergroup Reps, to determine how best to serve each segment of this population. That's how we determine our "primary purpose."

I recently spoke to a newly-elected rep who was surprised and delighted to learn that her role included asking her group for its opinion on Intergroup initiatives, not just to pick up flyers and newsletters and report on the General Meeting.

So if your Intergroup Rep is reporting only about parties, campouts, dances (all of them important, but not the whole story), perhaps you might ask some questions. We're not just the social butterflies – we're worker bees.

VICE CHAIR: Bob P. - Bob had five new Reps at the orientation tonight. He invites Reps with questions to call him at his phone number in the newsletter.

TREASURER: Pat H. - Overall expenses exceeded income by \$1,047 for the month of May. Group-supported expenses exceeded income by \$1,356 for the month of May and \$926 year-to-date. Group contributions have been lower this year than in past years. It might be the economy. ICSC is not concerned as we still have >\$15,000 in operating reserve (in excess of prudent reserve) She is looking ahead to plan and budget for rest of the year. Pat apologized for the financial statements printed in the newsletter - there were some errors: Titles should read May (not April); Group contributions ran into birthdays and there are no group names on last few in column; and the central office expenses for May 2007 were \$2,107 (not \$2,165)

SECRETARY: Donna L. - The June SCIF General Meeting minutes published in the July newsletter were approved without changes. REGISTRAR: Nan B. - Last month there were 363 meetings/week in Sonoma County. Of those, 143 (39%) were represented at Intergroup. Nan put in a plug for current reps to pitch Intergroup representation at meetings that don't have a Rep, and asked Reps to send a substitute Rep to the General Meeting if they can't attend.

BOOKSTORE: Linda M. - Bookstore will be closed Friday, July 4. She needs volunteers with at least 1 year sobriety on alternate Wednesdays from 10am-2pm, and on alternate Saturdays 11am-3pm (to assist woman volunteer in wheelchair with various tasks). There is a 6 month commitment. Interested? Call Linda at 546-2066.

COMMITTEE REPORTS:

ICSC: Rich S. - ICSC reviewed the financial report presented by the Treasurer. Linda gave the bookstore report (see above). Gene H. has been working with property management re: a 3 year lease with a 5 year option. Gene and Rich ask contractors to give them estimates for renovation. Diane will write a motion on renovations for SCIF steering committee.

ACTIVITIES: Laurie E. - The annual Family Picnic will be July 5th at Youth Community Park on Fulton Road across from Piner High. Bring a potluck dish to share, hot dogs, hamburgers and soda available for purchase. Volunteers are needed.

ALKATHONS: Barbara F. - Barbara stated that she needs help with the alcathons; her phone number is 318-5376.

NEWSLETTER: Roger D. - Roger apologized for the errors in the July newsletter. There is a new newsletter submission deadline – the Friday after SCIF Steering Committee meeting.

OUTREACH: Sean M. - Sean has been getting reports from the Registrar re: unrepresented groups that used to have Reps. He asked for volunteers to assist him in getting to these meetings to encourage them to have representation at the Intergroup General meeting. **SEMINARS:** Doug S.- The next seminar will be held on Wednesday, July 30 from 6:30-8pm at the bookstore, and the topic is "The Family in Recovery".

TELESERVICE: Dave R. - (Dave absent – Bob K gave report) Teleservice works to ensure there is a live alcoholic available on the AA hotline 24/7. There are currently two open shifts: Sunday overnight (10p-9a) and alternating Saturdays overnight (10p-8a). Their business meeting is on the 2nd Monday at 6pm in the bookstore.

LIAISON REPORTS (see Calendar, Page 6, or Liaison Committee reports for committee meeting information):

BRIDGING THE GAP: John B. - BTG introduces newly-released residents of treatment facilities to AA in their community. Members volunteer to take people to their first meeting. Volunteers should have 6+ months of sobriety and a working knowledge of the 12 steps. Transportation is also helpful. Contact volunteers are needed as are volunteers at the committee level. In June, BTG had 40 contacts: 20 local, 14 out of the District, and 6 out of the Area.

PI/CPC: Nick R. - Public Information/ Cooperation with the Professional Community distributes literature to emergency rooms, hospital waiting rooms, libraries, senior centers and other public locations. SOCYPAA: Tashia F. - SOCYPAA filled all 36 positions in their recent elections. They are planning a campout for the end of August in Bodega Bay – flyers coming soon. They are hosting the ACYPAA summit meeting, with Q&A sessions re: annual conference bidding, on October 10-11 at the Carpenters Union Hall. The first meeting will kick off at 7:30am. There is a new flyer that lists all the SOCYPAA meetings.

ACCESS SONOMA COUNTY: Jamie T.- The "Voices from Home" program offers brochures and the Big Book in many foreign languages including: Chinese, Farsi, Hungarian, Italian, French, Arabic, Portuguese, Tagalog, and Thai. GENERAL SERVICE: Lauralyn C. - The Treasurer has made a motion to raise their prudent reserve from \$1500 to \$3500.

PRESENTATION OF NEW BUSINESS:

Diane made Reps aware of the revised bylaws handout and the explanation article handout. She asked Reps to discuss these with their groups and come back next month for discussion about the revisions. Gary S. stated that he'd like to see the words "any" and "all" eliminated from the bylaws.

GROUP REPRESENTATIVES SHARING:

The Women's Meeting at 8pm on Mondays at Orenda needs support, especially from those with long term sobriety.

Mark V. said the Cache Creek trip was great, and that 50 sober alcoholics from Orange County joined them for a 200-person meeting on the river. They will try to combine their trip with these folks next year, and book the whole campground.

How It Works – Sunday 7:30pm on Newanga, has been meeting outside under the oak trees, next to the playground. Come and join them.

SUMMATION: Bob P. reviewed pertinent items for reps to take back to their groups.


