Chair: (Holly H.) First let me say thank you to Barry for covering for me in my absence. It made me feel really good to know that things were in Barry's very capable hands. There is a lot going on in Intergroup! The Founder's Day Picnic was Saturday the 20th at Howarth Park. Thank you to all who made themselves available to help. The Bookstore "redo" committee has things well in hand, and it looks like we may be able to get some new paint on the walls in August. We will be doing the Alkathon Lottery directly after the SCIF General Meeting on September 20th. The forms for the groups to fill out will be available at the SCIF General Meeting in July and August, as well as at the bookstore. A representative from your group needs to bring the completed form to the Alkathon Lottery directly following the September General Meeting. Just a reminder that you need to have someone from your meeting present on September 20th after the General Meeting in order to participate in the Alkathon Lottery. Linda W. will facilitate the lottery. Only one form is needed for all Alkathons.

ADJOURNMENT: The meeting adjourned at 8:44 p.m. with the Responsibility Statement.



Is your home group "kid friendly"? What about the other meetings that you frequent? According to our most recent meeting directory, meetings that identify as kid friendly are pretty scarce. That could be a serious problem for an alcoholic who needs a meeting but is responsible for a child. It could work out pretty badly for the child, too.

Each group decides its own policy on such issues and with our tradition of autonomy, each group is inherently "right" in whatever policy they choose. Perhaps with the exception of closed meetings where attendance is limited to alcoholics, there is no official "A.A. way" when it comes to welcoming members' children at meetings, or not. Some groups decide that their meeting isn't appropriate for kids. Others will welcome well-behaved kids. A couple of meetings locally even have childcare provided by group members so a parent can get a meeting without distraction.

Of course, we at Access have absolutely no opinion on how your group deals with the issue. We would however...in the spirit of making the A.A. message accessible to all...ask you to check your listing in the meeting directory and see if your meeting is listed with a "K" for Kids-Children welcome. It would be a shame if a parent who needed a meeting and would have been welcome at your group missed out because of an incorrect listing. Thank your for your service!

2015 ALKATHON LOTTERY

ntergroup would like to announce the 2015 Alkathon lottery. Each ▲A.A. group may host one or more of the 14 Alkathon meetings scheduled for Thanksgiving, Christmas, or New Year's Eve. The Alkathon lottery forms will be available at the July Intergroup General Meeting and at the bookstore. Please have your Intergroup representative bring the completed form to the SCIF General Meeting on September 28, 2015. Directly following the meeting a lottery will be held to determine which A.A. group(s) will host one or more of the Alkathon meetings. If your group does not have a rep, someone must be present to participate in the lottery process. There are no pre-designated meeting slots—all slots are open. The lottery will include all applications received, and will be chosen at random. This will be repeated until all slots are filled. BRIDGING THE GAP

Bridging the Gap Helped Save My Life

After thirty-five years of drinking, the last fifteen every day and the last five at an insane pace, I finally hit *my* bottom. When I checked into rehab on April 7th, 2014 my physical health was fading fast and my mental state had deteriorated into confusion and a recurring belief that maybe suicide was the best solution. I had tried quitting in the past and even gave A.A. a try a couple of times but it didn't stick. Looking back I realize it didn't stick because I didn't truly understand the enormity of my problem.

From the moment I checked into rehab I heard the same thing over and over again. Go to meetings (90 in 90), get a sponsor, do the steps, find a higher power and get in service. I also realized that there was a time that I loved the high I got from alcohol and that returning to casual use was a pipe dream. Mainly because why would I want to do something once in a while that brought me great pleasure? If it pleases me I want to do it all the time, that's how I'm wired... All or nothing. But that was still always my hope with previous stops in A.A.... That I could one day be "cured" and be a normal drinker again. Ha, cured! What does that mean? My brain did a wonderful job of making me believe that self-deception. Apparently left on its own, to guide my life, my brain wants to hurt me.

Rehab got me sober, A.A. has given me the tools I need to stay sober and Bridging the Gap has helped build my self-esteem, provided comradery, friendship, accountability and given me a purpose that I look forward to on a daily basis. For me it is true that the rewards of helping another alcoholic are greater than anything else in my life and that keeps me sober. And for me to drink is to wither away and die.

So, Bridging the Gap continues to help save my life in early sobriety.
