HAS YOUR GROUP TAKEN INVENTORY LATELY?

Many groups periodically hold an AA group inventory meeting to evaluate how well they are fulfilling their primary purpose: to help alcoholics recover through A.A.'s suggested Twelve Steps of recovery.

Some groups take inventory by examining our Twelve Traditions, one at a time, to determine how well they are living up to these principles.

The following questions, compiled from A.A. shared experience, may be useful in arriving at an informed group conscience. Groups will probably wish to add questions of their own:

- 1. What is the basic purpose of our group?
- 2. What more can our group do to carry the message?
- 3. Is our group attracting alcoholics from different backgrounds? Are we seeing a good cross-section of our community, including those with special needs?
- 4. Do new members stick with us, or does the turnover seem excessive? If so, why? What can we as a group do to retain members?
- 5. Do we emphasize the importance of sponsorship? How effectively? How can we do it better?
- 6. Are we careful to preserve the anonymity of our group members and other A.A.s outside the meeting rooms? Do we also leave what they share at meetings behind?
- 7. Does our group emphasize to all members the value of keeping up with the kitchen, set-up, clean-up and other housekeeping chores that are essential for our Twelfth Step efforts?
- 8. Are all members given the opportunity to speak at meetings and to participate in other group activities?
- 9. Mindful that holding office is a great responsibility not to be viewed as the outcome of a popularity contest, are we choosing our officers with care?
- 10. Are we doing all we can to provide an attractive and accessible meeting place?
- 11. Does our group do its fair share toward participating in the purpose of A.A.—as it relates to our Three Legacies of Recovery, Unity, and Service?
- 12. What has our group done lately to bring the A.A. message to the attention of professionals in the community—the physicians, clergy, court officials, educators, and others who are often the first to see alcoholics in need of help?
- 13. How is our group fulfilling its responsibility to the Seventh Tradition?

INVENTORY THE BIG BOOK WAY

Since I've walked in to the meeting rooms of AA, my sponsor insisted that I only share my experience with booze and God and to leave my opinions to myself. He also insists that all of my recovery be based on the Big Book. One of the things that I cannot say enough about is the inventory process. Inventory work has peeled back the layers of my persistent delusions and been the main spiritual tool to chisel away my self pity and the what if/if only stories that I've been telling myself since I was a child. I'm approaching 7 years of sobriety and have written 3 inventories in the 4th step format and am currently writing a 4th. I'm beginning to recognize when I ought to write an inventory: when I feel like what's going on inside is bigger than what's going on outside. Something (resentment and fear usually) is blocking me from a clear path to my God.

Page 64 of the Big Book states that resentments are the #1 offender. It destroys more alcoholics than anything else and from resentment stems all forms of spiritual disease. When I'm angry or resentful, my mind and spirit go to two places. One being a victim and self pity, the other being vengence with no room for God in between. Without my God working in my life, I'm in danger of insanity returning, of taking a drink, living drunk and eventually dying drunk. In my first inventory, I was satisfied when writing it that I was finally going to list and explain to another, surely understanding, person how everyone in my life had done me wrong and I was a hapless victim of a cruel world. I wrote down every person that I had been angry at for decades.

In my 5th step, it was revealed to me that the majority of people I had been resentful at my entire life hadn't done me wrong at all, I had only thought they had. I had been a victim of very little of the items on my inventory and I was shown that these people simply weren't the people I thought they should be and didn't behave the way I thought they should have and everything between the "A,B,Cs" and the 3rd Step Prayer came to life for me. There are 3 prayers in the 4 step, the 1st being the resentment or "Sick Man's" prayer on page 67 of the Big Book. "We said to oursevles, 'This is a sick man. How can I be helpful to him? God save me from being angry. Thy will be done."

Fear. "This short word somehow touches about every aspect of our lives. It was an evil and corroding thread, the fabric of our existence was shot through with it," page 67 of the Big Book. The following page states fear ought to be classified

with stealing. After some consideration, I noticed that my fear rational or otherwise - was robbing me of my participation in life. Everything I do and every decision I make is based on my level of comfortability.

My best friend is in the fellowship and she constantly reminds me that life begins at the end of my comfort zone. My sponsor tells me to say "yes" to my life. But it's my fear - fear of not getting what I want or fear of losing something I've got - that prevents me from experiencing a larger, fuller life. In my fear inventories, I have discovered how fear works in my life and that self reliance fails me every time. In aspects of my life that are uncomfortable, frustrating or occupying much space in my mind, I've been told to find the fear and I'll find the manifestation of self. On page 68 is the 2nd prayer, the fear prayer, "We ask him to remove our fear and direct our attention to what He would have us be. At once we commence to outgrow fear."

Next is a thorough sex inventory. If you didn't write a thorough sex inventory then you haven't finished your 4th Step. If you haven't finished your sex inventory, is it possible that it's an area of your life you are experiencing fear and frustration? In looking at my sex inventory I realized there isn't any area of my life where my character defects are more sharp and ready to use. I'm never more selfish, dishonest, resentful and afraid than in my romantic entanglements. It was also vital in this part of the 4th Step that I realized how sex had also been a source of ease and comfort much like booze and drugs. Left no stone unturned and what was unique in comparison to the resentment and fear portions of the 4th step, I found a lot of shame. I didn't understand that shame could exist in a straight guy's sex history and found that there were things that I didn't want to be doing with people I didn't want to be doing them with that were detrimental to myself. I had no problem being dishonest, manipulative, mean, and self pitying with women in order to get what I want and without offering anything in return. "In this way we tried to shape a sane and sound ideal for our future sex life. We subjected each relation to this test-was it selfish or not?"

We asked God to mold our ideals and helps to live up to them. We remembered always that our sex powers were God-given and therefore good, neither to be used lightly or selfishly nor to be despised and loathed," page 69. - Dave C.

If these topics interest you please ask you group representative when you will be having a sharing session. Our Summer Assembly will be September 14th this year (and in Petaluma) and we will be discussing this business at this assembly so the groups will have plenty of time to talk about these motions. We cannot be an informed area without our groups participating! Last but not least we will be talking about a 5th Edition Big Book and if it passes, we will send another request for New York to consider a 5th Edition Big Book of Alcoholics Anonymous. If this sounds like déjà vu well it is. The Conference considered a 5th Edition and stated, "now is not the time". Our area had been discussing this and if you want to know what happens next....come on down to Petaluma for the Summer Assembly.

Our District meeting is the 1st Monday of the Month at Faith Lutheran Church at 4930 Newanga Avenue, Santa Rosa. Orientation is at 6:45, service manual/concept study at 6:45 and business meeting at 7:30. Come on over and check it out...we love visitors!
