# **Ponder This**

It is useful for those recovering from addiction to consider reciprocity. I refer to the concept of mutual support in the Fellowship of A. A. It is the opposite of, "I want what I want when I want it." It calls attention to ego deflation, humility and helping others, through the practice and attitude of giving (altruism) rather than simply demanding and getting.

Who is the most powerful person in a civilized home? Who is also the most dependent person in the household? The Baby, the infant, the child, the small inthe-making person who exhibits little or no thought to anything or anyone other than self and his/her demands. Do new people and "slippers" in A. A. exemplify this stage of development?

If so, we have examples of the King or Queen Baby Syndrome, I refer to it as Arrested Infantism. A person who has not developed even to the point of Arrested Adolescence exhibits such behavior. This individual behaves as does the baby with a complete lack of concern or attention as to how their demands, preferences and expectations impact others. "It's all about ME!" You could add, "And to hell with you." But that would be so rude!

For such a person preferences, demands and

behavior are expressed only in terms of Self. "I can't stand all this repetition." "Why should I do Service?" "I don't put money in the basket." "I've never had a problem with drugs!" "I never drank that much!" "I can't relate to those people." "My sponsor won't give me enough time or attention."



"I, Me, Mine" was a Beatles' song, wasn't it? Those around the Fellowship who stagnate at this point are seldom happy or successful members. Such a person misses one of the greatest opportunities the program Alcoholics Anonymous has to offer, that of giving it away in order to keep it. A summary of the Twelve Steps says, "Grow Up!"





# LISTEN

I look into young eyes and see the cover that has grown over the shine -Put there by experiences too old for their years. Too painful to bear, too lonely to be imagined.

I see a certain dusty deadness that grows like mold on bread. Transforming this child into someone who is too old to be young and too young to be old.

"I've been ignored," he said, "dying for some attention, some love, some understanding, some discipline. Longing for something on which I could depend but everything changes around me like the shifting desert sands.

I've been hungry. No breakfast, no dinner, no milk for you. Birthday cake? Don't be foolish. We deal with much broader issues here. Stop dreaming. Stop thinking about it.

I've lay awake, wet with fear, straining for each noise, any motion Ready for what will be next. Ready? Ok - not ready. Trying to be ready. Ready to be ready.

The amazingly ingenious part is I've learned to cover it all up with a milky, "I'm bored and I don't really care" look. It's my best one! I almost believe it myself.

I've wrapped myself in defiance and indifference, muting my ears so I don't have to hear what's out of my reach, see what's too painful to see or think about what's too distant to touch.

I'm lost in my own life - locked up in my own body, out of control and too young to begin to understand how this happened to me.

Please listen to the words I don't say!
