
BOOKSTORE

They provide all kinds of services to veterans free of charge on a weekly basis. This was A.A.'s first presence at this event. They've invited us back the second Tuesday of every month. Specific outreach to veterans is new for PI/CPC and something we are very committed to.

This is just the beginning. If this is something that speaks to you or you are a veteran and would like to join us, we meet the 2nd Wednesday of the month at the Santa Rosa City Hall Underground. Speaker training is at 7pm, and business meeting is at 7:30

We do have a 2 year sobriety requirement (except for Young Speaker, which is 1 year).

SONOMA COUNTY INTERGROUP FELLOWSHIP GENERAL MEETING - OCTOBER 23, 2017

BIRTHDAYS: Mike (32 yrs), Danny (2 yrs), Jane (5 yrs), Debbie (39 yrs), Jason (3 yrs), Kevin (6 months).

ELECTIONS:

Election of Liaison for Spanish Central Office: Election was postponed until next business meeting.

Election to ICSC: There were two candidates (Kevin T., and Mike K.) Kevin was elected to the committee.

Election of Treasurer: Carolyn A. was elected until next election in January.

OFFICERS REPORTS:

Chair: (Barry D.) James fills in, nothing new to report.

Vice Chair: (James C.) There were four new reps tonight.

Secretary: (Patrick B.) September 2017 general meeting minutes were passed.

Treasurer: (Carolyn A.) Group contributions for October were \$5,152 and interest from bank of \$1.00 for a total of \$5,153 which was \$1,747 less than October of last year and after expenses we had a net gain of \$1,630. Bookstore income was \$4,921 and after expenses we had a net loss of \$882. The play income was \$2,899 and after expenses we had a net gain of \$759. Overall, we had a net gain of \$1,773 and year to date we have a net gain of \$5,881.

Registrar: (Linda W.) As of today's date, there are 237 groups in Sonoma County offering 351 meetings each week. There are 159 meeting representatives on record, for 67% participation. There were 81 representatives attending the September 2017 General Meeting, for 51% participation. There were 9 new reps attending the September 2017 new rep orientation.

BOOKSTORE REPORT: (Glenn C.) The new Grapevine book, "Voices of Women in A.A." is here; price is \$13.49. The sale book for November is "As Bill Sees It" regularly priced at \$11.64, sale price is \$9.31 plus tax. The bookstore will be closed on Thursday, November 23 for Thanksgiving. Pacific Standard Time starts on Sunday, Nov. 5; new bookstore hours start Nov. 6: Mon-Thurs close at 5 rather than 6; Fri open till 6, Sat 11-3. We need a new volunteer to make our bling chips, perhaps a jeweler or someone with similar aptitude. Approx. 10-15 chips a month; contact the bookstore. We received 12-15 boxes of used books (Big Books, 12&12's among others) plus pamphlets and old Grapevines donated by recovery folks in Marin and SF for those affected by the fires. Come to the bookstore to help yourself.

ICSC: (Esther S.) Thank you to the group for the privilege of serving this committee.

Teleservice: (Gus C.) There is one shift open; Tuesday 1-6pm.

ICSC NOMINATING COMMITTEE: (Cindi W.) Thank you to Esther for her service. The next ICSC election will be in April.

Staying Sober Under Fire and In the Fire

We are not separate from our A.A. ancestors. Their Big Book stories live in our stories today.

"When World War II broke out...A.A.'s entered the services and were scattered all over the world. They had even fewer alcoholic lapses or emotional binges than A.A.'s safe at home did. They were just as capable of endurance and valor as any other soldiers. Whether in Alaska or on the Salerno beachhead, their dependence upon a Higher Power worked" (P. 38, 12 & 12).

All of us, in our own way, stood up under fire, just as WWII A.A. soldiers did.

To those who lost their homes in the fires (think low bottom) are like the stories in the Big Book: They Lost Nearly All. To those who watched from afar breathing smoke for a week (think high bottom) is like the section They Stopped In Time and the story, It Might Have Been Worse.

These fires have changed us all. "No matter how far down the scale we have gone, we will see how our experience can benefit others" (P. 84). We listen to each other's fire story to learn— to learn how each stayed sober through it all. Our stories may be different but the rest is the same, we follow what those in the Big Book did. No matter what, don't drink. We reach out to those who are still suffering. We are survivors!
