

Secretary: (Erin H.) Minutes were passed.

Treasurer: (Susanne L.) The Central Office income for September 2019 includes \$4,600 from Group Contributions, and \$21 from Bank Interest for a total of \$4,621. Total expenses for September were \$3,718. The Bookstore income for September 2019 includes \$6,600 in sales. The Bookstore expenses were \$7,366. We had a net gain of \$136 in September 2019. Year-to-date, our income is \$115,669. Our expenses are \$102,171, leaving a net gain of \$13,498.

Registrar: (Peter R.) As of September 23rd, there were 234 groups in Sonoma County offering 346 meetings each week. There are 168 meeting representatives on record, for 67% participation.

BOOKSTORE: (Glenn C.) The bookstore has power and will be open as long as we do have power; come on in if you need a place to have a cup of coffee and share your resentments. The book on sale for November is, Voices Of Women. Regular price \$13.49, on sale for \$10.80 plus tax. We are now selling canvas tote bags imprinted with AA slogans/prayers for 13.99 plus tax. Remember this coming Sunday to set your clocks back one hour. New hours are, Mon-Thurs 10am-5pm; Sat. 11am-3pm.

Activities: (Marji B.) We had great volunteers at the Halloween dance and a great DJ.

Alkathons: (Kevin H.) We need a lot of volunteers to put the whole Alkathon together. Planning meetings will be 11/7, 11/12, and 11/21 at 7pm at the bookstore.

Newsletter: (Ryan L.) We need encouraging words from members submitted to the newsletter.

INTERGROUP TREASURER'S REPORT - OCTOBER 2019

The Central Office income for October 2019 includes \$5,922 from Group Contributions, \$10,000 Individual Contributions, \$25 from Group Insurance, and \$12 Bank Interest for a total of \$15,960. Total expenses for October were \$3,909.

Of special note: The \$10,000 individual contribution was bequeathed from a member of Alcoholics Anonymous.

The Bookstore income for October 2019 includes \$7,266 in sales, \$25 from Group Insurance, and \$894 from Activities for the Halloween Dance. The Bookstore expenses were \$9,298.

The Halloween Dance produced a loss of \$558.77 and it was anticipated because of low attendance due the Kincaid Fires and evacuations.

Overall we had a net gain of \$11,027 in October 2019. Even without the significant donation of \$10,000, we had a gain of \$1,027.

Year-to-date, our income is \$139,813. Our expenses are \$115,289, leaving a net gain of \$24,525.

BRIDGING THE GAP

Greetings fellow Alcoholics!

My name is Michael DiFranco and I am the men's coordinator for the Bridging the Gap service in Sonoma County. I take a presentation for BTG , along with my partner, Jim Smuck, into Azure Acures in Sebastopol, my home town. Jim is also an Azure Acre Alumni.

When a man residing in a recovery facilty decides he would like someone from our fellowship to connect with him on the day he is released, and he has filled out a BLUE request card, I look through my list of volunteers and make the call or text asking a volunteer to reach out to the cient/newcomer to help them feel connected to our fellowship and our meetings. We all know how quickly our minds talked us right back into a drink when no one is looking or... we thought we could suddenly drink safely and sanely or ...we just threw it all to the wind again and stopped caring.

Most of us know the story of how our co-founder, Bill Wilson, when traveling away from home, noticed the clamouring and clanging of the glasses and bottles and the cheerful chatter he could hear coming from the bar... knew he had to find another Alcoholic to talk to so he wouldn't be tempted by the cunning, baffling, powerful and convincing voice in his mind to take a drink. What we do here in Bridging the Gap is close to the same thing. It's as close as we get to a 12-step visit in a hospital just like the old days, but it seems somewhat common in our fellowship to resist stepping up and serving. Many times we have to be railroaded. I'm that way too, but I think we can all agree that once we accept our appointed position, we actually like it and appreciate serving. It's gets us out of ourselves.

Remember, our Big Book says "selfishness, self-centeredness is the root of all of our troubles". So we need the help as much as the newcomer does. So please consider helping us out by volunteering to be on our call list, man or woman, or even step up to be a presenter at a facilty. You will love throwing your pitch at these newbies. :))
