SCIF Committee Chairs, Liaisons to be elected February 23

Trusted Servants needed for Activities, Alkathons, Communications, Outreach, Seminars

SCIF Committee Chairs and Liaisons will be elected February 23, 2015, 8 p.m. during the Intergroup General Meeting at St. Luke's Lutheran Church. The positions to be elected include chairs for Activities, Alkathons, Communications/Newsletter, Outreach, Seminars, Teleservice, Unity Day; Liaisons to General Service and H&I; and the ICSC Nominating Committee (three positions).

Term length for all jobs is one year. Two consecutive terms are allowed. Recommended length of sobriety for all positions is two years. All Committee Chairs are required to attend the SCIF Steering Committee and General Meetings.

Activities Chair: Coordinates dances, summer picnics, and other activities and functions within Intergroup. Basically, puts the functions together. Must be able to delegate responsibility. Complete guidelines have been formulated for this service position. Average monthly time commitment: 20+ hours.

Alkathons Chair: Secures site for and coordinates organization of Thanksgiving, Christmas and New Year's Alkathons. Requires ability to recruit subcommittee chairs, delegate to them, and coordinate their efforts. Draft budgets for all three Alkathons, shop for supplies, and maintain a spreadsheet. Knowledge of Microsoft Word and Excel is helpful. Hold regular planning meetings for the Alkathons. Average monthly time commitment: 10+hours.

Communications Chair/Newsletter
Editor: Collects articles, reports, and meeting

changes for monthly Newsletter. Produces copy in format suitable for professional printing and delivers it to the printer. Maintains list of current subscribers. Prints mailing labels; sends PDF version to email subscribers. Requires familiarity with image and page formatting software or interest in and ability to learn such software. Familiarity with Microsoft

Office is necessary, particularly Word and Excel, as is a working knowledge of the English language. Manages updates to website and meeting directory, as well as directory printing. Average monthly time commitment: 15-20 hours.

Outreach Chair: Checks attendance for registered groups. Checks with groups to encourage groups to participate in the A.A. community and Intergroup, so finding volunteers to attend meetings is necessary. Average monthly time commitment: 6-12 hours.

Seminars Chair: Determines what workshops the Fellowship is interested in. Arranges for speakers and/or panels; contacts participants; sets up time and room for meetings; gets information into Newsletter; encourages participation. Average monthly time commitment: 6-10 hours.

Teleservice Chair: Oversees day-to-day operations of Teleservice. Conducts monthly Teleservice business meetings. Average monthly time commitment: 8-10 hours.

Unity Day Chair: Select a committee to help coordinate the event. Committee creates theme. Submit a budget to Intergroup steering committee for approval. Organize potluck, speaker panels, entertainment, raffle, creation and printing of flyers.

ICSC Nominating Committee: Three (3) members to be elected. Sobriety requirement – 2 years. Duties: "In April and October of each year, the Nominating Committee will present to SCIF not less than two (2) and not more than three (3) qualified individuals available to serve on the on the ICSC. Election will be by simple majority vote at that meeting."

SCIF Liaisons to Sonoma County General Service, Hospitals & Institutions:

Liaisons report at their monthly meetings news of interest about Intergroup. Must attend the monthly SCIF General Meeting. Average monthly time commitment: 2-4 hours.

It's been over 80 years now since Bill W. had his last drinking bout during the closing months of 1934 and we'll celebrate A.A.'s official 80th birthday this summer on the the anniversary of Dr Bob's last drink. Isn't it interesting that our official birthday commemorates Bob's last drink rather than Bill's?

Really, it seems, what we celebrate is the carrying of the message of sobriety, rather than the sobriety itself. No doubt, Bill's sobriety began on Dec. 11, 1934 but OUR sobriety... our fellowship and AA itself began when the message was relayed from one alcoholic to another.

For me, alcohol stopped being an issue in my life when carrying the message of A.A. to my fellow alcoholics became an issue in my life. I didn't "solve" drinking or even "quit" drinking one day...drinking just went away for me when YOUR SOBRIETY became important to me. I don't have to know your last name or your profession or frankly even "like" you very much. If I'm thinking of you rather than me, drinking hasn't shown up as an attractive option for me...and I invariably end up liking you.

Just like it's talked about in the 10th Step Promises on pages 84-85 in the Big Book "We will see that our new attitude toward liquor has been given us without any thought or effort on our part. It just comes! That is the miracle of it. We are not fighting it, neither are we avoiding temptation."

I've been doing this deal for a while now and I've gone through periods where I was kinda "fighting it"...I was sorta "avoiding temptation". I may have been technically sober but I wasn't carrying the message to the still suffering alcoholic. My life was about me, my and mine.

There's absolutely nothing special about me. Many of you reading this can relate. Here's why I bring it up...If you happen to be going thru one of those periods where your life is a little too much about you...where drinking is something you're "avoiding" or "fighting"... gimme a call. Our Access Sonoma County Committee has opportunities for you to be of service. We're doing some really worthwhile stuff this year and we need you. And by giving it away, you will keep it.


News From The Bookstore

"I have had many experiences with atheists, mostly good. Everybody in A.A. has the right to his own opinion. It is much better to maintain an open and tolerant society than it is to suppress any small disturbances their opinions might occasion. Actually, I do not know of anybody who went off and died of alcoholism because of some atheist's opinion on the cosmos.

"But I do always entreat these folks to look to a "Higher Power"— namely, their own group. When they come in, most of their A.A. group is sober, and they are drunk. Therefore, the group is a "Higher Power." That is a good enough start, and most of them do progress from there. I know how they feel, because I was once that way myself." [Bill W., Letter 1962]
