

OFFICER REPORTS:

CHAIR: Diane W. Thanked Tim P. for filling in for her at the last General and Steering Committee meetings. Thanked the volunteers for Unity Day. Reminded us that the December General Meeting would be on the 17th.

VICE CHAIR: Tim P. The New Rep orientation is at 7:30, before the General Meeting. He suggested we read the *Suggested Procedure for Doing Business at SCIF* to our groups.

TREASURER: Larry O. October group contributions were \$3,770; the Bookstore netted \$701; the Halloween Dance netted \$43. Teleservice expenses were down because we were not charged for our September Press Democrat Hotline ad (inquiries are being made). October net was \$1,236 and year-to-date net is \$14,734. Group contributions have exceeded last year's total: 2006 - \$47,413; 2007 - \$47,866. The 2006 income tax returns, (state and federal), were prepared and signed by Pat H., reviewed by John S. and approved, signed and mailed by Larry O. on 11/12/07. **SECRETARY: Nan B.** Asked for and received approval of

the October General Meeting minutes. **REGISTRAR:** Susy E. Diane W. filled in while Susy is recovering from surgery. There were 366 meetings per week in October, 129 were represented by 70 reps for 35% representation

BOOKSTORE: Gloria P. The bookstore has an opening of every other Thursday morning. They need a female volun-

teer to assist a female wheelchair-bound volunteer the last Saturday of the month from 11 to 3. Bookstore earnings are up \$2000 from this time last year. There are a lot of markdowns at the Bookstore and they make great holiday gifts.

COMMITTEE REPORTS:

ICSC: Pat H. The committee is very happy with the financial reserve and have begun discussion of the best way to put it to use. Some possibilities are adding \$5000 to the prudent reserve, making improvements to the SCIF office, and sending money to New York. November 15th was our tax deadline and we filed on time.

ACTIVITIES: Laurie E. Flyers for The New Year's Eve Dance are available. Decorating will start at noon on New Year's Eve. The decorations are extensive and will require 50 volunteers. Volunteers can call Laurie in advance or just show up. The most difficult job to fill is typically cleanup, and volunteers are greatly appreciated for this. She also needs a speaker.

ALKATHONS: Dale E. The volunteers for the Thanksgiving Alkathon did great jobs, especially Jeff S. and Jill S., volunteer coordinators. There are two more Alkathons coming up and there are flyers for those.

NEWSLETTER: Dave H. We were reminded that the deadline for submitting items for the next Newsletter is the second Monday at midnight.

OUTREACH: Barbara F.-K. Outreach goes to meetings to let our community know what Intergroup does and to encourage meetings to send a representative. There is a new meeting on Ridley Ave. she will try to attend.

SEMINARS: Donna L. There will be a change in the day and time the next seminar will be held. It will be Wednesday evening, January 23, from 6:30 to 8:30. The topic is *Being of Service at Meetings*. There will be flyers at the Bookstore and at the next General Meeting.

STEP ZERO - GETTING TO AA



Bridging the Gap provides support for anyone who has just been released from a hospital, treatment center or correctional facility by providing temporary contacts who help the newcomer make the transition to Alcoholics Anonymous in his or her home community.

Patients and inmates are often introduced to AA while in treatment or correctional facilities, but they may not know how to proceed once released, and sometimes find it difficult to reach out to AA on their own. Statistics show that these people have a significantly higher chance of staying sober if they get to a meeting immediately following their release. Bridging the Gap volunteers act as liaisons, working in pairs to take the individual to his or her first AA meeting outside the institution.

People who are about to be released from an institution can complete a card requesting a temporary contact of the same gender and age group who can take the newcomer to a meeting. Temporary contacts answer questions that the newcomer has about AA, and share information about the importance of home groups, sponsors, and going to meetings.

Bridging the Gap committees exist at both Area and District levels. The cards are returned to the Area BTG chair, who then forwards them on to the appropriate district representatives. The CNCA Bridging the Gap committee invites anyone who is interested in BTG—either participating or just learning more about it—to attend the monthly committee meeting in Petaluma.

The meeting is held every fourth Saturday at 11:00am, at the Petaluma Community Center, 320 N. McDowell Blvd., Petaluma, CA.

A NOTE FROM THE CHAIR

As we close out 2007, I'd like to express appreciation to you all for the level of participation this year by the groups of Sonoma County. Our Registrar has reported consistently this year that more than 40% of the meetings in the county are being represented at Intergroup meetings, and since most of us attend several



meetings a week, it is likely that most of us have had an opportunity to participate through our representatives in services that Sonoma County Intergroup Fellowship provides—Teleservice, the Bookstore, our Seminars, our activities.

Financial support this year has been very strong, and we are on track to end the year with more than enough money to provide for the future by increasing our prudent financial reserve with funds left over to support and improve our services.

Group participation has been lively and thoughtful, because of Intergroup Representatives who consistently attend our meetings, report to their groups, and report back to the fourth-Monday meeting with their group conscience.

SCIF Officers — Elected in January

Chairperson: Presides over monthly Intergroup and Steering Committee meetings. Maintains direct communication regularly with other Intergroup officers and committee chairpersons. Serves on ICSC. Must have general knowledge of A.A. Service Manual, Robert's Rules of Order, and SCIF business procedures (for conducting Intergroup Business Meeting). Length of sobriety: 4 years. Average monthly time commitment: 8 - 15 hours.

SCIF Vice Chair: The Vice Chair's Job is to support the Chairperson in the performance of his or her duties, and to fill in for the Chairperson should he or she be absent or unable to perform that office. The Vice Chair should be informed on these matters:

- 1) Intergroup history and responsibilities
- 2) Current and pending business
- 3) Chair's Rules that is Parliamentary procedure as informed by AA's Twelve Traditions.

In addition the Vice Chair has customarily run the new Rep orientation before the regular business meeting, gives the summation at the end of the meeting, and may be asked to liaise with other committees, or to fill in for absent officers/ committee chairs.

Length of sobriety: 4 years. Average monthly time commitment: 8 - 12 hours a month.

Treasurer: Pays SCIF-related bills. Collects and records contributions from groups and prepares monthly financial statements. Reports to Steering Committee, ICSC, and General Meeting. Submits information for inclusion in Newsletter. Accounting & computer background helpful. Receives all monies collected at Alkathons & Activities. Serves on ICSC. Length of sobriety: 4 years. Average monthly time commitment: 30+ hours.

Recording Secretary: Attends regular SCIF meetings and takes minutes. Delivers correct copy of minutes to Newsletter Editor. Attends Steering Committee meetings and records minutes. Length of sobriety: 3 years. Average monthly time commitment: 6 - 8 hours.

Registrar: Maintains a list of groups and meetings available within the county. Keeps track on a monthly basis of which groups have representatives and how often reps attend meetings. Works with Outreach Committee to contact those groups that are not active in SCIF meetings. Average monthly time commitment: 4 - 6 hours.

Committee Chairs — Elected in February

Seminars Coordinator: Determines what workshops the Fellowship is interested in. Arranges for speakers and/or panels; contacts participants; sets up time and room for meetings; gets information into Newsletter; encourages participation; attends monthly SCIF and Steering Committee meetings. Average monthly time commitment: 6 - 10 hours.

Teleservice Chairperson: Oversees day-to-day operations of Teleservice. Conducts monthly Teleservice business meetings. Average monthly time commitment: 8 - 10 hours.

Newsletter Editor/Webmaster: Collects articles, reports, and meeting changes for monthly Newsletter. Produces copy in a format suitable for professional printing, and delivers the copy to the printer. Maintains list of current subscribers. Prints mailing labels. Sends PDF version to email subscribers. Requires familiarity with image and page formatting software, or interest in and ability to learn such software. Familiarity with Microsoft Office is necessary, particularly Word and Excel, as is a working knowledge of the English language. Maintains the www.sonomacountyaa.org website. Requires a basic understanding of webpage construction, or the ability to finagle somebody else to do it for you. Familiarity with FTP, HTML, CSS, JavaScript, and/or Dreamweaver is helpful. Attends SCIF and Steering Committee meetings. Average monthly time commitment: 16 - 26 hours.

Activities Coordinator: Coordinates dances, Summer picnics, and other activities and functions within Intergroup. Basically, puts the functions together. Must be able to delegate responsibility. Complete guidelines have been formulated for this position. Length of sobriety: 2 years. Average monthly time commitment: 20+ hours.

Outreach Chair: Checks attendance for registered groups. Checks with groups to encourage them to send reps to Intergroup. The main emphasis of this committee is to encourage groups to participate in the AA community and Intergroup, so finding volunteers to attend meetings is necessary. Average monthly time commitment: 6 – 12 hours.
