SCIF OFFICER JOB DESCRIPTIONS - ELECTIONS ON JANUARY 22, 2018

Term length for all jobs is one year. Two consecutive terms O.K. All Committee Chairs are required to attend SCIF Steering Committee and General Meetings

CHAIRPERSON: Presides over monthly General and Steering Committee meetings. Maintains direct communication regularly with other officers and committee chairs. Serves on ICSC. Must have/gain general knowledge of A.A. Service Manual, Robert's Rules of Order, Chair's Rules, SCIF business procedures (for conducting Intergroup Business Meeting), and Intergroup history and responsibilities. Sound business or professional background.

Length of sobriety = 4 years. Average monthly time commitment: 12-15 hours.

VICE-CHAIRPERSON: Supports Chairperson in their duties; and fills in for Chairperson should he or she be absent or unable to perform that office (ex. running the monthly General and Steering Committee meetings). Runs the new Rep Orientation before the General meeting, provides the new reps with orientation packets, gives the "what to take back to your meeting" summation at the end of the General meeting, and may be asked to liaise with committee chairs and fill in for absent officers/committee chairs. The Vice Chair should have knowledge of: 1) Intergroup history and responsibilities; 2) current and pending business; 3) Chair's Rules – Parliamentary procedure as informed by A.A.'s Twelve Traditions.

Length of sobriety = 4 years. Average monthly time commitment: 8-12 hours.

TREASURER: Works with Assistant Bookstore Manager and Bookkeeper in overseeing monthly financial statements. Receives and records all monies collected at Alkathons and SCIF activities. Serve on ICSC committee. Sits in on initial planning meetings for all expense-related committees to assist with budgeting questions. Accounting/bookkeeping background helpful.

Length of sobriety = 4 years. Average monthly time commitment: 15+ hours.

RECORDING SECRETARY: Takes minutes at SCIF General and Steering Committee meetings. Emails drafts to steering committee for approval. Delivers final copy of general meeting minutes to Newsletter Editor and approved copies of both minutes to bookstore manager for archives.

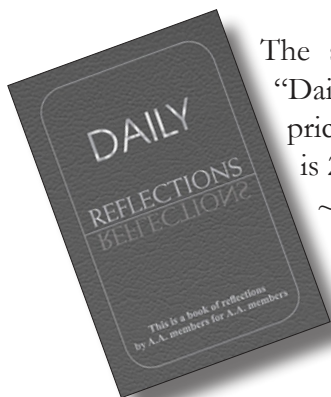
Length of sobriety = 3 years. Average monthly commitment: 6-8 hours.

REGISTRAR: Attends the monthly Steering Committee and General Meeting, provides report of previous month's attendance statistics, provides sign in sheets for General Meeting, updates Excel spreadsheet and generates report for presentation, sends Secretary New Rep sign in sheet, emails monthly report to steering committee, works with Outreach Chair to identify unrepresented meetings and improve reporting accuracy.

Length of sobriety = 3 years. Average monthly commitment: 3-5 hours.

ELECTIONS: Election of Liaison for Spanish central office: No one available. Will move election to December.

OFFICERS REPORTS:

Chair: (Barry D) The election of new officers will be in January. Look to the next newsletter for job descriptions.

Vice Chair: (James C) If you are a new rep., please come to our next orientation.

Secretary: (Patrick B) October 2017 SCIF General Meeting minutes were passed.

Treasurer: (Carolyn A) Group contributions for November were \$5,345; \$1 from bank for a total of \$5,346 which was \$3,352 more than November of last year and after expenses we had a net gain of \$2,033. Bookstore income was \$5,688 and after expenses we had a net loss of \$476. The Thanksgiving Alkathon income was \$1,530 and after expenses we had a net loss of \$295. Overall, we had a net gain of \$1,262 and year to date we have a net gain \$7,135.

Registrar: (Linda W) As of today's date, there are 241 groups in Sonoma County offering 355 meetings each week. There are 159 meeting representatives on record, for 66% participation. There were 60 representatives attending the November 2017 General Meeting, for 37% participation. There was 1 new rep attending the November 2017 new rep orientation.

BOOKSTORE REPORT: (Glenn C) The bookstore will be closed on December 25 to celebrate Christmas. The sale book for December is "Came to Believe"; regularly priced at \$6.77 – sale price is \$5.42 plus tax. The bookstore has a wide variety of items that make great holiday gifts for your sponsor, sponsee or any of your recovery friends. We also sell gift certificates for those who can't decide. Come on down and check us out!

ICSC: (Diana W) We are working with on a plan to shift some of the Treasurer's current duties to the Assistant Bookstore Manager. The changes will cause an increase to the number of hours monthly for the Assistant Bookstore Manager and a change to the job description while reducing the number of hours monthly for the SCIF Treasurer job description. The goal is to make the division of duties logical, more balanced and the Treasurer's job easier to fill. Due to an extreme family medical emergency out of state, our ICSC Vice Chair, Ward, is unable to fulfill his commitment. We are looking for two candidates to fill a position on the ICSC committee. We will be having an election in January.

Activities: (Debbie J) There will be a committee meeting this Thursday to discuss the New Years dance (November 30th, 5:15pm at the bookstore.)

Alkathons: (Jared T, Amber H) Attendance was down 50% at this year's Thanksgiving Alkathon. Thank you to everyone that participated this year. Next Wednesday will be our next planning meeting.

Newsletter/Communication: (Donna L) Cloverdale fellowship lost their main meeting location; new meeting locations are in the newsletter. Deadline for January issue is December 15th.

Outreach: (Judy H) Not present.

Seminars: (Dan F) Our next seminar is in January. My commitment will be up in February, and this is amazing commitment to have.

Teleservice: (Gus C) No open shifts.

ICSC NOMINATING COMMITTEE: (Cindi W) We are looking for a person to take over Vice Chair position within ICSC. We need two candidates to hold an election. This position requires 5yrs sobriety, knowledge of financial computer experience.

PI/CPC

This December, Public Information and Cooperation with the Professional Community (PI/CPC) held an inventory for our committee. We discussed two questions: 1. Is our group attracting alcoholics from different backgrounds? Are we seeing a good cross-section of our community, including those with special needs? 2. Are we fulfilling our primary purpose? We came away from the process with some pride for our accomplishments over the past year and an inspired determination to be as diverse and inclusive as possible. This year our outreach included veterans groups and new educational communities.

We are a two-purpose committee. We provide information to the public on what A.A. is and is not and work with the professional community. This service includes presentations to Drunk Driver Prevention classes and to high schools. We are always on the lookout for young members of A.A. to speak with high school classes. One of our speakers tells them about A.A. and how to find a meeting. The other speaker tells their story. We will make this type of presentation to any group that requests us, including businesses that may be concerned about recovery for the alcoholic employee. We also put our schedules and pamphlets in places where the public may see and need them, like police stations and libraries. As people are released from the Sonoma County jail they will find our schedules next to where they receive their belongings. We cooperate with professionals in the community such as the judicial system, and medical and educational communities to explain our program and invite them to work with us.

The work we do is front line service. It is exciting and fun. You may be the person that someone questioning their drinking can identify with. If you are interested in becoming a speaker or a member of our committee please join us! We meet at the employee underground lounge next to the underground parking at Santa Rosa City Hall (1st and D) on the 2nd Wednesday of the month. Our speaker training is at 7:00 pm and our service meeting is from 7:30 until 8:30. There is a 2 year sobriety requirement with the exception of Young Speakers for which 1 year is required.
