# Founder's Day was a Success!

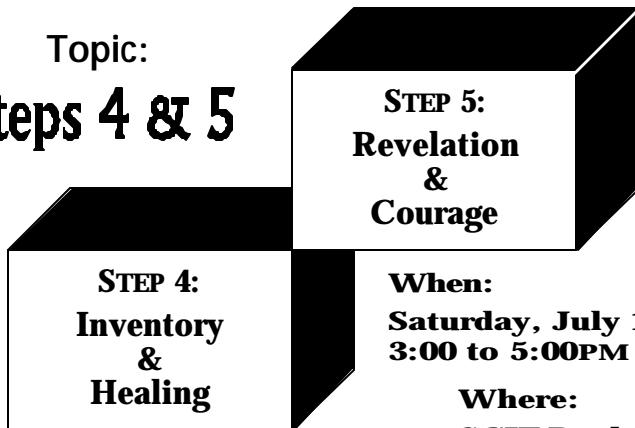

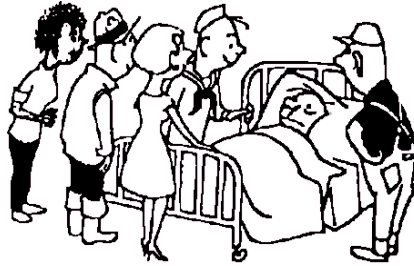
# HOSPITALS & INSTITUTIONS

"Then comes the World War. By now I've met Lois, we're married. I start for the front—I'm pretty much elated again, but after the war I ran up against the same problem that veterans do when they come home now—back in America I'm a nobody again. There aren't any jobs. I become rather rebellious against the powers that be. I become very radical in my opinions. I study law nights, again the old power to show somebody. Finally I wound up in Wall Street. I made a lot of money — I thought it was my brains. It wasn't; it was just dumb luck, which came to me in the boom of 1929.

Meanwhile, drinking, drinking, drinking, more drinking. My wife Lois recognized that it was a problem. I said it was a good man's fault. Each time I got drunk, I thought the next time I would control it better. Why did I drink in the era of success? You know why I drank. I drank because I could dream dreams of still greater accomplishments. I could dream dreams of power. And again the crash came, and it was all swept away. Well, my pride was so great that I looked with scorn upon those who committed suicide because they had lost their money. I figured, well, next time I'll do better. Ill come back. But I didn't come back, and you alcoholics in the prisons, you know why I didn't come back."

Service Board will be putting the Fourth Edition of the Big Book on the AAWS website; the proposal to update the illustrations and language of the cartoon pamphlet "What Happened to Joe?" was unanimously approved; the pamphlet "It Happened to Alice" will be redone after further draft ideas are reviewed in 2004.

Those motions are as follows:

- 1) That District 07, Alameda North, add a new sub-district, Linguistic Sub-District 07-006, composed of the Spanish speaking groups of Sub-District 16-002 that wish to join 07-006;
- 2) That the District ask the Area to get the following motion on the Conference Agenda Topics: Form an ad hoc committee to research the problem and possible solutions to get the Agenda Topics background material translated into Spanish as to allow all Spanish speaking members the same time as the English speaking members to participate in the conference process;
- 3) That CNCA request the General Service Conference and Trustee's Literature Committees to consider a proposal to allow for a broader understanding of God by modifying the wording of Steps Three, Seven and Eleven, and Tradition Two to read as follows:

**Step 3:** *Made a decision to turn our will and our lives over to the care of God of our understanding.*

**Step 7:** *Humbly asked God to remove our shortcomings.*

**Step 11:** *Sought through prayer and meditation to improve our conscious contact with God of our understanding, praying only for knowledge of God's will for us and the power to carry that out.*

**Tradition 2:** *For our group purpose there is but one ultimate authority - a loving God as expressed in our group conscience. Our leaders are but trusted servants, they do not govern.*

If you want to participate, please ask your GSR to set up a sharing session so that your group can discuss the motions. Remember that your General Service Representative may be asked to vote on these motions at the Assembly.

Once again, thank you for letting me be in service. Our next monthly business meeting will be held on Monday July 7<sup>th</sup> 2003 at Faith Lutheran church on Newanga Blvd. in Santa Rosa: New GSR Orientation is 7PM, Business meeting is 7:30. See you then!

that sobriety can come with a price-tag, if one cares to follow the insights of a special group or personality. These so-called "insights" guarantee success and advocate such un-traditional requirements as *paid* sponsorship, limited or non-existent group conscience polls, and so on. I have heard that people attending these meetings, old-timers and newer members, have spoken out against such notions. Taking advantage of newcomers, some of whom are literally grasping at straws (as many of us were when we were new), is *never* correct.

I have also heard that many sober AA's have simply walked out of these meetings, declaring later (perhaps) that it wasn't AA, no sense in staying. I prefer the former stance, because I believe that carrying the message to other alcoholics enables me to speak up. I come to a meeting because I am supposed to be there, I need to be there, and recovery is the point. No one can convince me that my recovery is being served at a meeting where obvious misrepresentations of AA are being accepted in silence by those who have been around for awhile. **I need to speak up for my own recovery.**

# THE MIRACLES OF ALCOHOLICS ANONYMOUS

On the 25th of May I was returning from "Gathering of Eagles" in Dallas, Texas. I was at the Airport Terminal Building. It was unbelievable that there were that many people waiting to check in and get a boarding pass. I stood in line for almost one hour. There were no seats available but finally a man got up to leave and I asked him if he was coming back and he assured me that he was leaving. I sat down and the man next to me asked me where I was going and I told him Sonoma, California. In a little while he asked if I was visiting Dallas and I told him no, that I was speaking at a Conference. He was silent for a little while and finally asked me what type of a Conference it was and I told him it was about alcoholism. Subsequently, he asked me if I was in AA. I said I was and he then told me he went to AA meetings for about one year but had not been to one for six years. I did not try to sell him on going back to meetings but he asked me how long I had been a member. I



told him it will be fifty-five years on 5 July. He became very interested and wanted to know where I went to meetings. I told him I went in Sonoma and surrounding cities, but got sober in Valley Stream, Long Island while in the Air Force. I told him however that my most important station was Lackland Air Force Base in Texas. He said "When were you there". I said from 1953 until I retired in 1961. He said, "I was there at that time". I asked him what Squadron he was in and he replied, "3700th Medical Squadron". I almost fainted because that was my Squadron also. That was 57 years ago and we did not recognize each other but I gave him my business card and he promised to contact me. Although it is a short time since seeing him, he promised to write me and his last words were, "I think I will go to a meeting when I come back". The Miracles of this program are still in place.
