

OFFICER REPORTS:

CHAIR: Diane W. stated there is no smoking on church's campus.

VICÉ CHAIR: Tim P. gave an overview of what he covers at the new rep meetings before the business meeting. TREASURER: Larry O. stated group contributions for April were \$4151. The Bookstore made a profit of \$158. Expenses were normal. Our year-to-date net total is \$3745. Teleservice expenses were less because we were delayed in getting the Press-Democrat bill of \$249. Their expense is normally \$888. Pat H. filed an extension for preparing our non-profit tax returns for 2006 due 05/15/07. Liability in-

surance for 2007-2008 fiscal year is \$1966. Last year's premium was \$2167. He reminded us that the financial summary is posted in the hallway at the Bookstore.

REGISTRAR: Susy E. stated that in April there were 349 meetings, and 120 were represented at the Business meeting for 34% representation.

BOOKSTORE: Gloria P. was absent due to illness. Report was given by Larry O. who stated the Bookstore made \$158 in April. There are two openings of every other Friday from 2-6 p.m. and every other Wednesday from 10-2 p.m. Gloria requested a CD player to test the CDs being sold at the Bookstore. She was authorized to purchase one at a cost of up to \$50.

COMMITTEE REPORTS:

ACTIVITIES: Laurie E. stated on May 7 they had a Steering Committee meeting for the dance and picnic. 20 people attended. Team leaders for both functions were selected. October 27th is the Halloween Dance. We have the Vet's hall for New Years Eve.

ALKATHONS: Dale E. was absent due to illness. It was noted that the Santa Rosa Alano Club is being considered for the Alkathons. The waiver to allow 24-hour open status has been received so they are one step closer to being able to use the Alano Club.

ICSC: Francis B. reported that the purchase of a CD player for the Bookstore has been approved. The cost is to be below \$50. Also approved is a Dutch door at a cost of \$450. Bookstore profit for April was \$158.

NEWSLETTER: Dave H. had no news to report. He apologized for the Birthday mistakes.

OUTREACH: Barbara F-K. was absent.

SEMINARS: Donna L. stated the May 19th seminar on relationships was a big success and all the chairs were full 20 minutes before the seminar began. She discussed the July 14 seminar on Freedom Through Acceptance.

will be brought to meetings by General Service Representatives. The packet is an easy introduction to the program of A.A. for your clergyperson.



Notes From the Chair



THE "HANDS" OF A.A.

On the one hand... on the other hand... That was the theme of some interesting discussions at the June Steering Committee meeting. The Committee meets on the

second Monday of the month (see Calendar), and while SCIF officers and committee chairs are the voting members, it is an open meeting that any AA member may attend. The committee hears reports from committees and officers and decides on the agenda for the General Meeting on the fourth Monday.

Our Outreach chair, Barbara F-K., has been told by some groups that they don't participate in Intergroup because "all they talk about is money." It seems that on the one hand, some AA's hate any discussion about how we use our funds; on the other hand, some are deeply suspicious that money is being misspent if we don't tell them about it.

We had a lively and earnest discussion about how much to charge for hamburgers and hot dogs at the July 21 picnic. On the one hand, Laurie E. and her hardworking committee organize events they think you will want to attend, keeping admission fees and food charges low so that more folks can come. On the other hand, SCIF-sponsored Activities Committee events are supposed to be self-supporting, so that basket money isn't used to subsidize them.

The plan is that some events make a little profit, some lose a little money. If it evens out at the end of the year, we've met our responsibility to the groups. But we have to talk about the money to make sure that happens.

Since last Fall, we have been publishing the SCIF financial summary only every three months, after the quarterly inventory. The idea was that without a monthly inventory, we couldn't have a monthly financial report. It turns out that we do have the reports, but only the ICSC sees them. Bookstore Expense, one of the 16 numbers reported each month, is only an estimate in a non-inventory month, since Cost of Goods Sold is a component of that number. Without an inventory, we don't have that cost. So we estimate it.

We have had pretty good estimates, and each quarter we check it with an actual number after the inventory. Since we have the report, we have decided to go back to monthly reports, starting in July (we'll have our last "quarterly" report after the June inventory).

This decision followed another "hands" discussion – on the one hand, publishing a report with an estimate may confuse or alarm members and generate discussion or controversy. On the other hand, since we have the information, we should publish it, in the interest of transparency and accountability.

These would seem to be discussions about money. On the other hand, aren't they really about Tradition 9 – being directly responsible to those we serve?

It's harder to be responsible to groups who don't

Reflections on Getting Sober from a Bar-Drinking Woman

It just didn't seem possible to stay out of the bars. After all, I had spent the past fifteen years imbibing with my good friends (consisting of whomever was on the bar stool on each side of me). What was I to do with myself? And how was I to support myself? I had been getting projects from other attorneys I met in the bars who couldn't get their work done. I just couldn't leave those bars alone. I would go in and order orange juice, very bad orange juice as I remember. I figured I was getting healthy. Sometimes when the conversations around me would get too unintelligible I would go to the payphone (my sobriety predates cell phones) and call my sponsor, just to check in. I calculated that the phone call would keep me from doing bad things, like ordering a drink so I could understand what was being said. My sponsor told me later that I had given her great practice in "turning it over."

After a meeting one day I told some guy that I was spending time in the bar after leaving my office while waiting for my boyfriend to pick me up after work. I think I wanted his approval. My fellow alcoholic, who must have been very new, me me every afternoon for a week in that bar to help me with my effort to stay sober. He asked his



sponsor's advice because his fiancée was starting to get upset and hw was feeling uncomfortable. Thank God, his sponsor knew of the Alano Club.

I sat in the Alano Club for the next three months until closing time. I felt safe there and I could understand the conversations, or at least most of them. I spent a lot of time with Carl, the dumpster driver, at the hospitality table (where you sat if you wanted to talk to someone). The Alano Club was where I had my first memorable change in attitude. The secretary of the Sunday brunch meeting had asked Carl to be the speaker. I can remember wondering what in the world that secretary was thinking; what did wet-brain Carl have to tell anyone! Halfway through his share a light went on for me, Carl knew how to attain six years sobriety, I didn't.


When I got my ninety days and was eligible, I proudly joined the Alano Club. I know belonged! It had replaced the Bonanza as my home away from home. I'm happy that a new Santa Rosa Alano Club now exists, particularly for bar-drinking women like me.
