### **FACTS REGARDING CREDIT / DEBIT CARD MACHINE**

For the past few months members of the ICSC have been receiving questions from members of Sonoma County Interoup fellowship regarding accepting credit / debit cards at the bookstore. To clarify a few things the ICSC committee thought it would be a good idea to list some facts. The ICSC has been researching accepting credit/debit cards for a while and have received bids from 3 different banks. If the credit card / debit card motion were to pass the ICSC would most likely chose the Exchange Bank to handle the credit/debit card process. The information below has come from a representative of First Data who processes Exchange Banks credit/debit card transactions.

SCIF can expect to pay between 2% to 2 ¾ % on average for every dollar charged on credit/debit card. For example if we except \$3,000 in credit/debit card sales in a month the cost to SCIF Bookstore would be \$60 - \$82.50 for the month, this includes all monthly and quarterly fees. First Data is going to give SCIF the hardware that is needed to process credit/debit cards for free. Exchange Bank will waive the \$50 start –up fee. Exchange Bank will also waive the \$500 early termination fee if SCIF decides to terminate our two year contract with exchange bank. Exchange Bank will do everything in their power to minimize SCIF's expense and the goal is to keep SCIF as close to 2% or less of total credit/debit card sales as possible.

The ICSC committee also realizes some members of Sonoma County AA may be concerned about the safety of their credit card information. This is what the representative from First Data had to say: You can also rest assured in the security of your customer's credit card information because you will be using our Trans Armor technology. Trans Armor is exclusive to First Data and is packet technology. When a customer's credit card information is captured it is assigned a key and the key information is transmitted. Should that information be intercepted it is useless to the perpetrator because they do not have the key! Also Exchange Bank never sells its customers information and First Data does not gather or disseminate purchase information.

PI-Public Information – CPC-Cooperation with the Professional Community

"Isn't A.A. a brainwashing cult?"

"I need alcohol and drug counseling, I'll call A.A."

"I'll get A.A. to back me up in court for my arrest."

"I'll ask A.A. to recommend an alcohol program."

These are needs and expectations persons in a crisis with alcohol problems frequently have when contacting A.A. Unfortunately for them they are perplexed to discover that A.A. does not participate in social services, rather than provide an atmosphere of recovery for the person who has a desire to stop drinking. What A.A. does and what A.A. does NOT do is what Public Information attempts to convey to those who would benefit with a heightened awareness of our fellowship.

A relatively frequent "public" audience that P.I. visits is the DUI program held by the County of Sonoma. These people would rather be anywhere else doing anything else than listening to an A.A. presentation. This is one reason why attending a P.I. training class is mandatory, to prepare the speakers. Other service providers request our presentations as well, after all alcoholism is an equal opportunity illness that touches lives everywhere: Elders, mentally ill, homeless, adolescents, professionals, etc.

It is important that the listener of the presentation has an understanding of the presence and availability of A.A. After all, if A.A. is not for them, perhaps they know someone who could and would benefit from our fellowship.




