Come celebrate AA's 68th Birthday!

YOU NEVER KNOW WHEN...

This Twelfth Step story began about 4 years ago when I gave my card to a newcomer with my phone number on it. I was new myself and had learned early on to extend my hand and make newcomers feel welcome at meetings. I certainly remember being a newcomer and seeing the friendly faces of the women who put their arms around me, saying "I'm glad you are here". Those were powerful words to me. I watched my sponsor and the other women extending their hands, giving out phone numbers and saying, "Call me **before** you drink, not after".

The following experience showed me **YOU NEVER KNOW WHEN** a 12 Step call will

come, or in what form. Mine came in a 2AM phone call. "Ringgg"... Ringgg"... my husband reluctantly answered the phone and he was asked for someone by the name of Jackie. "No one here by that name", he said. The phone rang again and this time he handed the phone to me and saying, "I think this call is meant for you".

A lady on the other end identified herself as a bartender and asked if I knew a person by the name of ____? I thought for only a second or two. In fact I was working with a gal by that name in the fellowship who was having a very difficult time maintaining her sobriety. My thoughts were, "Oh No! Not her!"

What is Teleservice?

Sonoma County Teleservice is a group of alcoholics who answer the local A. A. Hotline from the convenience of their homes. This telephone service operates 24- hours a day, seven days a week. Calls to the hotline range from people requesting meeting information, to people wanting to stop drinking, people wanting information about A.A., or people afraid they will drink. Hotline volunteers are given training and Operations Guidelines to assist them in handling calls to the Hotline. Suggested requirements include 6 months or more of continuous sobriety, a sponsor, and a working knowledge of the 12 steps. Alcoholics need help from other alcoholics. Please consider this as an option for service that will enhance your sobriety and help other people who need direct contact with an alcoholic.

Old Business: Work on the bookkeeping continues, with Pat, John S, and the new

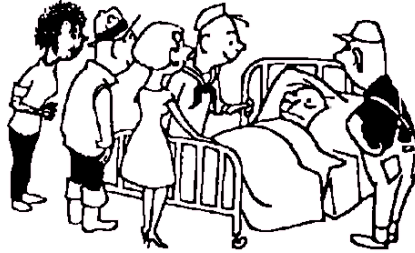

"Everything or nothing—all life was evaluated on the basis of winning or losing. So you see, actually I was a person who never really joined the world about me. I couldn't belong anywhere; I either had to be on top of society or underneath it. I guess you fellows there in the "jug" by now know exactly what I mean. Because I feel that in all probability most of you have felt that way too. Either you were in a struggle to get on top of society or you were underneath society. Now that is the way that some of us have formed prisons. Prison walls constructed of pride, prison walls constructed of anger, prison walls just as strong as any that have contained you. It is a wall that we have put around ourselves that really kept us from functioning as happy citizens, much more than any wall that society could put around you and call it a prison. Now folks, isn't that so?" [Part 9 of Bill W.'s chair at San Quentin in the early years of H&I, reprinted from a 1951 *Grapevine*].

The bartender told me what she knew of the situation. While cleaning up after closing she found a lady who appeared to be drunk curled up under the table. While searching through her purse looking for a family member to call, she found my card with my name and phone number on it saying, "With God all things are possible". She thought that I might be in the AA program and said, "I think I have one of yours and could you help this lady"?

As I hopped out of bed. I explained to my husband that I was going to the bar to make sure that she would be OK. My concerned husband told me to be careful. I knew the location of this bar. It was in a fairly safe neighborhood so I wasn't worried about where I was going. I don't think I would be so eager to go out in the middle of the night by myself if it had been necessary to look at a street map for directions. As I was driving to the place I realized how empty the streets were at 2:15 in the morning and I couldn't believe this was happening to me. But, I had to make sure that this lady would be OK. Besides, my Higher Power would be with me. He was already working through me when I received the phone call.

I arrived at the bar along with the police and the ambulance drivers. Now inside, I had forgotten how bars smell, and it was not a nice thing. Thank God I don't go to those places any more. Inside the smoky bar room there were many questions being asked about the lady. I began to think "this might not be the person that I thought it was". So, I leaned over her, and swept her shoulder length hair away from her face. I realized that she was not who I thought it was. I was relieved because it wasn't my friend. However to my surprise, the lady lying before me was the newcomer I had given my card to years ago. Over the years we have seen each other at meetings and she always made a point to tell me "I still carry your card in my wallet". We would hug and I would wish her well.

With the police and ambulance on the scene I felt it was time to leave. I went back to my car and locked the doors and said a prayer. I thanked God that it wasn't the lady I thought it was. I was grateful for my own sobriety and that I answered the phone. I made some calls the next day to follow up on her condition but I was unsuccessful. Some how I knew that our paths would cross again one day.

Today I know that with the help of my sponsor and the Twelve Steps and the fellowship, "With God all things are possible". If you extend your hand to a newcomer or give out your phone number then you are doing some

PUBLIC INFORMATION REPORT

One of the things that attracted me to the PI/CPC committee was the opportunity to talk about AA instead of simply sharing my experience, strength and hope. Indeed, when people think about the Committee, of times they think about speaking at schools and drinking driver programs. And, in fact, we on the committee do a lot of those presentations. So far this year, we have spoken at over 50 drinking driver classes.

One of the questions frequently asked at presentations is "What about this God stuff? When I attended my first AA meeting for me, I heard people talking about God. I left that meeting knowing that this AA stuff that worked so well for so many people would not work for me because I wanted nothing to do with anything that had anything to do with God.

Three years later, when I came back to AA, I was a little more open-minded. I still didn't want anything to do with the God stuff but I could accept the concept of a power greater than myself as long as it wasn't called

God. So I used the AA group as my higher power for a while. Over time, I let go of my old ideas of God and found a loving, forgiving God in the rooms of AA.

When doing PI/CPC presentations, I explain the principles of AA's suggested program of recovery. I explain that they work in cultures throughout the world, in all religions, and with individuals who claim no religion. And in talking about the spiritual principals, I have found that my concepts have changed. No longer is my concept of a higher power limited by organized religion. My concept of a

loving God has grown to encompass all religions. As I heard one speaker say recently, "The universal spirit of love".

If talking about AA is something that might interest you, join us on the 2nd Wednesday of each month in the Santa Rosa Employees Lounge underneath City Hall. Speaker training is at 7:00 pm and the business meeting is at 7:30. And, by the way, we do a lot more than just public speaking. Come check us out.

form of Twelve Step work. I learned early on from my sponsor that I had something to offer even it was just being sober for that twenty-four hours, and for that I am grateful.

PS... Remember that I said earlier in my story that I believed our paths would cross again one day. They did. Four months after the bar room incident I walked into a Step Study meeting. I immediately recognized her. She looked bewildered and bruised and was shaking from a drinking episode the night before. I felt my heart racing as I realized that this was another one of God's miracles unfolding right before my very eyes. As we made contact a weak smile came from her face. We embraced and again her first words were, "I still carry your card in my wallet". I listened to her sad story of the night before. I then revealed to her my experience of getting the late night phone call months ago and driving to the bar to help her. She had little memory about that evening and was surprised to hear that I would venture out in the middle of the night to make sure she was OK. My prayers are with her and to every newcomer that walks into the rooms of Alcoholics Anonymous. If you give this program a chance it may save your life and it can give you a new life, "One Day At A Time".
