Chair: (Steve B.) Welcome everyone. Going to begin meeting with vote for two positions open on the ICSC committee. Explained voting eligibility and what the ICSC committee does.

Election of ICSC Committee Members:

Ernest W., member of the ICSC nominating committee, said Mary O'D. stepped aside due to health, so a six-month position was open. There was also the 18-month position open as Steve Z. rotated off committee. Ernest introduced the three nominees for the 18-month position: Pat H., John F. and Jim W. Vote for 18-month position: Jim W. elected to the ICSC.

Ernest introduced nominees for the six-month position: Sean McP., Steve Z. and John F. Vote for six-month position: Sean McP. elected to fill six-month position on ICSC.

Vice Chair: (Trevor H.) Good orientation this evening. New reps. who didn't sign in, please come up after meeting and do so.

Secretary: (Patty G.) March 26, 2012 General Meeting minutes put forth and approved.

Treasurer: (Jimmie B.) Group contributions of \$2,870 were \$337 more than March 2011. Group supported expenses exceeded income by \$560; bookstore income was \$8,418, exceeding expenses by \$828 -- resulting in a \$268 net gain overall.

Registrar: (Carolyn A.) Last month 225 groups offered 364 meetings per week in Sonoma County; there were 75 reps at the February General Meeting for a 33% representation. Carolyn has updated sign-in sheets.

Bookstore report: (Linda M.) All shifts are filled. March bookstore sales were more than \$8,400, about \$1,770 more than March 2011. Credit/debit card sales were \$3,930 of total sales (47%). April sales are typically slow, current April proving true again. First quarter inventory went well, less than a \$50 variance. Thanks to bookstore and inventory volunteers for good, thorough work for Fellowship.

ICSC: (Steve Z.) Still evaluating ways to ensure bookstore is self-supporting and to hire an assistant for Linda M. ICSC had asked for feedback from members on two issues: charging for all pamphlets and including Hazelden books in bookstore. Steve thanked all who responded; the ICSC is not pursuing either of these options right now. Enjoyed ICSC service, thanks to current and former committee members for service.

A.A. and the County Probation Department

To ease overcrowding in our state prisons, the California Legislature recently passed a bill (AB109) authorizing the return of certain non-violent offenders from the state prison system to their counties of origin, thus shifting the overcrowding to the county jails. The counties in turn, have begun releasing more offenders on probation and parole.

Since many offenses relate to the use of alcohol and other drugs, some county probation departments are using A.A. as a resource in addressing the problem. Here in Sonoma County I recently had the opportunity to speak on behalf of A.A. at a Probation Department event called Community Connections Day.

Community Connections Day is sponsored by the Probation Department as a way to inform parolees about the many resources that are available to them. It may be something as simple as how to apply for a library card, and providers are invited to make informational presentations about their services to clients of the county's program. On this day we were the only provider invited.

I made the presentation with another A.A. member. I talked about A.A. and then my partner told her story. At first impression, it was a hard looking group, but as the meeting progressed the reception they gave us was warm and welcoming. Several of them had actually asked the county to bring us in, and their questions and comments showed a strong interest in what we had to say.

After years of speaking to classes of the county's Drinking Driver Program, it was especially gratifying to talk to these people, some of whom are already grateful members of our A.A. Fellowship. At the end of the meeting, at least a dozen members of the group asked us for meeting schedules — a response I have never experienced at the best of our DUI presentations.

You are sure to meet some of these folks during an A.A. meeting soon, and I know you will treat them with the dignity and respect we promised them. After all — this is Alcoholics Anonymous and it's what we do!

I said yes, thinking, "Hey I'll just tell my story, and I'm out!"

My first visit had about four guys at Orenda detox and they looked bored and not interested. So, I told my story and watched the video. After that meeting I knew that Bridging the Gap (BTG) was for me. A man that was 58 years old approached me and asked me about my home group and was excited about it. I told him there was an eclectic mix of people and he would fit in perfectly! Ever since that connection I was hooked! I am so grateful I get to be a part of carrying the message of A.A. Thank you BTG! Volunteers sign up!

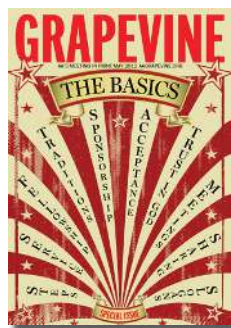

A.A. Grapevine is the international journal of Alcoholics Anonymous. Written, edited, illustrated, and read by A.A. members and others interested in the A.A. program of recovery from alcoholism, the Grapevine is a lifeline linking one alcoholic to another.

Widely known as a “meeting in print,” the A.A. Grapevine communicates the experience, strength and hope of its contributors and reflects a broad geographic spectrum of current A.A. experience with recovery, unity and service. Founded in 1944, the Grapevine does not receive group contributions, but is supported entirely through magazine subscription sales and additional income derived from the sale of related items.

The awareness that every A.A. member has an individual way of working the program permeates the pages of the Grapevine, and throughout its history the magazine has been a forum for the varied and often divergent opinions of A.A.s around the world. Articles are not intended to be statements of A.A. policy, nor does publication of any article imply endorsement by either A.A. or the Grapevine.

As Bill W. expressed it in 1946, “The Grapevine will be the voice of the Alcoholics Anonymous movement. Its editors and staff will be primarily accountable to the A.A. movement as a whole Within the bounds of friendliness and good taste, the Grapevine will enjoy perfect freedom of speech on all matters directly pertaining to Alcoholics Anonymous Like the Alcoholics Anonymous movement it is to mirror, there will be but one central purpose: The Grapevine will try to carry the A.A. message to alcoholics and practice the A.A. principles in all its affairs.”

We wish to convince audiences that our alcoholism is a sickness we no longer fear to discuss before anyone.

“If, however, we venture beyond this limit, we shall surely lose the principle of anonymity forever. If every A.A. felt free to publish his own name, picture and story, we would soon be launched upon a vast orgy of personal publicity.”
