### Officer Reports:

**Chair:** (Patty G.) Welcomed everyone. Reported that all is going well.

**Vice-Chair:** (Tina C.) Welcomed all new representatives. Reminded that it is very important for new representatives to arrive at 7:30 p.m. If you don't have an orientation packet, please see Tina.

**Secretary:** (Mark V. C.) March 25, 2013 General Meeting Minutes put forth and approved.

**Treasurer:** (Jimmie B.) Group contributions for March were \$2,630 which was \$240 less than March 2012. After expenses, we had a net loss of \$1,048. Bookstore income was \$6,712 and after expenses we had a net loss of \$293. Overall, we had a net loss of \$1,341 for the month.

**Registrar:** (Carolyn A.) Last month there were 231 groups offering 375 meetings per week in Sonoma County. At February's general meeting there were 75 representatives equaling 32% representation. She asked reps. to be sure to sign in on the correct day of the week (clearly marked) and if the rep. is an alternate or just picking up the items for another representative to sign up using their name, meeting name and meeting time/city.

**ICSC Election:** Mary B. from the ICSC nominating committee introduced Peter R., 22 years of sobriety, as a candidate for the ICSC member-at-large. Mike C. from the ICSC nominating committee introduced the second candidate, Virginia W. with five years of sobriety. Virginia was elected.

### Committee Reports:

**Bookstore Report:** (Linda M.) Reported that all shifts are filled. Ben C. from Petaluma donated a used wide screen computer monitor, which is much appreciated. Linda reported that sales for the year are down around 5%. Bookstore now open until 6 p.m. Monday -Friday until the fall.

**ICSC:** (Annie T.) Introduced Jim W. as the new chairperson of the ICSC. The committee is looking at the financial workings of the bookstore. Annie encouraged the representatives to thank the groups for supporting Intergroup. Patty G. thanked Annie for her wonderful service, dedication, and wisdom.

**Activities:** (Lorie J.) No report.

**Alkathons:** (Richard H.) Reminded everyone that there are only seven months left until the first Alkathon.

**Communications/Newsletter:** (Barry D.) Reported that May newsletters are available. Same color as April, with new words. Barry focused on the calendar & how it can help a new representative get into service.

Thanked Annie T. for being a voice of reason. Thanked us for letting him be of service.

**Outreach:** (Ben G.) Described Outreach. Encouraged reps. to sign in. He visited two meetings. Ben is still looking for volunteers as some on his list are MIA.

**Seminars:** (Kathy M.) Reminded that Origin of the Twelve Steps will be on May 29th. Announced that the July seminar will be on the 24th and it is Steps Two & Three: Connecting With A Higher Power.

**Teleservice:** (Joe B.) Thanked the reps. for their announcements. Stated that there are 42 active volunteers. Stated that an average of three shifts turns over each month. The calls are forwarded to where the volunteer is. Described an average shift. Encouraged reps to continue to promote it.

### Liaison Reports:

**SOCYPAA:** (Cassidy S.) Reported that there will be a speaker meeting followed by Dodgeball on Saturday, May 11th. Saturday, May 25th will be a speaker meeting and a carnival.

**Spanish Central Office:** (Rosa S.) No report.

**H & I:** (Patrick W.) Reported there were six brown-outs, where the facility is shut down, and three black-outs (A.A. fails to show.)

**General Service:** (Joann L.) Reported that the next upcoming assembly will be May 18, 2013 in Livermore. There are flyers on the back table. If you cannot make that then please join General Service at their annual Delegate's BBQ which will be held on June 3 at 4930 Newanga Ave in Santa Rosa. This BBQ is held instead of the monthly business meeting. BBQ starts at 6 p.m. The Delegate report will start at 7:30 p.m. This year we are privileged to have the event in the church's sanctuary. There is no need for anyone to bring their own chairs and there will be plenty of room. If you bring an FM radio with headphones, there will be assisted listening provided by our I & T committee. We both almost said Fourth Tradition at the same time. Each group is autonomous. Each group can make its own decisions based on its own group conscience. But as I reflected on it further, I thought more of the Third Tradition, the only requirement for membership is a desire to stop drinking. We have no dues or fees! No one is asked for any money to be in an A.A. meeting or to be an A.A. member. No one is required to give money to be a member. You are a member when you say you are. The services that are provided by Intergroup, General Service in Sonoma County, California Northern Coastal Area and the General Service Office in New York are provided to all groups equally, whether they contribute or not. But the real beauty is when an A.A. group recognizes the services that are being provided for them, and out of the gratitude of their heart, desires to make sure that these services continue by making a monetary contribution. Services like publishing meeting schedules and newsletters by Intergroup to the books and literature published by A.A. World Services, to having the support of District Committee member at a steering meeting or having a member answer the A.A. hotline phone. The group contributes because they would like to see the meeting kept open for the next alcoholic who needs it. When we as members understand and know what these services are to our A.A. groups, and how they keep us functioning, we just might feel compelled to put in the basket what we used to throw down on the bar. We give because we want to, not because we have to. That is where spiritually and money really do mix.

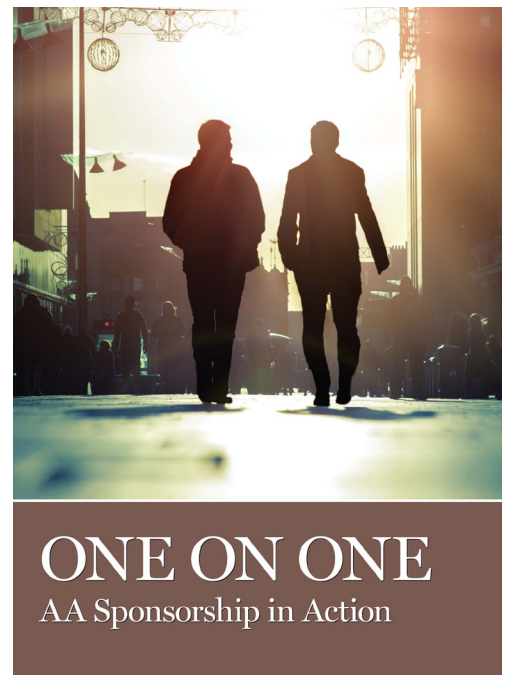
### New A.A. Grapevine Book on Sponsorship

## SONOMA COUNTY ICSC

### Facts About the Intergroup Central Service Committee

The Intergroup Central Service Committee (ICSC) is a management and oversight committee specifically charged with responsibility to set the policy, regulate the affairs, and oversee the operation of the SCIF Central Office/Bookstore. It also advises the Steering Committee on matters affecting SCIF's status as a non-profit corporation, making sure that state and federal government regulations are followed and regulatory filings are completed as required. As such, it fulfills many of the functions cited as responsibilities of "the Board of Directors" in the California Corporations Code.

The ICSC is a rotating body of five members — two officers and three at-large members elected by the group representatives. The composition of the ICSC committee changes several times a year, providing both continuity and fresh eyes.

As a hotline volunteer you are the voice of A.A. You can help alcoholic, as well as non-alcoholic, callers. Calls range from directions to meetings to Twelfth Step work. ### **Talking to Young People About A.A.**

Your new PI/CPC committee continues to take shape and is as always very active. Making presentations at the Sonoma County DDP, delivering literature to various locations, and talking with freshman at high schools are just some of the activities we are involved with. As the current Schools and Juvenile DDP coordinator, I feel the need to talk to you about some of my recent experiences in assisting some of our younger presenters make a presentation at a few of our local schools on behalf of A.A. We have made 22 presentations since March.

To be able to share with these young and open minded students is one of best things that I have done since I have found sobriety. To calmly explain and inform them about A.A., what we do, what to expect, how it works and what we DON'T do is one of the highlights of my sobriety. This information — along with a brief share from a young sober member about their struggles and ultimate surrender and how their life has changed since becoming a member of A.A. — is truly an eye-opening experience. To let these young adults know that at some time in their life, if not already, alcoholism will be affecting them directly or indirectly and that we believe we have a solution; this is the class we all missed.

The best part actually was the Q&A after we did our bit. We sent note paper out to the students so they could ask questions anonymously. The sharpness of these questions really makes you feel proud that to be an A.A. and to talk openly about the illness and recovery process is a gift. It picks you. We talked of our sister programs, and how to get in touch and find meetings.

The PI/CPC committee meets on the second Wednesday of each month at Santa Rosa City Hall's employee lounge located down in the lower parking area. Speaker training begins at 7 p.m. (2 yrs. sobriety requirement), meeting starts at 7:30 p.m. We invite your attendance, but more importantly your participation. We could be doing more if we had more involvement. Thanks for reading.

Luckily for me, there were people in the fellowship who went out of their way to make me feel welcome. If not for them, it would have been easy for me to return to my misery.

Bridging the Gap's mission is "To ease the transition of recovering alcoholics being released from treatment facilities and other places of confinement into the A.A. Community. It involves taking newcomers to an A.A. meeting after their release and introducing them to members of the group."

Another service we provide is to go into facilities and sign up residents for contact by a Bridging The Gap representative upon their release.
