"Then came that little man that we who live in this area saw so much, him with the kind blue eyes and white hair, Doc Silkworth. You'll remember that Doc said to me, "Look Bill, you're preaching at these people too much. You've got the cart before the horse. This 'white flash' experience of yours scares those drunks to death. Why don't you put the fear of God into them first. You're always talking about James and The Varieties of Religious Experiences and how you have to deflate people before they can know God, how they must have humility. So, why don't you use the tool of the medical hopelessness of alcoholism for practically all those involved. Why don't you talk to the drunk about that allergy they've got and that obsession that makes them keep on drinking and guarantees that they will die. Maybe when you punch it into them hard it will deflate them enough so that they will find what you found."

It's funny, because I'm about 3 quarters Irish and



### What is Teleservice?

Sonoma County Teleservice is a group of alcoholics who answer the local A.A. Hotline from the convenience of their homes. This telephone service operates 24- hours a day, seven days a week. Calls to the hotline range from people requesting meeting information, to people wanting to stop drinking, people wanting information about A.A., or people afraid they will drink. Hotline volunteers are given training and Operations Guidelines to assist them in handling calls to the Hotline. Suggested requirements include 6 months or more of continuous sobriety, a sponsor, and a working knowledge of the 12 steps. Please consider this as an option for service that will enhance your sobriety and help other people who need direct contact with an alcoholic. 150. Even though we sell about 200 most of every year, the spots are selling closer and closer to the end of the registration period. We, as the Cache Creek Steering Committee cannot in good conscience ask the rafting company to hold these spots open while we may or may not find enough interested rafters to fill those spots.

We want all to have a good time. At the same time it is just too stressful to not have the last fifty spots up in the air as to whether they will be sold or not. We are financially responsible for the amount of spots that we reserve, whether we sell them or not! That is why we ask for money to be paid beforehand, we are required to give the raft company a deposit for every spot we reserve. Also then we won't have last minute cancellations that leave the rest of us on the hook financially.
