ARE WE HEARING THE MESSAGE?

At my home group last week, a woman was sharing at the other end of the room. I could hear about half of what she was saying. I've been wondering if I should have my hearing checked, so asked my neighbor, "Can you hear her?" She said no. Whew! It wasn't me!

At the New Year's Eve Alkathon, there were American Sign Language interpreters on duty for the 6:00 pm meeting. The interpreters, unfortunately, couldn't hear sharing from the back of the room.

What's the point of sharing at an AA meeting if you don't speak up so that all can hear you? Some meetings make a point of providing sound systems or seating close to the speakers. Most of us can hear most of what is said at meetings. But many AA members have hearing deficits and can't hear what the rest of us can.

There seems to be a stigma attached to being "hard of hearing." Access Sonoma County tried last year to do a survey of our county's AA members who have difficulty hearing in meetings. Few folks 'fessed up to having the problem – even in meetings where members privately admit they can't hear the proceedings. In meetings where seats are saved for the hard of hearing, few folks fill those seats.

The Access Committee is investigating the purchase of Assistive Listening Devices to help with the problem. Such devices are available through the San Francisco/Marin Intergroup, but they are finding that they aren't being used, possibly because of the administrative difficulty of checking them in and out. I'm wondering if there is also just that old stigma at work – members don't want to admit that they can't hear the proceedings. I am reminded that there is "stigma" associated with being alcoholics – that's why we're Anonymous!

Before we invest (as San Francisco has done) precious group Seventh Tradition funds donated to our service committees in pursuit of solutions for hard of hearing members, let's try a less "public" assessment of whether or not they might be used. If you have a problem hearing at AA functions – and IF you are willing to ask for assistance – please email your need or suggestion or story to asc@sonomacountyaa.org.

FINDING LOVE

Before recovery, back when I just thought I was broken, I divided my time between trying to disprove my underlying belief that I was of no worth and did not deserve to live, and abandoning myself to the inevitability of an alcoholic death which would demonstrate I had been right all along. In my quest for a feeling of significance, I placed unreasonable demands on people for time and attention, desperate for someone to place a permanent validation stamp of worth on my forehead. One by one, as people failed to live up to my expectations of what it meant to love, I discarded them, arriving finally alone full of contempt for all, despising relationships.

When I came to AA I thought, here at last was a group of people that would love me unconditionally, and provide a sense of purpose and worth for an otherwise empty life. Well, that certainly did happen, but not right away. At first it seemed like the same old story. People could not provide enough love to fill the great void that comprised the core of by being. They disappointed me, and hurt my feelings. They had other things to do when I needed them, and they had other relationships that were more important to them than me. My sponsor even had the audacity to tell me that it was inappropriate for me to stop by his house without calling. Shouldn't he be there for me at any hour? How dare they?

I'd love to say I didn't drink over it, but I did. When alcohol delivered me back on the stoop ragged and bloody, suddenly the people in AA seemed less important. All that mattered was the "not drinking" part of the program. I got a new sponsor and harassed him (after calling first), less concerned about whether he liked me or not. I went to meetings with a different attitude. If people seemed disapproving, I thought, they can leave, I'm not going to. I began to develop a relationship with a higher power, and, even though HP also failed to grant all my demands, I began to experience a source of constant love such as I'd never known from a human being. Through a moral inventory I saw my flawed nature in a new light, one of acceptance with the opportunity for change. I recognized that this was what "growing up" meant.

After awhile I discovered that I cared about the people I saw in meetings. My heart would leap when I heard of their successes, and shed tears for their losses. I began to think of this as love. I wanted to provide for them in my fledgling way the same genuine concern I'd found, though after a few rough experiences I began to understand the boundaries others had set with me. Today I understand the admonition "to love rather than be loved," as not just another religious regulation, but an observation about the nature of the true path to happiness. Relationships are where it's at. My favorite part of the meeting is the 15 minutes before and after when I get to talk with my family of friends. I still get my feelings hurt, and can still be disappointed, but the imperfections of human beings are now what we have in common; not the final brick in my wall of isolation.

HOSPITAL AND INSTITUTION COMMITTEE

["Within the last three years, the US Department of Justice released a research report indicating as much as 80% of our prisoners should be classified either problem drinkers or alcoholics. There is little evidence or reason to believe that situation will change significantly during the next 50 years:]

"Unless during the next 50 years we are willing to go into our jails and detox centers with greater numbers of the Fellowship involved in this special Twelfth Stepping. Everyone who goes to prison has first been in jail and probably a detox center.

"Unless during the next 50 years we are willing to establish a cooperative relationship with our overworked probation officers who need the kind of support for their alcoholic probationers only an effective AA sponsor can provide. Nearly every person in prison today failed their conditions of probation, and most of those failures were related to alcohol.

"Unless during the next 50 years we are ready to test our collective maturity as we change our attitudes about referrals from treatment centers and the lower courts. There are too many of us who came to the Fellowship under duress of family, employer, regulatory agency, or others to permit the bigoted attitude some of us display toward court and treatment center referrals. The program won't work for them all, we know, but it won't work for any of them if they aren't received with the same loving discipline we were received with." [Part 3 of 1985 address by W.J. Estelle, Jr., then Class A Trustee, Texas]


