

#### **OFFICER REPORTS:**

**Chair:** (Patty G.) Election for activities chair tonight. Working on a picture of finances on how money is spent for activities, etc.

**Vice Chair:** (Holly H.) Those new reps that did not attend the orientation tonight should arrive by 7:30 p.m. next month to attend the orientation. Include phone number and email when signing in.

**Secretary:** (Jennifer R.) The General Meeting minutes of February 24, 2014 were put forth and approved.

**Treasurer:** (Carolyn A.) Group contributions for February were \$3,151, and individual contributions were \$60; which was \$1,445 more than February of 2013. After expenses, we had a net loss of \$339. Bookstore income was \$7,674, and after expenses there was a net gain of \$16. Alkathon expense of \$30 from receipt for garbage disposal. Overall, we had a net loss of \$352. Groups are asked when sending in checks to place their meeting's name on the check.

**Registrar:** (Jim W.) In February there were 233 groups offering 366 meetings per week in Sonoma County; and at February's General Meeting, there were 75 representatives for a 32 percent representation. New reps are encouraged to sign in on the correct day of week (clearly marked) and if the rep is an alternate or just picking up the items for another representative please be sure to sign up using their name, meeting name, and meeting time/city.

**Bookstore:** (Suzanne A.) Inventory at the Bookstore was conducted on March 23, 2014. There was a loss of \$119.32 for the quarter due to 382 pamphlets not accounted for at the cost of \$76.36 and \$42.96 in other products. The 75th Anniversary edition of the Big Book will be available April 2014 for a cost of \$12.00 per copy. The Bookstore has preordered 200 copies. There is a sign-up sheet at the Bookstore for people who would like to reserve a copy. Through the end of March the Bookstore will feature the book "Dr. Bob and the Good Oldtimers" for the sales price of \$11.84 per copy. April's book will be "Living Sober" on sale for \$4.49.

# Carrying the message...

With Gratitude, I like to think of myself as a conduit from the Rehab Center to the very first A.A. meeting. I get to carry the message as a presenter of Bridging the Gap, AKA, Bridging the Gap to Mountain Vista Farm. We match client information cards with a volunteer in his/her community to help get them connected with A.A. in their community." Bridging the Gap is a General Service sub-committee that supports that very important first step for alcoholics who have just been released from a hospital, treatment center or correctional facility. By providing a temporary contact, B.T.G. helps newcomers make the transition to A.A. in his or her own community. We spend an hour showing a video, have a short share, open the door to Q&A's and request that they fill out these little cards with Confidential information. Another important fact is we carry the message that A.A. is a we program. Or as a I once heard, "It's just one beggar showing the other beggar where the bread is." A.A. Bridging the Gap is an organization of alcoholics helping other alcoholics. The only thing we want from this work is the satisfaction of helping another alcoholic, specifically bridging the gap from familiarity to the unknown and in many cases a very unsettling place. Being an alcoholic myself, I know that the people you will meet in your first days out could make all the difference. I am committed to my sobriety and to be of service and for that I am a grateful member of Alcoholics Anonymous.

# **Processing the Steps**

# Step Five

My sponsor wanted me to read her the inventory I wrote out for Step Four. I didn't know what I was getting into. This became painful. As I read I began to cry, with each of the things that I recounted, I felt more deeply the pain. But my sponsor just kept her eyes on me without judgment. I felt her support.

Speaking the words I wrote up in Step Four exposed things I hadn't seen. While they were just thoughts in the writing, just swimming in my head, they became real when I said them to my sponsor. The saying became freeing, liberating. There was a sense of a burden laid down.

After, my sponsor, told me to go home and sit quietly for an hour. The speaking was an emotionally draining, intense experience. But I was relieved.

# Step Five

When I finished my fourth step and was preparing to do the "dreaded fifth step," I knew the fifth was crucial to my sobriety. So in reviewing my fourth to make sure that I didn't miss anything it occurred to me to put myself in the shoes of the people on my resentment list and see myself through their eyes, knowing their likes and dislikes. To see me the way I was then. What I saw shocked me. It struck me to the very core. What I saw was a selfish, self-centered individual. But what struck me the most was that I saw a person devoid of humility. So I knew that step five was important in acquiring that much needed quality.

When driving to a meeting with my sponsor one evening he asked, "are you ready to tell me what you've never told anyone else?" I was like lancing an old wound that had been festering for many years. It all came out. The relief was tremendous. The doorway to freedom had just opened a little wider.

Step five continues to play an important part in my sobriety, when any dark moments from the past come up, they must come out as soon as possible.




# Example of Suggested Group Contributions to A.A. Service Entities:

# Anyone, Anywhere Reaches Out for Help

"Though I know how hurt and sorry you must be after this slip, please do not worry about a temporary loss of your inner peace. As calmly as you can, just renew your effort in the A.A. program, especially those parts of it which have to do with meditation and self-analysis.

"Could I also suggest that you look at excessive guilt for what it is? Nothing but a sort of reverse pride. A decent regret for what has happened is fine. But guilt—no.

"Indeed, the slip could well have been brought about by unreasonable feelings of guilt because of other moral failures, so-called. Surely, you ought to look into this possibility. Even here you should not blame yourself for failure; you can be penalized only for refusing to try for better things." [Bill W., Letter, 1958]
