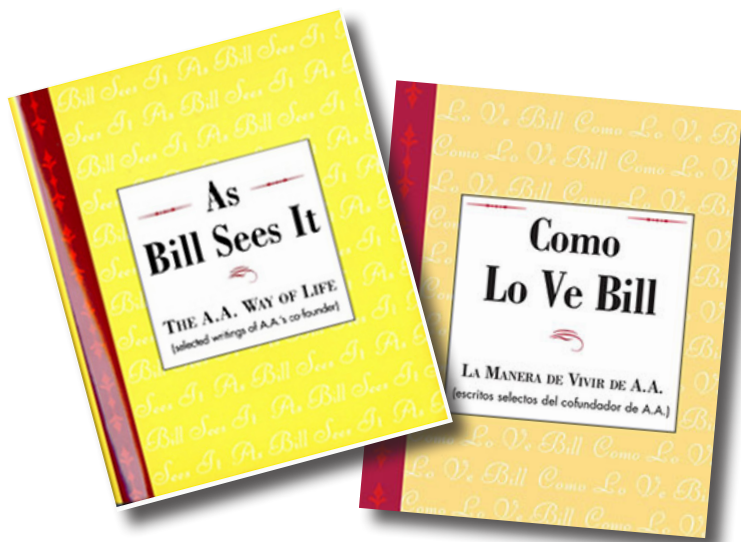

BRIDGING THE GAP

My name is Tom F. I am an alcoholic and the current Chair of the Bridging The Gap (BTG) Committee. I wanted to take some time to tell everyone about a new BTG program, and also to explain how BTG works with people who volunteer for the existing program. BTG gives presentations to eight different facilities in Sonoma County. At these presentations, we offer the people in the facility a contact card to fill out if they would like to be contacted upon their release. The contact person is a volunteer that has filled out the yellow form and is available to meet the newly released person at an A.A. meeting in that person's home area. We try to match the requests with a volunteer who is the same sex, similar age, and lives in or is willing to drive to the client's home area.

The most frequent complaint I hear is "I have been on the volunteer list forever and BTG never calls." When you fill out the volunteer form, you are telling us that you are available. We may not need you right away, but being available is the key. The largest volunteer list is made up of Santa Rosa residents, but we still need more. Areas outside Santa Rosa are really hurting for volunteers, especially younger people. If you are available to meet a new person at a meeting, please contact BTG or see your General Service Rep. at a local meeting. Remember that you will be matched up based on the criteria listed above, so have patience.

The newest BTG program is the Short Term Corrections Correspondence program. This program is for inmates in an institution that have a release date within the upcoming year. The volunteer on the outside (you) would be a letter writer to the inmate while they are confined and also the person who will meet the client at an A.A. meeting when they are released. If you are interested in this service, please contact me. My information is on the back cover of this newsletter. ~ Tom F

PI/CPC

The Sonoma County Public Information and Cooperation with the Professional Community is a subcommittee of General Service directly responsible to those they serve. That would be you, members of Alcoholics Anonymous. We give presentations at DUI classes put on by the county and speak at high schools. Two members of A.A., usually a man and a woman present. One of us explains a little of how A.A. works and what to expect at a meeting, a little of our history and, in a very general way, how the program works. The other person tells their story.

We also make sure libraries, hospitals, police stations, and other public places are stocked with schedules and pamphlets. Part of our mission is to find simple, effective ways of cooperating with the professional community without affiliating. For example, we are exploring the possibility of making a presentation to an SRJC nursing program class. Recently we were asked to put on a demonstration meeting for the Sonoma County Sheriff's department.

Speaking at DUI classes and high schools forces me to avoid jargon. I know that some of the people listening are hearing about us for the first time. It teaches me that I shouldn't expect any specific reaction from the group. I think it might be good insurance too.

If this kind of service appeals to you, please join us. We meet at the employee lounge next the Santa Rosa City Hall underground parking at 1st and D streets. Our regular service committee meeting is on the first Wednesday of the month at 7:30 p.m. We give speaker training at 7:00 pm right before the service meeting. There is a sobriety requirement of two years. ~Philip C.
