#### **PICPC NEWS**

#### Giving Thanks:

This is a good time of year to take stock of my blessings, and to reaffirm the gratitude I feel for the gifts I've been given. Foremost among the blessings I count sobriety - and for that gift I'm most grateful of all.

When I speak on behalf of AA, to classes of the County's Drinking Driver Program, I introduce myself as "a grateful member of Alcoholics Anonymous". A remark like that can be met with a certain amount of skepticism from those unfamiliar with recovery until they hear my story. Then the reason for my gratitude becomes abundantly clear.

At one of the first AA meetings I ever attended, a member of AA was celebrating his 80th birthday. He'd been sober for 40 years, and he was asked if he would like to 'say a few words'. He responded by saying "I'm at this AA meeting because I'm grateful - and I'm grateful because at 80 years of age I have a better life expectancy than I had when I walked through the doors of Alcoholics Anonymous 40 years ago!" His words made a profound impression on me, and today I'm grateful to AA for the same reason.

Alcoholics Anonymous not only saved my life, but it showed me the way to a life worth living! I hope that truth comes across in my presentations. If it does maybe someday someone who hears me will say, "I want a life 'worth living' too!" And if I've done my job they'll know where to find it.

If this kind of service appeals to you, please check it out at one of our PICPC committee meetings. We meet at 7:30 P.M. on the second Wednesday of every month, at Santa Rosa City Hall Employees Lounge. The room is adjacent to the underground parking garage, but please park in the outdoor lot as underground spaces are reserved. We look forward to seeing you.




