BOOKSTORE UPDATE — THE NEW POS COMPUTER SYSTEM

Did you know that when you buy a Big Book for your group at \$8.00, the price includes the sales tax? The argument that appeared in the April newsletter describing this proposed new Point of Sale (POS) system mentioned the challenges of managing our sales tax calculations for the Office Manager and the Treasurer. In May, you unanimously approved the proposal for the new system, in part because of the workload efficiencies we could realize.

The system will go live *sometime* in October at the Bookstore. You may notice that the prices you are used to seeing will be different when the system goes in. Our challenge was to adjust the "retail price" in the computer system so that the sales tax can be calculated separately on the total amount of the purchase. The net effect for you, in many cases, is minimal. For instance, a Big Book, recently sold for \$8.00, will be priced at "\$7.40" – with sales tax added, your final price will be \$7.99.

While we were adjusting prices for the sales tax calculation, we took a hard look at prices overall, which have not been adjusted in some time. We found that at the Bookstore, just like at the grocery store and the gas pump, some of our costs have increased. We also found that in some cases – because we had not looked at our costs years – some items appeared to be priced too high. Because the Bookstore is intended to be "self-supporting," we buy most items at a discount and add a "markup" margin to ensure that we don't lose money on rent, salaries, and overhead. We took the opportunity to overhaul our pricing structure.

Those of you who have volunteered to help at our quarterly inventories may realize that we have about 240 items in stock. (Did you know we have that many items?) Our price review has resulted in substantial price changes for about 75% of our items under the new system. "Substantial" price changes mean more than 5 cents difference from the old price. Fifty-eight items will not change price, or will change less than 5 cents (after-tax) from the old price.

Our decisions about price changes were driven by our primary purpose: the closer an item is to our mission to foster sobriety, the smaller the markup ("profit") we expect to achieve. When it comes to stickers, jewelry, "lifestyle merchandise" or "drunk junk", we look for a higher margin. Additionally, the slower the merchandise sells – it costs us money to keep it in stock, but it may be important to have it – the more it costs us to make it available.

Bottom line – I just want you to know that we (our Office Manager and your ICSC) have thoughtfully considered these price changes. Most sobriety chips will be slightly less expensive for your groups; basic recovery items will be about the same, and we are confident that we have approached these changes with AA's spiritual values in mind.

One final note – we had hoped to bring up the new POS system seamlessly on October 1 – but that's not going to happen. We underestimated the amount of analysis, data input, and training it would take to do it. We think the new system will go live some time in October. We ask your indulgence while we make the transition. Our volunteers will be coping with two different pricing systems as they learn how to use the new computer on their desk. Please trust your trusted servants as they guide you to what "today's price" is on merchandise that may be labeled one price on the shelf, another price on a label attached the item. While it's confusing, remember that, "this too shall pass."

We are excited about the opportunities the new system will provide to ensure that the items you need will be in stock when you wamt them, at an affordable price, and the efficiencies the new system will give us to reduce the costs in time or money to meet your needs.

To serve as a BTG volunteer the following is required: 6 months of sobriety, a working knowledge of the 12 Steps, attend one BTG volunteer orientation meeting, a working telephone and transportation.

Service work brings a "new quality" to the sobriety of the volunteer who makes himself available to help others. Learn what it means to be truly "available". Come join us in this celebration of service and help us honor our volunteers.

PI/CPC Can Be a Low Maintenance Commitment

As a new member, commitments to groups have multi-facet benefits to the individual including the feeling of inclusion, being useful, and interacting with other people who really want to recover. Long before the steps have taken hold of a person's life, a commitment to a group is evidence to the new member and those around them that they are personally vested in the recovery process.

Those of us with a few more 24 hours continue to see the value of holding commitments for the same reasons as the new member. The commitments we hold increase in complexity and responsibility but at the core they have the same benefit except that it is more on the service / gratitude plane rather then proving that we are serious about recovery.

The problem is that if we continue to engage in commitments that continually increase in responsibility and complexity and need for time, we find that for a lot of people the demands of these volunteer positions are too large. There are those of us that embrace this challenge and I commend them for it. But what about the rest of us?

There are two solutions:

- 1) Drop out of the service structure which means we abandon the benefits of commitments or
- 2) Find something that isn't as taxing.

PI/CPC speaking or PI/CPC committee work might just the ticket.

The committee meets only once a month with no other requirement. Being a PI/CPC speaker allows you to accept or deny any possible speaking engagement ... your terms.

OFFICER REPORTS:

CHAIR: Diane W. – Diane acknowledged the passing of Bill S. of Sonoma, who died August 17, 2008 with 60 years of sobriety. She reviewed Steering Committee decisions, including an increase in Unity Day seed money to \$550.

VICE CHAIR: Bob P. – Welcome new reps. Call Bob if you have questions.

TREASURER: Pat H. – Group contributions were \$5,635 for July. Total income exceeded expenses by \$1,688 for July: \$1,545 from Central office, \$190 from the Picnic, \$14 from the Seminar and \$61 net loss in bookstore. SCIF provided sign language interpreters for the July seminar and three deaf people attended.

SECRETARY: Donna L. - The August SCIF General Meeting minutes published in the September newsletter were approved without changes.

REGISTRAR: Nan B. – In July there were 354 meetings/week in Sonoma County. Of those, 151 (43%) were represented in SCIF.

BOOKSTORE: Diane W. (Linda M. was absent) – All shifts are currently full. The bookstore donated 20 metal folding chairs and 3 tables that weren't needed. Staff is currently entering data into the new POS system, and the overall cost is remaining under the \$3,000 budgeted.

COMMITTEE REPORTS:

ICSC: Gene H. – The committee has been discussing bookstore renovations, which will be discussed under New Business.

ACTIVITIES: Laurie E. – Halloween Dance "Night of the (Sober) Dancing Drunks" will be held Saturday, October 25, at the Sebastopol Community Center. There will be a live band, "Lucky Earl", and a costume contest. Laurie is looking for someone interested in being the next Activities Chair to step up and learn the ropes from her during the last 3 activities of her term. Call her if you're interested.

ALKATHONS: Barbara F. – It's time to schedule meeting slots for the three alkathons. Volunteers are also needed to help with the events. Call Barbara.

NEWSLETTER: Brian Z. – Brian was introduced as the new Newsletter Editor.

OUTREACH: Sean M. – There is, once again, a signup sheet going around for people to volunteer to attend unrepresented meetings and encourage them to elect and send Intergroup Rep to business meeting. Some meetings have reps, but they aren't signing in when they attend. This is important for SCIF records.

SEMINARS: Doug S. – The July "Family in Recovery" seminar was well received. The next seminar will be a "Secretary's Guide", and will be held in October.

TELESERVICE: Dave R. – There is an open shift on Sunday overnight – 10pm-8am. Kevin P. attended as a representative of Petaluma Teleservice, which has a 24-hour answering service equipped with a meeting schedule and contact list. They've requested their contact phone number be added to the newsletter.

LIAISON REPORTS:

BRIDGING THE GAP: John B. – BTG's purpose is to "bridge the gap" between AA meetings in prisons, hospitals and treatment facilities and the first meetings inmates and patients go to upon release into their home communities. In August there were 33 contacts: 14 local, 8 out of district, 8 out of area and 3 returning from out of district to Sonoma Co. If you're interested in volunteering, go to their business meeting (see calendar). CNCA is hosting 3rd Annual Bridging the Gap Forum on 10/26/08 at Cotati Veterans Hall 9am-4pm.

HOSPITALS AND INSTITUTIONS: Mark V. – Come to H&I business meeting to get involved in bringing meetings and literature to people who can't get out to meetings. The 61st Annual NCCAA Fall Conference will be held Sept 5-7 in Santa Cruz. For info. visit www.nccaa.org

PI/CPC: Nick R. – Come to PI/CPC business meeting to get involved in distributing literature to libraries, police stations, jails, trauma centers and hospitals, etc. PI/CPC also provides speakers to DDP classes, schools, the judicial system, etc.

SOCYPAA: Sean M. (temp) – There are a lot of open service positions in SOCYPAA, so come to a business meeting if you want to get involved. They are working on a bid for the 2010 ACYPAA conference, which would bring ~1700 people here. The Pomo Canyon campout is Sept 5-7. Discovery Kingdom trip is Sept 27.

ACCESS SONOMA COUNTY: Jamie T. – They are temporarily out of the list of child-friendly meetings – more will be reprinted and available next meeting. They are also expanding their survey to ask those with special needs what exactly they need to access AA.

GENERAL SERVICE: Lauralyn C. – GS disbursed \$1000 to CNCA – the first this year. They passed a motion to increase their prudent reserve from \$1500 to \$3500.

SPANISH INTERGROUP: Shaline E. - no report

UNITY DAY: Shirley J. - Unity Day will take place on October 18 from 9am-4pm at the Sebastopol Veterans hall. SCIF is responsible for registration/beverages/decorations. Shirley passed around a sign-up sheet for reps to volunteer.

OLD BUSINESS: Motion: That the SCIF By-laws be revised to amend the process of electing Intergroup Central Service Committee members, to specify voting privileges at the General Meeting, and to add the Central Office/Bookstore Manager to the Steering Committee.

- After more discussion, it was decided to bring this back to the September General meeting for a possible vote.
- Because some group conscience reports reflected misconceptions about SCIF history and AA Traditions and Concepts, Diane promised an expanded information packet would be available at the bookstore by August 28

NEW BUSINESS: Motion: That SCIF proceed with a renovation project to enlarge the bookstore area to make more efficient use of space, at a cost not to exceed \$5,400.

- Reps are asked to discuss this motion with their groups, and bring comments back to September General meeting.
- Information is available in September newsletter, pages 2 & 3.




