NOTES FROM THE BOOKSTORE

If you have been following the treasurer's report in the Newsletter for the last few months you have probably noticed that the SCIF Bookstore has been operating consistently in the “red”. After studying this problem the ICSC has recognized that we need to raise book prices to the level that is comparable to the margin that existed before AAWS raised book prices in July of 2009. Therefore book prices will be going up as of Monday October 4th 2010. These price changes that are going into effect in October will be less than a dollar per book and a new price list will be available at the Bookstore the first week of October.

The Bookstore has an opening for a volunteer on alternate Monday afternoons from 2pm to 6PM. If you are interested in volunteering for this bookstore position please come in and fill out an application. All Bookstore volunteers must have a least one year of sobriety and knowledge of the 12 Steps and the 12 Traditions.

Daylight Savings time ends on Sunday November 7th and Bookstore winter hours will go into effect on Monday November 8th. This means that the Bookstore will be closing at 5PM Monday through Thursday until March 14th 2011. The Bookstore will remain open until 6PM on Fridays throughout this period and will retain its regular hours on Saturday from 11AM to 3PM.

The Sonoma County Public Information Committee of Alcoholics Anonymous is dedicated to providing our community with information about our personal form of recovery from alcoholism and to explain what AA is and is not.

We provide updated literature to Police stations, libraries, Emergency rooms, Senior Centers, Court Houses and the like. One of our services is provide speakers knowledgeable about our recovery program to any institution desiring them. These speakers are A.A. members- former problem drinkers with some years of sobriety, and are well qualified to answer any questions about how alcoholics can recover in A.A. We would encourage younger members to get involved or anyone for that matter.

The truth is that as energetic and enthusiastic as we on this committee are we are too few to accomplish all the tasks we have the potential to undertake. We are making progress though; doing some of our tasks by committee and not as individuals has helped. What we do, we do very well but it seems that there are things left untouched or unfinished through no fault of anyone's. We are already busy with our current tasks and life in general to do a whole lot more. So I invite anyone with some sobriety time and knowledge of the steps to join us. We have positions available and are in need of additional committee members. The time obligation is not a burden and really manageable

We are preparing to contact our local Radio and TV channels in an effort to get AA public service announcements aired and schools are back in session so we will be discussing our strategy on making them aware of our capabilities and how we can be of service. As you are aware we continue to provide your GSRs with packets for you to take to your doctors and clergy. These professionals are in contact with problem drinkers who maybe unaware of our program and the possibility of recovery.

Thanks for you support Sonoma County and we look forward to seeing you at our committee meeting, you never know when you actually help that struggling alcoholic find their way to recovery, what a gift we have been given.

When anyone anywhere reaches out for help, we want the hand of A.A. always to be there and for that I am responsible.

SOCYPAA

At age 19 I hit bottom. I knew I had a problem and it was time to find help, though I doubted anyone could help me. Coming to Alcoholics Anonymous was a last resort. At the time, and place, I got sober; there were few people my age in meetings. I found it hard to identify at first, as many of us do. With regret and dismissal, I realized that getting sober meant I would no longer be able to have friends my age. I accepted this, because I was tired of hating myself. If I hadn’t been so afraid of my own self-destruction, I probably would not have stuck around. In fact, I did relapse after 2 years of sobriety, when I returned to my old stomping grounds to find the peer relationships I craved. By some miracle, I made it back, and that earlier experience made me want to be a part of making the program more attractive to young people. In the spring of 2004, a friend came to me and told me she wanted to start a young people’s meeting. A few months later SOCYPAA was born. I have been a member on the committee ever since. Being of service, through SOCYPAA, has been an essential part of my recovery. It helps me stay in the center of the record. I now have a vast amount of sober friends. I am constantly meeting new young alcoholics and showing them getting sober doesn’t mean life will be boring. The SOCYPAA events are a bright spot in my life. It is there that I find the fellowship and excitement that I crave. Speaking of which, I’m off to the campout. Hope to see you there!
