# A.A.'s Big Book Named One of the "Books That Shaped America"

(NEW YORK) – It's never been on The New York Times Best Seller list. Yet the "Big Book," A.A. members' fond name for the book "Alcoholics Anonymous," is now designated by the Library of Congress as one of the 88 "Books That Shaped America," and is included in the library's new exhibition.

While we cannot know what impact A.A.'s basic textbook, "Alcoholics Anonymous," has had in shaping America, we do know that the Big Book has helped millions of men and women throughout the world, and in all walks of life, find a new and satisfying way of life without alcohol. The Big Book describes the A.A. program of action for recovery from alcoholism. It has offered con-

vincing evidence to relatives and friends that alcoholics can recover; and has furnished revealing insights to physicians, psychologists, members of the clergy and other professionals who work with alcoholics.

Although no author is listed, it is common knowledge that the initial draft of the Big Book was written by A.A. co-founder Bill W. when he was not quite four years sober. But he did not complete it alone. "Alcoholics Anonymous" was a collective creation, since each chapter was "edited" by A.A. members in Akron, Ohio and New York City—all of them sober less time than Bill. This cooperative effort, reflecting the shared experience and consensus of the small Fellowship as a

whole, set in motion the democratic process of decision-making that characterizes A.A. today.

The book provided the name for a small movement with nearly 100 members. It took 36 years to sell the first million copies. Yet today, every year approximately one million copies of the Big Book are distributed in the English language alone (it is translated into 67 languages), and A.A. membership has grown to over two million with a presence in more than 170 countries. In 2010, the thirty-millionth copy was presented to the American Medical Association, which declared alcoholism an illness in 1956. For information about A.A. go to: www.aa.org.

#### The Danger of the "I'm Bored" Club

One of the biggest challenges to sobriety and continued membership in A.A. is to stay out of the "I'm Bored" club.

I've heard your rags to riches to rags and back to emotional riches story blah, blah, blah. I know, "Rarely have we seen a person fail ..." You've told me that, literally, more than a thousand times.

You would think that our primary enemy is an overwhelming unimaginable craving. However, you won't hear that from the people who come back to our groups after drinking. We have coached them to say that they were in error and had stopped going to meetings. But why did they stop going to meetings?

It's easy to become dismissive (even if it isn't verbalized) of the lifeline that has been given to us. Becoming part of the "I'm Bored" club is more insidious than a craving because it can immobilize a person without a fight.

Unlike what the rest of society thinks, it's not someone else's job to keep me entertained. It's also not A.A.'s job. From day one of sobriety I have to find something that is more interesting than drinking. Meetings are a good start but that has limited range.

Good News! There is a world inside and outside our Fellowship that has a wide variety of interesting challenging fun activities for me but they are not packaged conveniently in the meeting guide. One has to do a little scratching and finding.

#### **BRIDGING THE GAP**

#### A Full Circle of Service

It was the summer of '98. A decent summer it was. Warm days, calm nights and I was in rehab. Not that I had a problem, just that the problem was greater than I wanted to be incarcerated over.

It was August and two men showed up on the second Saturday of the month, as was done for some time and still is. They showed a video that I could barely remember in my foggy brain — even the next day. They spoke a bit of their journey in A.A. and handed out blue cards that if we filled out someone would contact me and take me to a meeting after I graduated from the program. So I filled out the card with the thought that I would be returning home soon enough.

After I arrived at the SLE I had never intended on going to, I received a call from a gentleman offering to take me to a meeting. I told him I wasn't where I had declared I would be on the card. He told me that wasn't a problem that there were members of A.A. all over and only a phone call away. I graciously declined the offer, as I was with my crib mates, don't ya know. And wasn't that enough? Some years later I was introduced to the very committee I had declined for that first ride to a meeting.

It was a subtle commitment as many are in the beginning. Just helping do what was done for us the day we filled out our blue cards. Wonder how many others never made it? Soon enough the commitment escalated to its own fourth dimension and I was flying solo, leading a team of presenters at treatment centers.

Ten years later — to the very day — I was on the opposite side of the table at that very rehab I had attended. Having had come full circle I reflected, this was all bigger than I was. Never in my wildest dreams did I perceive I could stay sober for this long and eventually have the privilege to give back what had been freely given to me. What do you know, service can keep you sober. Go figure — they were right.

I still work with the Bridging the Gap committee, and a renaissance is happening. Public information, Hospitals & Institutions and Bridging the Gap sitting at the same table with a singleness of purpose to inform the public and private sector, carry the message, and bring an alcoholic to a meeting so they don't have to continue to suffer. Not a bad gig.

#### District 12 - Sonoma County General Service Interpretation & Translation Committee

Do you have experience with sound system and/or electronic equipment? Do you enjoy being a recording secretary? Are you bilingual in English and Spanish? Or are you just interested in expanding your recovery in a new service job (no experience necessary, just willingness). The Sonoma County General Service Interpretation & Translation Committee (ITC) will be rotating members at the end of this year. This is a great time to get involved so that new members will have plenty of time for the "pass it on" process with the current five members.

Come join the youngest sub-committee of our local General Service, which originated in January 2011, at the start of Panel 61 (a two-year rotation). We were the first district interpretation & translation committee to form of the 23 districts that make up California Northern Coastal Area (CNCA). Our ITC Guidelines state that the purpose of the ITC is to improve communication within the District through enhanced interpretation and translation services.

Specifically, we are the custodians of District 12's equipment (sound system, speakers, transmitters and wireless microphone system). We are available for all District 12 service events to provide a sound system, simultaneous Spanish/English interpretation and assisted listening. We may also provide such services to any A.A. service event within the geographical boundaries of the Sonoma County Fellowship. Our members have also provided written translation upon request.

#### Home Groups: Reach Out to Those in Need

When I came into Alcoholics Anonymous I was told how the home group is important. For one thing it's the place where people get to know you, where they notice if you aren't showing up, and might call to check in with you.

It happens at times that members will be hospitalized or homebound due to illness or injury, unable to get to meetings. Not only are they dealing with infirmity, they may be isolated from their Fellowship that they rely upon for support even during good times. This is where the home group can be of service to the alcoholic in need.

If you notice that a regular member at one your meetings has not shown up for a while you may ask around to see if anyone has heard from them. You may pick up the phone list and give a call to see if they're OK. If you find they are hospitalized, or simply can't get out to a meeting, you could ask them if they would appreciate a visit from you or a few members from the home group. Bring a meeting to them!

This reminds me of the responsibility statement "I am responsible... when anyone, anywhere, reaches out for help, I want the hand of A.A. always to be there. And for that, I am responsible." Many meetings do a group inventory in November, this could be a topic for your group to explore during their next inventory.

The Access Sonoma County committee is dedicated to educating members about how they can help address barriers that folks may face when wanting and needing to participate in A.A. Removing barriers to access doesn't always mean moving chairs around or giving rides to others, sometimes it means bringing the program of Alcoholics Anonymous to someone!
