


There are signs that the upcoming Petaluma Fellowship Unity Day celebration could be one of the most exhilarating yet.

<u>H&I Report</u>: Mark V. reminded folks that H&I meets on the first Wednesday of each month at the Senior Center with an orientation for those interested in this service commitment at 5:30PM, followed by the business meeting at 6:00PM. The 36th Annual H&I Conference will be held in Petaluma on August13, 14, 15th 2007 — volunteers are needed.

<u>General Service</u>: Kenin H. reported that the Summer Assembly will be held in Fortuna, California on August 12, 2006.

<u>PI/CPC Report</u>: Bob K. filled in for Dave R. Bob encouraged anyone wanting to be of service to this committee to attend the service meeting. They meet the 2nd Wednesday of every month at SR City Hall lounge, with speaker training at 7:00PM and the business meeting at 7:30PM. They are in need of volunteers. He explained the function of the group is to provide accurate information about A.A. and to distribute literature to hospitals, police stations, hotels, jails,

libraries, etc. They are in need of speakers for the County's drinking/driving program. This commitment requires two years of sobriety.

They use a list of AA volunteers to coordinate with recently released AA newcomers and take them to their first meeting. ASC is working to help other groups identify and remove barriers for access to members in order to better carry the AA message. Some of our members are concerned with homebound members, others with access to non-English speakers, and some for access to AA's with physical disabilities. ASC currently has a member working to reach out to the blind and visually-impaired members and help them integrate into the program. If you know of anyone who would care to help in this way, we would love to hear from you.





The Complaint

Tradition Ten states that no A.A. group or member should ever, in such a way as to implicate AA, express any opinion on outside controversial issues – particularly those of politics, etc. The interesting thing here is that it refers to "outside" issues, carefully ignoring "inside" issues.





The fact of the matter is that we all (Intergroup or General Service members) were elected by our respective groups to do certain things that by their very nature <u>seem</u> "political." But that draws too wide a border around the concept of "political." That is, we make decisions and choose – for our groups and for Alcoholics Anonymous – from options that have more than one point of view attached to them; but we do the same thing, granted with less consequence attached, when we decide what to have for breakfast. If that is "political", so be it.

Having choices, and having to decide among them, is in the nature of being human, and there is no reason that we, as alcoholics, should escape that fact of life. Sometimes the result is important, and sometimes not. But the fact is a decision needs to be made. It seems to me a suspiciously peculiar habit of alcoholics to want to disavow any responsibility. If you don't do anything, you can't be blamed.

One thing that we have, which tends to not be characteristic of other institutions, is a really careful way of making decisions. We allow discussion about a topic to go way beyond the discussions allowed in other institutions. We tend not to be impressed by titles. We tend to pick our "leaders" more carefully than in other institutions; then we more or less strip these "trusted servants" of any but an advisory power. But we get the job done in the most democratic way possible, and with the fewest hard feelings.

So this is just a reminder to all those who hear the complaint that "blah blah (Intergroup or General Service) is too political." You can dismiss that complaint knowing that if someone did not do the job, we would not have meeting schedules, we would not have Unity Day, a Book Store, any connections with New York, or any of the information which is really useful to run the day to day affairs of Alcoholics Anonymous.

Stood Up or Stand Up?

For the past decade I've served as an AA speaker to classes of the County's Drinking Driver Program.

Two years ago I took on the responsibility of coordinating speakers for the program as well. As one of four coordinators I schedule speakers for classes held on Wednesdays and Thursdays, which means I'm responsible for usually about one class a month.

In the past few months I've had a couple of speakers stand me up, agreeing to speak at a given time and then not showing up. In



neither case did the person call to explain, and I was beginning to harbor a certain *resentment*. Then came August, and when I pulled out my schedule on the 6^{th} to find the date of the next class – I discovered it had already passed on the 2^{nd} and now I was the one who had stood up the class!

I too was guilty of human error, and I too had the responsibility to take my own inventory, admit my failure, and do my best to make amends. The next day I called the instructor and left a message on his answering machine, apologizing for missing the class and offering to schedule a make up at any time that would be convenient for him. At this writing I haven't

Editorial on the 4th Step

The following editorial first appeared in the AA Grapevine, February 1946.

"Made a searching and fearless moral inventory of ourselves."

Self appraisal which attains any real accuracy is unquestionably a difficult process. We all find it so easy and pleasant to view ourselves through a rosy hue of complimentary half-truths and so hard and unpleasant to take a look in the uncompromising and glaring light of the unvarnished truth.

The 4th Step is, indeed, a real challenge to honesty with oneself. In this way, it is both preparation and a complement to the 5th Step. To make the "searching and fearless moral inventory" called for in the 4th Step, one must first of all be searchingly and fearlessly honest about himself. The degree of honesty one can achieve will determine the accuracy and therefore the usefulness of the moral inventory.

One practical way of starting this very practical Step--or at least a way that helped one newcomer--is to prepare a record sheet with two columns, one headed, "Liabilities" and the other, "Assets."

Under "Liabilities" can be listed personality deficiencies and faults, such as intolerance, selfishness, indecisiveness, fear, indolence, a bad temper, impatience and a whole host of other qualities which most everyone at this early stage discovers he has in abundance.

Under "Assets," if any, can be listed the opposite positives--tolerance, generosity (and this does not mean giving the poor bum a dime for a cup of coffee and feeling noble about it for two blocks), thoughtfulness of other people, humility, patience, and a few other attributes. Few persons, if honest, ever work up much of a list on this side of the ledger for their first moral inventory.

The actual process of deciding what to put in each column consists of asking oneself some pointed questions. Am I tolerant of other people's peculiarities, other creeds, other colors, other races, other opinions? Or do I dislike somebody because of the way he combs his hair or ties his tie? How many favors will I do other people without expecting one in return? Will I really go out of my way to help someone, or only when it's convenient? Do I feel

superior to others? Am I impatient of others' shortcomings, while being very patient about my own? Am I honest, or do I practice deceit and double-talk, and then excuse myself afterwards with some fancy rationalizing? Am I kind, considerate, gentle?

The more questions one asks himself along this line the clearer become the entries he should make in each column.

If this is the first moral inventory one has taken of himself, or at least the most honest one, he will find it the most trying. But he also will find that in itself it will give him a certain feeling of relief. Finally he has begun to face facts. Finally he has worked up enough courage to face himself as he really is, and not as he has been dreaming he is. This is a courageous step forward. It is another step onto the path to sanity, stability and happiness.



To Hear And To Be Heard

The following is contributed by Tim P., Intergroup Vice-Chair.

After a sharing session (about printing reports on funding for ASL translation at the Signs Of Sobriety group), a member mentioned having had a conversation with a British friend on a similar subject. I encouraged her to ask him to share his experience, since it might be meaningful to us. Here is what he had to say.



(I am leaving the local member's name blank at her request. Also, she informed me that "lip reading" allows comprehension of about a third of what's said.)

- --Re: Pimlico Deaf and Hard of Hearing Group--

How are you doing? I just thought I would send you my thoughts on the above meeting which I told you about recently.

Early this year an AA member, John H., phoned me to ask if I would be able to speak at the first meeting of the Pimlico Deaf and Hard of Hearing Group. He explained that several people who were hard of hearing had approached Chelsea Intergroup to see if they would consider paying for a professional "signer" for this new group. After a debate they agreed to do so initially for a year. This would be the first time in the UK that this would have happened.

So off I went, dressed becomingly, to do service for our fellowship. There was a turnout of about twenty, half like myself with normal hearing, and the rest with various hearing difficulties. The "signer" was there and a loop had also been set up to help those with hearing aids. I spoke for about twenty minutes. Then the floor was open for general sharing. Each person had to come to the front so that the signer could do her job and also people could lip read.

There was one girl there who was completely deaf. Because of the signer, this was the first time in her six years of sobriety that she had been able to share. She had always had to rely on one of her family scribbling down notes for her. She was crying, I was crying (tough Scot that I am), and so was everyone else. I realised then what a great decision the Intergroup had made. Sometimes we AA's just need to put our hands in our pockets and give a little extra. I felt so happy afterwards that one of our fellow alcoholics who had been just sitting for years was at last feeling that she was "part of."

God Bless. I hope all is well in Northern California. Peace and keep the faith.

The first inventory should not be the last by any means. In fact, the principle and the technique of the moral inventory become a vital part of the new life. The first is the most difficult. Subsequent inventories show where progress has been made, where more effort still needs to be placed. If an inventory be taken at regular intervals, one has at hand a guide for keeping on the beam.

The moral inventory is one of A.A.'s most effective techniques. Of course, as with other A.A. techniques, its effectiveness depends on how well it is used. The inventory will not work by itself. The benefit comes about through the efforts made to change that which the inventory reveals should be changed.
