

A New Look for an Old Space **Proposed Central Office and Bookstore Renovation**

Motion: That SCIF proceed with a renovation project to enlarge the bookstore area to make more efficient use of space, at a cost not to exceed \$5,400.

The Central Office/Bookstore has been at 750 Mendocino since October 1994. The facility is showing its age - it is crowded, dingy, and worn. The "bookstore" room is only 15% of our space, and it is not serving us well.

The proposal is to remove two partition walls and move the bookstore from its present location in a small room in the back corner of the space to the front room (see floor plan). The move would provide an open and spacious store for those we serve, while preserving a slightly larger space for meetings. Beyond appearance, however, there are practical reasons for a renovation.

SAFETY/SECURITY: Bookstore volunteers cannot see who has entered when the door's cowbell rings. When the volunteer is alone, it can be scary. Removing the hallway wall and repositioning the volunteer desk would provide a clear view of the door.

The closet where we store folding chairs is also the location of the electrical breaker box. In an emergency, we would lose time removing the chairs. Removing the hallway wall would allow us to store the chairs on a cart that could be wheeled out in seconds.

WASTE: The front room and the hallway are 42% of our space. Our rent is \$805/ month. This means that we are spending \$340/month on these areas, and they are used approximately 8 hours each month for meetings and seminars. The rest of the time the front room is unused. The renovation would allow us to use the space 199 hours/month.


INCREASING BOOKSTORE SALES: The current bookstore room is not adequate to display and sell our books and merchandise. The bookstore is intended to be a selfsupporting (non-profit) operation, but there are indications that some of our merchandise could help us "self-support" better if members could see it when browsing for gifts for sponsors, sponsees, or others. With a better return on our investment in space, we could consider reducing the cost of books and chips, which are our "meat and potatoes."

WHY NOT MOVE? The average annual cost of comparable space in Santa Rosa is \$15,000. We pay only \$9,660. We now have a three-year lease. Investing up to \$5,400 in renovating this space would cost about \$10,000 less over the course of three years than paying rent in another space (even without the cost of moving). And in the fourth year and each year thereafter, we would save more than \$4,000/year in rent by remaining here, in our updated space.

We have an extraordinary opportunity now because we have unallocated funds in our operating reserve - more than enough to fund this renovation. These funds are available because the fellowship was very generous last year and we have been reducing expenses for the last 18 months. What SCIF has historically done with unallocated funds is forward them to GSO in New York (last done in 2002). This proposal allows us to use a portion of those funds locally to benefit the groups and members who contributed them.

Your ICSC members have discussed this problem for months. They have consulted the landlord, interviewed contractors for estimates, looked at other rental sites, measured space, planned costs and considered alternatives. Over the last two months, they have discussed the proposal with the Steering Committee and secured its endorsement. We look forward to a thoughtful and informed discussion of this proposal by the groups we serve.

OFFICER REPORTS:

CHAIR: Diane W. – Diane reported that we need a newsletter editor, and reported on the earlier issue of exposure to liability if we advertise child care at an event. Our liability insurance covers us, but we decided not to advertise "child care".

VICE CHAIR: Bob P. – Bob welcomed the 9 new reps that attended the orientation, and invited them to call him if they had any questions.

TREASURER: Pat H. – Group contributions were low - \$2355 for June. July is looking good – almost \$3000 as of the 10th. Due to low contributions and low bookstore sales, expenses exceeded income by \$1624 for June, and \$402 YTD. A physical inventory was taken at the bookstore at the end of June, with extra detail work to insure accuracy. Thank you to Diane and our bookkeeper, Anne, for all the extra time they put in. We have separated out the \$1500 we voted to commit to sign language interpreters and the \$3000 set aside for the POS system from the un-appropriated operating reserve.

SECRETARY: Donna L. - The July SCIF General Meeting minutes published in the August newsletter were approved without changes.

REGISTRAR: Nan B. – (Nan absent, Sean M. reported) There were 363 meetings/month in June, and 147 of them (40%) were represented at the June SCIF General meeting.

BOOKSTORE: Linda M. – Bookstore sales were down in June, but gross sales are up 10% so far this month (July). They have the software and hardware for the new POS system, and need another computer for the volunteers to use. By September, they expect to be running the old and new systems parallel. There is an opening at the bookstore on alternate Wednesdays from 10am-2pm.

COMMITTEE REPORTS:

ICSC: Gene H. – Treasurer's report was discussed – gross profit for bookstore lower than normal for June, but close to target for YTD. Now down to 3 month inventory, this is better. Also discussed POS system implementation. Gene talked about facility lease – 3year with possible increase of 2 yrs and not to exceed 6% increase in rent in any year. Current rent of \$805 is very reasonable compared to market. Bookstore renovation estimates are being received for removing walls and patching. May need to improve drawings for City and get fire inspection. May need to get business license for bookstore and pay retroactive fees. Gene was elected ICSC Chairperson. Raise for Bookstore Manager approved.

ACTIVITIES: Laurie E. – The picnic was great – well attended and it broke even financially. Thanks to SOCYPAA for face painting and games for the kids. Next event is Halloween Dance the Saturday before Halloween at Sebastopol Community Center. New Year's Eve Dance will be held at Santa Rosa Veterans Hall. Laurie is looking for others to get involved, especially anyone running for Activities Chair next February.

ALKATHONS: Barbara F. – It's time for Groups to request meeting slots at the Alkathons. She is also looking for volunteers to help.

NEWSLETTER: Open Position – Roger is no longer the Newsletter Editor, so the position is open. The August newsletter was produced by Diane with help from Donna.

OUTREACH: Sean M. – Sean passed around a list of meetings that used to have reps but don't now. He wants other reps to sign up to attend some of those meetings, encouraging them to elect and send reps.

SEMINARS: Doug S. – (Doug absent, Donna gave report) The next seminar is in two days – July 30 at the bookstore on "Families in Recovery".

TELESERVICE: Dave R. – All Teleservice shifts are currently filled.

LIAISON REPORTS:

To The Fellowship:;

I think most, if not all of us, can agree that the "n" word is inappropriate. Lately, another "n" word has been popping up. It seems like I hear it more than I used to. I am not sure the speaker of this other "n" word realizes the connotation this word invokes, or the painful historical memories it carries.

The other "n' word is Nazi ... as in "step nazi," "book nazi," or "my sponsor is a real nazi." It seems I have been hearing these phrases more lately. Like the other "n" word, Nazi carries a violent and painful memory for many in our fellowship. Some of us lost relatives or entire families at the hands of a hateful enemy.

This is my opinion. It is absolutely inappropriate to use these phrases at meeting level and, quite possibly, at all. You don't know whom you are offending or the depth of the pain your words cause.

One of the attractions of this AA program is that I can go to any meeting, anywhere, and be, theoretically, safe from physical harm, and verbal and physical harassment. The contract is I am safe because you agree to not harm me. You are safe because I agree not to harm you. We all have the right to speak out when meetings become unsafe. And when we feel unsafe, the rest of us have an unswerving obligation to honor those feelings and requests.

It isn't necessary that you understand why someone is offended, although I hope you can. What is necessary is that you honor the request and the person who made it. If we truly are here for each other, that is. We try not to bring old behavior into our recovery. The Big Book says that once we know better, we are obligated to do better.

We don't need to make new rules. We just need to raise the awareness. A raised awareness generally takes care of the problem.


Let's keep the meetings safe for all who seek recovery.




