**Secretary:** (Patty G) June 27, 2011 General Meeting minutes put forth and approved.

Treasurer: (Shirley J) Group contributions were \$2,496 for June -- \$826 more than 2010. Group-supported expenses exceeded contributions by \$925. Bookstore expenses exceeded income by \$773, Activities contributions exceeded expenses by \$1,269, Seminar income was \$81, resulting in a net overall loss of \$348. Slow Bookstore sales month.

**Registrar:** (Jimmie B) There were 229 groups offering 352 meetings per week in Sonoma County; there were 84 reps at the June General Meeting for a 37% representation.

June sales lowest recorded in 30 months with gross sales less than \$6,000. #### **PICPC NEWS**

PICPC is the acronym for Public Information and Cooperation with the Professional Community. Two committees combined into one, which are part of the General Service structure here in District 12.

We are the committee that provides trained speakers to make presentations to the public and to professionals about what AA is and isn't, what AA does and doesn't do. We provide this information to the public at DDP (Drunk Driving program) classes, students at schools, Health fairs and the like. We provide this information to Professionals such as Child Protective Services staff, service providers to the homeless or at risk adults, Judges, Lawyers, Dr's to name a few. Why do we "train" our speakers? Because speaking to the general public and to professionals is not like telling your story at an AA meeting. At an AA meeting there are people who may know they are alcoholic or have a desire to stop drinking. The likelihood is that they are interested and having an emotional response to what you have to say. At a PI/CPC presentation, it is much more likely that you are not speaking to alcoholics or they are not responding emotionally to your presentation.

It is important to conduct ourselves in a more businesslike and professional manner for this special type of service. We are giving a professional and concise overview of the AA program in the hopes that those listening will see how it can benefit the clientele they serve or maybe themselves. How that comes across is how they will perceive the potential lifesaving success of the program of Alcoholics Anonymous.

It is truly spiritually rewarding to carry the message in this different way. We welcome you to check us out and see if you feel it too!

#### A DEDICATED TRUSTED SERVANT

Our Sonoma County Intergroup Fellowship, indeed all of Alcoholics Anonymous, has lost a dedicated trusted servant. Diane W. passed away on August 10, 2011.

Diane found sobriety in San Mateo County on September 1, 1985. She had a long history in General Service and served as the California Northern Coastal Area Delegate to the General Service Conference in 1993 on Panel 43. She was Conference Delegate Chair in 1994.

More recently, Diane served as Chair of Sonoma County Intergroup Fellowship in 2007 and 2008. It was an eventful two years. Diane was instrumental in organizing the remodel of the bookstore, installing the computerized POS system and reducing inventories to appropriate levels. She also established systems to document policies and procedures for future reference. Diane was also a founding member of the Access Sonoma County Committee. AA accessibility for all was a passion of hers and she served on the Access Sonoma County Committee until her death.

Since AA's 12 Traditions were so ingrained in her, Diane had an innate ability to look at any problem and see what we weren't seeing. In a detached but loving way she could come up with solutions and processes which were immeasurably helpful to each situation. Because of her attention to the Traditions and the Concepts, she served on dozens of AA committees: Steering, Ad Hoc and Guidelines. She always said to "Trust the Process". She was a Sponsor and Service Sponsor, always encouraging us to believe in ourselves. She was passionate about AA service and cherished AA's principles. She brought her Experience. Strength, Hope and Wisdom everywhere she went. Diane dedicated her AA life to making the message available to all who want it. And for that we are all grateful.

A Memorial will be held to celebrate Diane's life. Time and place will be announced.

#### **BRIDGING THE GAP PRESENTER GOES TO JAIL!**

Santa Rosa—After four months of waiting, BTG presenter Chris S is cleared to present the message of hope and help to soon-to-be released inmates of the "Starting Point" program at the North County and Main Detention Facilities(Jail). *18 inmates* filled out blue request cards for help to get them to their first meeting after release. The beginning of the miracle begins with the willingness of the inmates(newcomer) and the generosity of the AA member who passes along the gift which was so freely given to him or her.

"I am responsible when anyone, anywhere, reaches out for help; I want the hand of AA always to be there. And for that I am responsible."

Remember our statement to keep this gift of sobriety we must give it away. For we have this Twelfth Step opportunity in **Bridging the Gap**. We have the privilege of doing for the newcomer what someone did for us. Here's what BTG needs:

- Volunteers to take newcomers just out of treatment to their first meeting. Just fill out a yellow card (or flyer) and show up for orientation at the bookstore on the <a href="third">third</a>


