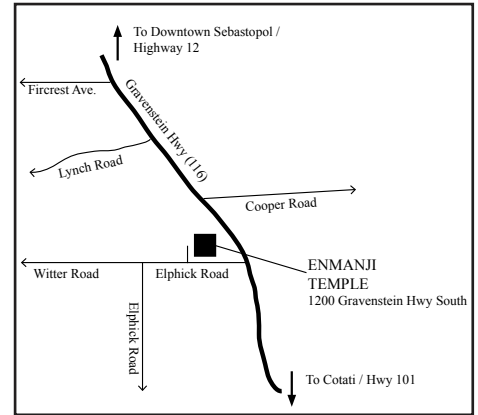
Next Unity Day Planning Meeting Aug. 31 at Enmanji Buddhist Temple

A Spiritual Experience!

I'm a volunteer with Bridging the Gap. I help present at Orenda Center one day a month. Back in April I went to the Orenda Center to share my experience with A.A. That day I met a nice lady that was in detox. She listened to my story and, at the end, we talked for a while. I knew she would be out in a few days, because she had filled out one of the blue cards. The blue cards help us contact the person getting out of treatment. We offer to take them to a meeting when getting out so they don't have to go alone.

On the day she was getting out I called her and left a few messages. A few days later I received a very nice voice mail thanking me for the phone call. In the message she thanked me and my partner for what we shared at the meeting that night. She went on to say she could relate to a lot what we had to say and she was going to meetings. There was something about this woman I really liked; I guess because she reminded me of myself when I was getting sober. I didn't hear from her again.

In June I went back to present again at the Orenda Center one Monday evening. To my surprise here was that nice lady I had met back in April. When I came in the room I gave her a hug and told her I had been thinking about her. She said it was a miracle I was there that night. She was very happy to see me again. My partner and I did our presentation about A.A. And at the end she filled out one of those blue request cards. We don't get a lot cards from the Orenda Center so it's pretty exciting when we do. Again before we left I talked to this woman for a while and promised her I would call her when she got out. So on Thursday I called her. I left a message checking in. To my surprise a couple hours later she called me. That afternoon I picked her up and we did a lot of talking and then went to a meeting. It really was a wonderful day. It's been almost a month now. We go to meetings together and talk and keep in touch on a regular basis.

The only thing I have done is what someone had done for me. I remember being so scared going to that first meeting. I was lucky enough to have a friend show me how A.A. works. I could of never been able to do this alone. The lady I met back in April I now consider a friend and I'm grateful she filled out that little blue card.

Heres an update: This woman has asked me to be her sponsor and the other day when she got her 30-day chip, she stated, "I couldn't have done it without you, Sheri! What a gift she is!"
