Processing the Steps

Step Nine

As so often with this program, I began to think about Step Nine as soon as I got seriously into the steps, working with my sponsor and going to meetings almost daily. It gave me the same kind of dull, aching headache that Four had, before further and well-supported investigation. In fact, Step Nine has resulted in great relief and much joy.

I love that this work on making amends started in Step Eight, where I was able to "become ready." So much of my learning in A.A. has developed through my willingness, my being open to something new and having a chance to take that in, let it develop inside me and then taking the action required: making the sincere attempt.

Much of my Ninth Step has been dicey – a lot of the people on my list are gone, have died or have disappeared from my life. I've learned about making Living Amends, where I act in a way that acknowledges, honors the memory of someone. I've learned that when I behave in a better way, think about the person I've harmed with my old ways and do the best I can to do things better, I clear the spiritual slate and can feel a real and loving connection, even with someone long gone. This, along with writing or even speaking my amends to someone not immediately in front of me, has been enormously healing and surprisingly pleasing. I include my father, my mother, and a partner of many years ago who took his own otherwise physically healthy young life – most likely because he was an alcoholic, long before I knew or understood anything about this disease.

And then there was my older brother, with whom I'd been on very tense terms for nearly 40 years. One day during a phone call I asked if he has an extra minute, to which he replied "sure." I told him that I'd come to realize that I'd been really very and unnecessarily hard on him, for years, that I now knew I didn't need to do that and that I was truly sorry for any pain and discomfort I'd caused him. There was a pause, and then my sixty-something brother sobbed deeply. There was another moment of silence – and then we were done. I told him that I loved him. He told me that he loved me too.

After 40 years I have my brother back. It's an imperfect, human relationship, but my gratitude is unbounded.

This is a wonderful, powerful step, from which I continue to learn and receive surprising, enlightening and restorative gifts. I now cannot imagine my life without it and the other blessings of A.A.

The Ninth Step is an amazing process, one that continues throughout my journey in sobriety. It brought me much freedom and relief and opened my heart and mind to degrees I could never imagined.

I have completed many Ninth step amends, but have always started with the required work of Steps Four to Eight. The Fourth step inventory allows me to clearly see my part, where I have been wrong. How my instincts out of balance (my perceptions, my words, my actions and behaviors) have harmed others. Only after I have willingness to set right my wrongs, without implicating the actions of others, can I make my amends.

My first Eighth Step list was lengthy with friends, family, employers, exes, business establishments, the IRS, and even total strangers. The names stared up at me from the page with seemingly impossible expectation. But I knew that in order to stay on my path of recovery I would need to face my past, let go of my fear and my pride and take full responsibility for my actions. To be accountable

and not blame others for my life condition was completely foreign to me. Up until then, I understood myself to be the Victim: not how I see myself at all today.

My first sponsor pointed out that I did not have to make all these amends at once; that I could approach them one at a time, starting with the ones that did not seem so difficult. That was a good plan, as the easier ones gave me practice and confidence to move onto the more challenging ones. I relied heavily on the guidance of my sponsor and reaching out to my Higher Power, asking for courage and the ability to approach each amends with dignity and grace.

My Higher Power has often revealed Itself to me when working the Ninth Step through synchronicity. People I have not seen for decades, suddenly appear in the strangest of ways usually after a couple of "road signs" reminding me of them.

Even the most awkward of these encounters is softened by the pure intention of this Step, creating an atmosphere of light and goodness that is difficult for me to describe. A sense of true freedom and purpose combined with a deeper understanding of my connection with Life and with Spirit often followed making amends and lingers to this day. It transformed how I treat others, how I see others and myself. And best of all, I'm still standing, here, sober.

OFFICER REPORTS:

Chair: (Patty G.) Things are going well. Many preparations going on for Traditions play; Alkathons and Seminars.

Vice Chair: (Holly H.) Those new reps that did not attend the orientation tonight should arrive by 7:30 p.m. next month to attend the orientation. Include phone number and email when signing in.

Secretary: (Jennifer R.) The General Meeting minutes of June 2014 were put forth and approved.

Treasurer: (Holly H. for Carolyn A.) Group contributions for June were \$2,910 which was \$187 less than June of last year. After expenses we had a net loss of \$1,231. Bookstore income was \$7,257, and after expenses there was a net loss of \$260.00. Overall we had a net loss of \$1,380.00. Our year-to-date for the end of June is almost \$1,000 more than the same time last year.



Our Experience Has Taught Us

Intergroup Fellowship is pleased to announce the hit play "Our Experience Has Taught Us" will be coming to Sonoma County for a one-night-only engagement. This is a great way to see the history of A.A. come to life. The play will be presented the evening of September 28. An A.A. meeting precedes the play.

"Our Experience Has Taught Us" dramatizes our fellowship's coming of age, from the founding of the first groups in Ohio, New York and Los Angeles to the First International Convention in 1950. Powerful and entertaining, this play brings to life the often comical and sometimes tragic experiences of the period of our history that led to the adoption of the Twelve Traditions.

Background information from the production company of "Our Experience Has Taught Us."

We are a rag tag group of volunteers who have dedicated our time and efforts to presenting educational and entertaining plays about alcoholism and addiction to recovery communities throughout California. Our new play has been invited to perform in an international convention for a potential audience of thousands at the 2015 International AA convention July 2-5.

Bridging the Gap

My Name is Devon and I'm the women's phone coordinator for Bridging the Gap. This is a fairly new commitment for me and it has brought about a lot of contemplation about service.

Some of the first concepts I learned when I worked the twelve steps of Alcoholics Anonymous were that I had been selfish, self seeking, inconsiderate, dishonest and full of fear. That was revealed to me on a fifth step. Then I needed to continue on to ask my higher power to remove these character defects from me. Steps six and seven guided me through that process. If my behavior or character traits like dishonesty or selfishness showed up in my affairs (sometimes my sponsor or another alcoholic pointed that out to me!), I kept asking to be willing to be in action and to be honest and of service instead!

What does this have to do with Bridging the Gap? Everything! I have called over 130 women this past month and it has been wonderful to receive the 40 return phone calls that allowed me to be able to talk to some very nice women. They made the decision to get out of "self" and pick up the phone and call me back.

The list of women volunteers is now up to date and cleaned up. I would like to have more women on this list. David, our men's phone coordinator, is also looking for men to volunteer. Bridging the Gap is our modern day twelfth step call. If you want a service commitment that will help you introduce a newcomer to meetings in their community, to be the hand of AA that is there for someone just getting out of a treatment or correctional facility, then this is it! Be a volunteer. Fill out a volunteer form at your nearest literature table. Come to our business meeting and new member orientation which is at 6:00 p.m on the third Tuesday of the month at the Bookstore. Come and get to know how you can be a part of Bridging The Gap.

PI/CPC News

One of the best ways I've found of enhancing my sobriety, and thus becoming a happier human being, is to do service work and also, to continually challenge myself. My first service commitment was making coffee for a small women's meeting. I worried at the time because I didn't drink coffee and therefore, I had no idea what I was doing. The women were wonderful. They taught me everything I needed to know. Over the last 5-1/2 years I've gotten pretty good at making coffee. I've also had the privilege of growing thru Literature Person, Set-up Person, Secretary and I've been an Intergroup Representative for several meetings. Recently, I was looking for a new service opportunity. I heard about PI/CPC and thought I'd check it out. PI stands for Public Information. CPC stands for Cooperation with the Professional Community. What we do is provide information about what AA is and is not to Professionals such as Child Protective Services staff, service providers to the homeless or at risk adults, Judges, Lawyers, Doctors ...to name a few. We also provide speakers for non-AA groups like DUI classes, school classes, health fairs and more. Another thing we do is deliver literature to places such as health clinics, libraries, police stations, hospitals etc. I've only been involved with the PI/CPC committee a few months and already I feel I've learned so much. I have had the chance to speak at a few DUI classes. I was pretty nervous, but it went really well. When we were done, there were lots of good questions. We handed out meeting schedules and a few pamphlets. I walked away feeling like maybe, just maybe, we helped someone. And that would be awesome! If you're interested, come join us. We meet the 2nd Wednesday of the month at the Santa Rosa City Hall employee lounge. It's next to the underground parking. Speaker training is at 7pm, our Business Meeting is from 7:30pm-8:30pm. Speakers should have no less than 2 years of sobriety and a working knowledge of the 12 Steps. I hope to see you there. We're always looking for new people.

Remember the first time you reached out for help?

Imagine if the hand of A.A. wasn't there the first time you reached out for help? What if the teleservice hotline was not staffed, or the bookstore had been closed, or there wasn't a meeting directory (either on paper or online) that directed you to a meeting? It might have been the last chance you had to get sober — and you had that chance because the hand of A.A. was there.

I'm not suggesting that any of these services is a guarantee of sobriety — willingness and a belief in something greater than ourselves are the primary ingredients for that. But the hand of A.A. services provided the glimpse of hope many of us ever had, a ray of hope that we could have a life free of fear and the bondage of John Barleycorn.

One way we stay connected is having Intergroup Representative attend the monthly SCIF General Meeting that is on the fourth Monday of each month. Intergroup Reps. pick up newsletters, meeting schedules and hear about upcoming events and issues and share them with their group. They are the connection between their group and the Fellowship. If your group does not have in Intergroup Rep. please consider having someone fill that service position. It just might help a newcomer feel connected or discover something about A.A. that helps them stay sober.

The SCIF Outreach Committee's goal is to increase group representation by spreading the word about the importance of Intergroup participation. If you attend a meeting and don't hear an Intergroup report, or if your home group doesn't have an Intergroup Representative, please let me know by email or phone. If you are interested in being a member of the Outreach Committee — and are willing and able to attend meetings to visit groups that are not represented — please let me know.
