SERVICE WORK HELPS TO KEEP US SOBER

If nobody was doing any service work, the Alcoholics Anonymous program would simply cease to exist. Without the service work of those who came before us, none of us would be here now!

Service Work In Recovery

One of the more common sayings you will hear at an Alcoholics Anonymous meeting is that, “you have to give it away in order to keep it”. What this is referring to is the idea that service in recovery can help the giver as much as the receiver. This giving should not be done in the hope of a reward or praise. Instead the individual does it because they know that it is helping to keep them connected. Numerous studies have provided evidence that helping others in recovery provides great benefit to the helper.

Service in Recovery Defined

Service in recovery refers to work carried out for no financial reward or compensation. This may involve directly helping somebody else, or indirectly helping them by providing services. Some individuals do go on to make a career out of helping others, but this is no longer considered service if they receive payment.

The Importance of Service in Alcoholics Anonymous

Groups like Alcoholics Anonymous could not function without the voluntary services provided by members. All these meetings around the world are organized and maintained by volunteers. There is usually a collection at the end of each meeting, but (in the spirit of the seventh tradition) this money is used to pay for rent, coffee, donuts, literature, and other overheads. Almost every person at these meetings will provide some type of service, even if it is just sharing a bit of their story, or preparing the coffee.

Other Types of Service in Recovery

There is no need for the individual to be a member of a particular A.A. group in order for them to become involved in service. There are plenty of official and unofficial ways that those in recovery can help others. Such work is highly rewarding, and it can strengthen the commitment of the individual to their own recovery.

Types of Service in Recovery

Anything that directly or indirectly helps others in recovery could be considered service. Examples of this type of work include:

- Sponsorship
- Intergroup Representative
- General Service Representative
- Chairing or moderating at a A.A. meeting
- Welcoming newcomers to recovery meetings
- Being supportive of those who are struggling in recovery
- Taking an official service role within a recovery group, for example treasurer or secretary
- Making time to reach out to people who are obviously struggling with problems
- Those individuals who do not hide their past can prove inspirational for those who are dealing with this type of problem

The Benefits of Service in Recovery

Service in recovery benefits both the giver and receiver. In a lot of instances it will actually be the giver who ends up benefiting the most.

- Those people who devote some time to helping others are less likely to suffer with depression.
- Helping others with problems reminds the individual of where they have come from. This will keep the pain of dysfunction fresh in their minds so that they never forget it. This should keep them committed to the recovery path.
- The giver will feel that they are giving back and this will increase their confidence and self-esteem.
- Providing service ensures that groups such as A.A. stay in business. If nobody volunteers their time these groups will disappear.

Bridging the Gap

Statement of Purpose

Bridging the Gap is a General Service sub-committee that supports that very important first step for alcoholics who have just been released from a hospital, treatment center or correctional facility. By providing a temporary contact, Bridging the Gap helps newcomers make the transition to Alcoholics Anonymous in his or her home community.

Members of Alcoholics Anonymous, usually in pairs, meet the patients or inmates after release and accompany them to their first A.A. meeting. As in all 12-step work, this activity is strictly voluntary.

What Positions are Available?

We're always looking for volunteers to fill our phone list. When someone requests our service, we provide them with a volunteer to take them to their first A.A. meeting. We try to have a volunteer available who is someone around their age and gender, who lives in their neighborhood, who can take them to the volunteer's home group, introduce them to the fellowship and make them feel welcome and at home. It is usually a one-time commitment, and as in all 12-step work, should be done in pairs. To be a volunteer, it is suggested that you have at least 6 months sobriety and a working knowledge of the twelve steps.

There are also service positions available on the committee. These service positions include chair and alternate chair positions, recording secretary, phone coordinators, Intergroup liaison, H & I liaison and presentation teams.

Chair: (Kevin H.) Kevin is still getting settled. All committee chair positions are filled. Bookstore Manager performance review to take place in the coming month.

Vice Chair: (Meghan A.) Meghan sent out 6 New Rep orientation packets last month; will send another 6 this month. Four new Reps attended orientation.

Secretary: (Katherine C.) Nothing to Report

Treasurer: (Buddy M.) Central Office income for February 2021 includes \$1,692 from Group Contributions and \$521 from individuals for a total of \$2,213. Total Expenses for February include \$2,411 from central office, \$377 from pamphlets and cards, and \$59 from Teleservice for a subtotal loss of \$294. The bookstore income for February 2021 was \$4,074. Total expenses were \$4,830 leaving a subtotal loss of \$757. Overall for this month we had a net loss of \$1,051. Year to date income is \$13,618 and our expenses are \$13,966, leaving a loss of \$347.

Registrar: (Laurie H.) Laurie requests that all Meeting Reps complete the sign-in form [link posted in chat] Sonoma County has 273 meetings per week [35-40 per day]. Thirty eight of these are in-person meetings.

COMMITTEES:

ICSC: (Ben) Kevin reports for Ben that ICSC is reconstructing SCIF's digital filing system to make it more efficient and user-friendly.

BOOKSTORE: (Glenn C.) We have enough volunteers for now. Sale book for April is Young and Sober for \$11.80 plus tax. Sunday 3/14 we turned clocks ahead for Pacific Daylight Time so starting Monday 3/15 the bookstore is open from 10am until 6pm, Monday through Friday; Saturdays 11am to 3pm.

Activities: (Chelsea N.) Chelsea is figuring out the Chair position, reaching out to past Chairs.

Alkathons: (Diana L.) Diana is newly elected to this position, will reach out for support.

Newsletter: (Ashley H.) Next Newsletter will be April's. Newsletters will return to monthly publication. Publication will remain digital only, probably until the number of in-person meetings warrants paper publishing. Groups and individuals are encouraged to submit articles, flyers, announcements, etc. to newsletter@sonomacountyaa.org Deadline for submissions for May Newsletter is April 16. Chris shared that PI/CPC has submitted articles that haven't been published and asked whether those had been retained. Ashley will look into this. **SCIF ANNUAL REPORT** for 2020 is posted on the SCIF website. Teleservice: (Deb D.) Teleservice going well. Has a full roster of people to answer the phone. Needs more volunteers to make 12th Step calls as needed. Qualifications for 12th Step callers are: 1 year sobriety and a working knowledge of the Steps.

Unlike AA meetings, speakers must be mindful of avoiding profanity laced drunkalogs, as we are the public voice of AA. The AA pamphlet "Speaking at Outside Groups" is an essential guide.

Central Office income for March 2021 includes \$1,401 from Group Contributions, \$1,872 from individuals, and \$25 from group insurance collection for a total of \$3,298. Total expenses for March include \$1,700 from central office, and \$59 from Teleservice for a subtotal gain of \$1,539.

The Bookstore income for March 2021 was \$5,344 from the bookstore and \$25 from group insurance collection. Total expenses were \$5,332 leaving a subtotal gain of \$12.
