



BRIDGING THE GAP

"When your life sucks, do more service."

It was one of the things an oldtimer said to me early on that stuck. And it was the phrase echoing in my head a year ago when I found myself deep in the throes of yet another "period of growth" in my sobriety and someone asked me if I would like to be of service to Bridging the Gap.

At my first BTG committee meeting I learned that BTG connects the alcoholic in treatment with AA in their home community. The New Volunteer Coordinator position was open and I made myself available. A big part of this position involves going to meetings and actively seeking volunteers for BTG. I didn't know it then, but the year to come was one of the most challenging times in my sobriety to date.

My service position with BTG kept me connected to my AA program in ways I hadn't anticipated. Because I was eager to make the BTG announcement, I attended more meetings than usual, went to meetings even when I didn't feel like it, and ended up staying after to talk to those who were interested in volunteering. Instead of hiding out at home or in the back row of a meeting, I found myself connecting with other alcoholics, giving and receiving the message of recovery.

10/10 recommend stopping by our monthly meeting, every 3rd Tuesday of the month!

GENERAL SERVICE

"The Value of the General Service Representative"

Does your home group have a GSR (General Service Representative) and is one even needed? To answer this question let me select a quote from our founder, Bill W.: "The strength of our whole AA service structure starts with the group and with the General Service Representative that the group elects. I cannot emphasize too strongly their importance." General Service helps us, your groups, function as a whole. Our worldwide unity and much of our growth since early times is directly linked to General Service.

The GSR has the "job" of linking his group with AA as a whole. He/she talks with members of his group and then reports the group's wishes to the committee member or to the delegate. He needs the confidence of his group, and a good ear for listening. He also brings back to the group communication from the committee members and the delegate regarding remedies and problems. The GSR keeps his group informed, and then listens to his group conscience, so he can report back and the Conference can make decisions based on AA as a whole- and all of our fellowships.

We all have a need to have our voice heard, and the General Service Board needs to hear our voices to guide them in making decisions about AA today, and the future of AA. Your General Service Representative is the key to this process. If your group would like a presentation with more information please reach out to your local General Service- District 12. The prime time to elect your new General Service Representative is in the fall so he/she can take office January 1st, along with other committee members and the delegate. General Service is a two year commitment and our new panel, Panel 73, will start 1/1/2023.

Public Information/Cooperation with the Professional Community Committee is the public voice for AA of Sonoma County and outreach to professionals who work with alcoholics.

I want to use this opportunity to focus on AA's Third Tradition: "The only requirement for AA membership is the desire to stop drinking". Why? Courts across the land have been sued for requiring DUI offenders to attend AA meetings as part of their sentence. The claims that AA is a religious group has gained traction because of the Christian trappings that AA groups have inserted into their meetings and AA literature. The Lord's Prayer that is commonly used as a closing in many AA groups is taken from the Gospel's of Matthew and Luke in the Christian Bible. And the 12 steps suggest that one finds a God as you understand Him. Capital "G" and "H". Even the Big Book Chapter "We Agnostics" ends the chapter: "When we drew near to Him He disclosed Himself to us." A bait and switch as I understand this chapter. As a result, the courts are now ordering offenders to find a recovery group of their choice.

It is the primary job of this subcommittee to carry the message of inclusion to all sufferers: Christians, Jews, Muslims, Zoroastrians, Buddhists, atheists, and everyone else. We need to meet the suffering alcoholic where they are and share how we stay sober; Not tell them how to stay sober. I'm proud to be a member of this fellowship and hope to continue by my example to carry the message to all alcoholics wherever they are and whatever they believe or don't. Won't you please join us? Total expenses for August include \$2,214.00 from central office and \$58.00 from Teleservice for a subtotal gain of \$2,960.00. The Bookstore income for August 2022 was \$6,126.00 and \$997.00 from Activities. Total expenses were \$6,600.00 for the bookstore and \$545.00 for activities leaving a subtotal loss of \$22.00. Overall, for this month we had a net gain of \$2,938.00. Year to date our income is \$80,440.00, our expenses are \$70,056.00, leaving a gain of \$10,384.00.
