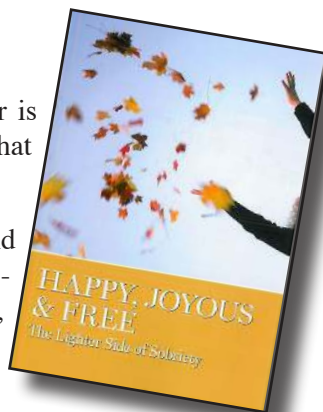

Finding Spiritual Fitness Through Service

I wanted to share with you about a year end practice I enjoy. I set aside some time to look back with gratitude on the past year, and look forward to some goals for the coming year. As I reflect on 2023 the first thing that comes to my mind is the question: how healthy is my spiritual fitness? What's working, are there areas I can improve on? This seems like a timely subject to share as the New Year approaches. I believe spiritual fitness means different things to different people. Experience in A.A. has taught me the rewards of spiritual fitness as it has become an integral part of the quality of my sobriety.

For me spiritual fitness means balance. To keep it simple I look at the A.A. symbol, the triangle - Unity, Recovery, Service. Unity means I stay in the middle of the program. I stick to the basics: a home group; working the Twelve Steps and Traditions with a sponsor; fellowship; prayer and meditation; service; learning to ask good questions. In this way I find balance in recovery and in my life. I get super squirrely when I veer too far away from these basics, even after some time in the program. I start to fall into the abyss of self-centered fear. To be honest, I've been feeling a bit stuck lately around some personal issues. However, I have come to appreciate and face these feelings with courage and awareness with the understanding that these stages in life are a part of recovery, a gestation of spiritual growth. I'm also reminded that alcoholism is an 'ism, not a "wasam".

With that said, the timing of saying "yes" to a service request to write a newsletter article could not have been more perfect. It has taken me out of my uncomfortable comfort zone, myself, and into service. It is actions like this, among others, that keep me renewed in sobriety. Doing the work, and giving away freely what I have found so that another alcoholic can possibly find comfort in recovery... I find that to be a highlight of the program. I also appreciate the spiritual essence of the program that is based on spiritual principals. It is through connecting with you, another alcoholic, that I get to experience my Higher Power. Being of service to the program of Alcoholics Anonymous has given me a deep sense of belonging. And that, without a doubt is the greatest spiritual fitness I have ever found.

I also wanted to share that a new panel in General Service has recently been selected. I am excited and looking forward to participating in serving District 12 with members of Panel 73.

If you are not yet involved in service and have been considering jumping in to the exciting world of service outside of your home group, there are MANY opportunities available: General Service, Intergroup, Hospitals & Institutions, PI/CPC, SOCYPAA, Bridging the Gap. Some are hybrid optional. You can start by finding your niche, going to one of the meetings of your interest, the meetings are posted on the Intergroup calendar. Make 2023 the year to have FUN in service as a means to exercise and develop YOUR spiritual muscle!

Total expenses were \$6,317.00 for the bookstore and \$2,099.00 leaving a subtotal loss of \$1,441.00. Overall, for this month we had a net gain of \$1,424.00. Total expenses for November include \$2,232.00 from central office, \$93.00 from pamphlets & cards, \$300.00 from the Newsletter and \$59.00 from Teleservice for a subtotal gain of 2,572.00.

The Bookstore income for November 2022 was \$6,279.00 and \$25.00 from Group Insurance. Total expenses were \$7,131.00 for the bookstore, leaving a subtotal loss of \$827.00. Overall, for this month we had a net gain of \$1,745.00.
