Total expenses for August were \$2,637 for a subtotal gain of \$4,056. Central office income for August 2023 was \$5,432. Total expenses for August were \$3,376 for a gain of \$2,056. Overall, for this month we had a net gain of \$6,113. Year to date our income is \$102,355, total cost of goods is \$31,433 and our expenses are \$60,230. Other expenses included correction to the reporting of annual contributions for a total of \$10K, leaving a gain of \$692. As of August 31,2023our inventory is \$23,549 a 25% increase from this time last year. Renovations to the bookstore were limited to \$2,407. Its a special note that the bookstore sales increased 29% over July!

## **GENERAL SERVICE REPRESENTATIVE**

Your group has elected you to the position of General Service Representative (GSR). What do you do? Where do you go?

Prior A.A. service experience provides a helpful head start for a GSRs' success. "By choosing its most qualified member as the GSR, a group helps secure its own future — and the future of A.A. as a whole."

The makings of a good GSR are generally a minimum two or three years' sobriety. They should be an active member in their home group and possess the same character qualities that mark a good, trusted servant of any sort: patience, understanding and a firm determination "to place principles before personalities."

The new GSR needs awareness that this is a two year commitment. Attending your Monthly District meeting, Area assemblies four times a year as a voting member and participating in other service events when asked are just a few of the requirements of a General Service Representative.

It is also important to elect an alternate GSR. The two will work together closely so that the alternate can be a knowledgeable replacement if the GSR is unable to attend a district or area meeting. The alternate then becomes the voting member.

As General Service Representatives you have an even bigger responsibility: the job of linking your home group with the whole of A.A. and to transmit ideas and opinions, as well as facts. Through you, the group conscience becomes a part of the "collective conscience of our whole fellowship," as expressed in the General Service Conference.

You and your fellow GSRs all over the world have become the key to the unity of A.A.

Most future Conference delegates will come from the ranks of today's GSRs. So, your choice now can help to ensure good representation for your entire area in years to come and continued vitality for our General Service Conference — the heart of our co-founders' Third Legacy to all of A.A. around the world.

## **ACCESS**

I am responsible.


A little less than 11 years ago I got my start in General Service. I was at a meeting without a General Service Representative and I asked myself this question: "Am I available?" I was willing and available; and with no other nominations I began my journey in General Service. I am now into my 11 year and on the Access Committee. I am the Recording Secretary. The Access Committee is here to insure that Alcoholics Anonymous remains accessible to anyone seeking recovery from alcohol. Like the Responsibility Statement says: "I am responsible. When anyone, anywhere, reaches out for help, I want the hand of A. A. always to be there. And for that: I am responsible."

Not everyone learns the same way, and if I am responsible to carry the message of AA to the suffering alcoholic, then I need to be willing to adapt to the person and the situation. What gets in the way of carrying the message to another suffering alcoholic for me is when I let social stigmas or misunderstandings influence my judgments.

I personally struggle with some mental and neurological disorders. The AA program has helped me to be able to deal with these other disorders, by staying sober. I have a psychiatrist for treating my other disorders, but staying sober has always had to come first for me. Even the "Big Book" talks about the usefulness of doctors, so I need both the AA program and outside help to be successful. The responsibility statement reminds me that I am responsible to pass on the freedom that was freely given to me in Alcoholics Anonymous, or the still suffering alcoholic may die. I have the responsibility to do my part in keeping A. A. around for future generations. I do this by being of service, which is the third of A. A. 's three legacies. The first two are Recovery and Unity.
