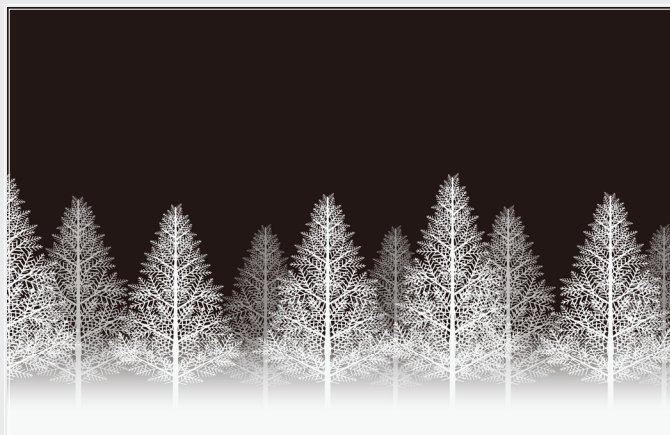

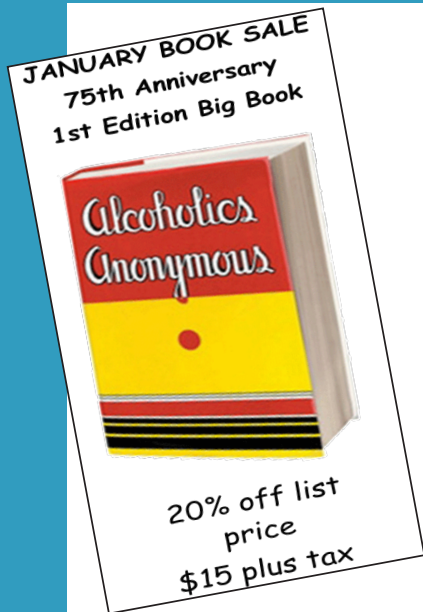

Upcoming Mental Health Workshop

Last year Access Sonoma County circulated surveys throughout the fellowship to get an idea of topics of interest for a workshop. Every accessibility barrier is important to address and we plan to have more workshops to bring awareness & support around other barriers in the future. But the topic which received the most votes was Mental Health in Recovery, and so we've begun planning this workshop to be held on April 20, 2024 at Bethlehem Lutheran Church. More details to come. For those looking to be of service, Access committee needs volunteers before, during & after the workshop. There will be panel speakers, breakout rooms, snacks and more. We're planning to make this a Hybrid workshop. Members willing and able to be of service will help to make this workshop successful and helpful to our fellowship, to the alcoholic who still suffers, and to AA as a whole. All are welcome to attend these workshop planning committee meetings. This was how I, myself, stumbled onto Access Sonoma County in 2021. I attended my first workshop planning meeting not knowing what this committee was or how it served the fellowship. I didn't know a single member on the committee before that day. But I was available and I was willing. I've learned through recovery that's all I need. I've learned that I just need to show up, that I am enough, and that I am just a small part of a greater whole.  - b. At least two (but no more than five) color versions, showing how you would implement two colors in your design. Please note that we may change color schemes based on General Planning Committee vote.

Chair: (Joe S) Our general meeting next month will be December 18th on zoom only!!! 4th Monday in January will be the elections, Jan 22nd.

Vice Chair: (Kristin P) Working on fall/ winter schedule

Treasurer: (Meghan L) The Bookstore income for October 2023 was \$8366. Cost of good total was \$3,062. Total expenses for October were \$3,646 for a subtotal gain of \$ 1,658. Central office income for October 2023 was \$ 8,165. Total expenses for October were \$4,996 for a gain of \$3,169. Activities income for October 2023 is \$2,031. Total expenses included \$575 for an overall gain of \$1,456. Alkathon expenses for October 2023 is \$1,000. Overall, for this month we had a net gain of \$5,283. Year to date our income is \$128,660, total cost of goods is \$37,859 and our expenses are \$79,211, leaving a gain of \$11,590.

Registrar: (Ellen W) As of October 2023 there were a total of 241 groups here in Sonoma County offering a total of 425 meeting each week. There were a total of 48 reps in attendance and 10 were new. Reps: Zoom 15, In-person 23, New reps 10. Meetings: Zoom 125, In person 270, Hybrid 30.

COMMITTEE REPORTS

ICSC: (Marian McD): My time as chair follows 2 strong leaders- Clark is visionary, he saw the deficits and envisioned solutions- for continuity, planning and a new look and new system for the bookstore. Lance has done the implementation. He made the new look and new systems for the bookstore happen. I see my role as consolidation- we DO what we say we will do and we finish what we start! I envision the theme for my time: We are RESPONSIBLE and REPONSIVE. * Bookstore income has increased significantly since the recent changes! We propose to hire a second Assistant Manager with strong tech skills. We have 1 strong candidate and would welcome more! We propose an OPEN process to review bylaws to begin in January

BOOKSTORE: (BOB): We sold 77 big books in October 63 12x12's, 70 living sober, 742 aluminum chips, 128 meeting in a pocket, 131 sobriety chocolates. Basic literature sales are up 138% we have increased our inventory 10 fold. We have an abundance of Holiday gifts at the bookstore. We are looking to offer personal AA stories from local members. Don't forget the T-shirt and chocolate bar wrapper slogan contests. Pocket edition of Daily Reflections @ 20% off for \$12.55- Also on sale is the anniversary edition of the 1st edition of the Big Book in a bundle w/ an "History of the Big Book". We need volunteers. 10% off sale next month. Online bookstore has a QR scanning code- So much to see at the bookstore.

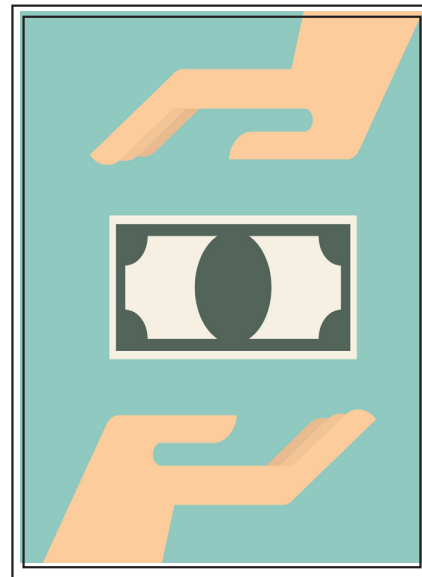

Central Office income for November 2023 was \$3,225. Total expenses for November were \$3,067 for a gain of \$158. Alkathon income for November 2023 is \$1,485.
